If you are disqualified or exempt from jury service under the law as set forth on this notice, you may submit the completed and signed form below. This must be received no later than the date and time specified for your appearance. Proper attire is required in the courtrooms, please visit courts.dallascityhall.com for latest Dress Code. **Note: If you do not respond to this summons, a Judge may issue an order that requires you to appear at a hearing before the court to show cause for your failure to comply with this summons. A failure to show good cause at such hearing for noncompliance may result in the imposition of imprisonment for not more than three days and a fine of up to \$100. The Dallas Municipal Court's main priority is safety and is taking precautionary steps to protect you and court staff during the COVID-19 pandemic. Please visit courts.dallascityhall.com for latest requirements to enter the Dallas Municipal Court building. Before you report to jury duty, you must complete the questionnaire on the back page.**

DISQUALIFICATIONS:

- I am not a resident of the city of Dallas, Texas, and not qualified to vote in said city elections under the constitution and laws of the state of Texas.

- I am not able to read or write.
- I have been convicted of a felony or any misdemeanor theft, or I am under indictment or legal accusation for a felony or any misdemeanor theft.
- I have served as a petit juror for 6 days during the last 3 months in the county or for 6 days during the last 6 months in district court.
- This person is deceased.

EXEMPTIONS:

- I am over seventy (70) years of age.
- I have legal custody of a child younger than 12 years of age, and service would necessitate leaving that child without supervision, or I am the primary caretaker of a person who is unable to care for himself or herself.
- I am a student at a public or private secondary school or I am enrolled and in actual attendance at an institution of higher learning.
- I am chronically ill, infirm, immobilized, or have an impairment of sight or hearing that would make it difficult or impossible for me to serve.
- I have served on the municipal court petit jury during the last twelve (12) months.
- I am an officer or employee of the legislative branch of the state government.
- I am a member of the United States military forces on active duty and deployed to a location away from the home station and outside of the Dallas County.
