§46-1. "It is the policy of the City of Dallas to bring about through fair, orderly, and lawful procedures the opportunity for every person to obtain employment, access to all places of public accommodation, and housing without, regard to sexual orientation. This policy is based upon recognition of the rights of every individual to work and earn wages through gainful employment, to obtain and enjoy goods, services, facilities, privileges, advantages, and accommodations in all places of public accommodation, and to obtain housing. The denial or deprivation of this right because of sexual orientation is detrimental to the health, safety, and welfare of the citizens of Dallas and is within the power and responsibility of the City to prevent." §46-5 "This chapter does not apply to; religious organizations: the United States government, and any of its departments or agencies, or any corporation wholly by it; or the government of the State of Texas or any of its departments, agencies, or political subdivisions."
