This plan submission meets the population equality test. All districts have less than a 0.90% percent deviation from the optimal district size, with an average deviation of **0.47%**. The total range of deviation is **1.77%**.

2. Minority Representation: Voting strength of minorities should not be diluted.

This plan submission meets the minority representation test. This plan includes 8 minority districts and 2 minority coalition districts. No retrogression of minority representation from the 2001 District Plan is noted.

3. Contiguity and Compactness: All districts should be geographically compact and contiguous.

This plan meets the contiguity and compactness test. All districts are contiguous. On the following page are the compactness scores based on four measures of geographic compactness compared to the City as a whole.

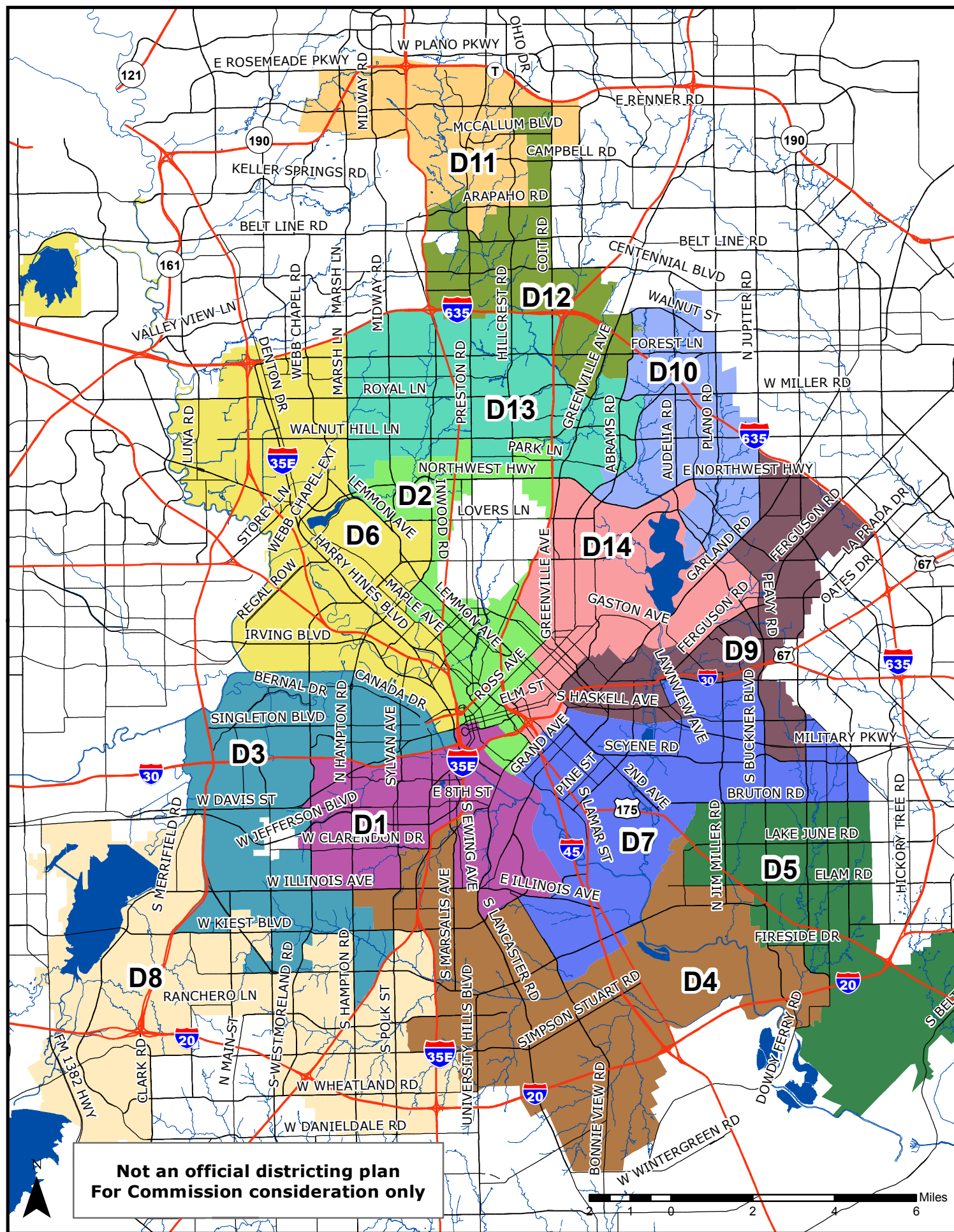
