DISCUSSION

(1) DCA212-007 Lori Levy Consideration of amending Chapter 51A of the Dallas Development Code, Section 51A-4.701(d), "Two year limitation" to revise the applicability of the two-year limitation, the standard for the waiver of two-year limitation, and related regulations.

Ms. Levy presented and the item was opened for discussion and questions from ZOAC members. Ms. Levy and Ms. May provided clarification as needed. Chair Hampton led the discussion and the committee concluded with the following motion.

Motion to forward the proposed amendments in DCA212-007 to City Plan Commission, with the following changes:

- 1. Approval of (d)(1) and (d)(2) per ZOAC request
- 2. Approval of (d)(3)(B) per ZOAC request, strike "if" at the end of the sentence of (d)(3)(B) and revise to read as follows:
 - (i) There are changed circumstances regarding the property;

- (ii) The length of time that has elapsed since the previous zoning decision;
- (iii) Whether the previous final decision for a change in zoning district classification or boundary of the property was city-initiated;
- (iv) Whether the previous final decision was for a specific use permit;
- (v) Whether significant and material changes between the previous and subsequent requests are expected, including but not limited to:
 - (aa) a change in land area
 - (bb) the nature of the subsequent request, or
 - (cc) new circumstances or information has been discovered that were unforeseeable;
- (vi) Whether the previous final decision for a change in zoning classification or boundary of the property was or was not unanimous;
- (vii) The nature and degree of public support for or opposition to the prior final decision; or
- (viii) Other factors in which granting a waiver is or is not contrary to the public interest.
