No minimum lot size - Allows small scale development to be viable instead of being forced to consolidate and do large developments, making it more likely new development is comparable to existing development

No maximum number of dwelling units - Encourages affordablility by not penalizing a developer for building smaller, more efficient (affordable units)

Other rules like height limits keep developments from going too far out of bounds.
