ORDINANCE NO. 29875

An ordinance correcting Ordinance No. 28407, passed by the Dallas City Council on September 28, 2011; correcting Ordinance No. 29551, passed by the Dallas City Council on December 10, 2014; providing a saving clause; providing a severability clause; and providing an effective date.

WHEREAS, the city council finds that it is in the public interest to correct Ordinance No. 28407 and Ordinance No. 29551 to accurately reflect the intent of the city council; Now, Therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the Exhibit A (Property Description for Stevens Park Conservation District) attached to Ordinance No. 28407, which established Conservation District No. 20 (Stevens Park Conservation District), is replaced with the corrected Exhibit A (Property Description for Stevens Park Conservation District) attached to this ordinance.

SECTION 2. That the Attachment No. 1 to Exhibit A (boundary adjustment agreement) attached to Ordinance No. 29551, which ratified and adopted an agreement between the cities of Dallas and DeSoto adjusting their common boundary line, is replaced with the corrected Attachment No. 1 to Exhibit A (boundary adjustment agreement) attached to this ordinance.

SECTION 3. That the Attachment No. 2 to Exhibit A (boundary adjustment agreement) attached to Ordinance No. 29551, which ratified and adopted an agreement between the cities of Dallas and DeSoto adjusting their common boundary line, is replaced with the corrected Attachment No. 2 to Exhibit A (boundary adjustment agreement) attached to this ordinance.

SECTION 4. That upon final passage of this ordinance, the city secretary shall transmit a certified copy of this ordinance to the city secretary of the City of DeSoto.

SECTION 5. That the zoning ordinances of the City of Dallas shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 6. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code, as amended.

SECTION 7. That this ordinance shall take effect immediately from and after its passage and publication, in accordance with the Charter of the City of Dallas, and it is accordingly so ordained.

EXHIBIT A Conservation District No. 20 - Stevens Park

PERIMETER

BEING all of the area generally bounded by Atlantic Street on the north, N. Plymouth Road on the east and south and Hampton Road to the west and including part of Block 3832 containing roughly .06464 acres, an area containing approximately 81.527 acres.

SUBAREA: A-Tract 1

BEING all of the area as noted, all of City Blocks 1/4629, 2/4607, 4/4609, 7/4614, 8/4615, 9/4616, 10/4630, 11/4796, and the following portions of City Blocks as noted: Lots 1 through 9, along with Lots 13, 14 and 15 and Lots 25, 26 and 27 as platted in City Block 12/4797. Lots 12 through 21 and a portion of Lots 22 and 23 being a tract containing roughly 0.3895 acres in City Block 3/4608 and all of Lots 10 through 24 in City Block 5/4610.

SUBAREA: A - Tract 2

BEING all if that certain lot, tract or parcel of land situated in the W. MYERS SURVEY, A-880, and in City Block 3832, City of Dallas, DALLAS County, Texas, said parcel being a part of that same tract of land described in deed to Second Church of Christ, Scientist, Dallas Texas, recorded in Volume 2917, Page 27 and being all of that same tract of land described in deed to Board of Trustee, Second Church of Christ, Scientist, recorded in Volume 2917, Page 18 of the Deed Records of DALLAS County, Texas, the composite of said tracts being more particularly described as follows:
