

FROM THE CITY MANAGER...

During the last year, the City of Dallas has been planning and developing a comprehensive bond package to address the infrastructure needs of the community. In October 2016, the City hosted 31 public meetings to get your input on what should go into the bond program. Building on that input, the City Council created the Citizens Bond Task Force to help identify, review and recommend projects for each proposition. The Task Force met from April to June of 2017 and presented a recommended bond program to the City Council at their June 7, 2017 meeting. Two additional town hall meetings were conducted on May 21 and May 22 to gain additional citizen comments before the Task Force and City staff finalized program recommendations.

What is a bond program?

A bond program is a voter-issued debt that will be used to improve the City's infrastructure such as alleys, streets, sidewalks, parks, drainage and facilities.

What is the difference between a system-wide project and a district-specific project?

A system-wide project has a regional impact (e.g. library or fire station), draws patrons citywide, has project costs too high for one district to bear alone, and/or a specific site that is undetermined.

District-specific projects are specific to one district, including streets, alleys, sidewalks and neighborhood parks.

Where can I see a full list of projects for each district?

Residents can view all projects and bond-related materials at www.dallasbond.com.

Do residents vote for the entire bond program with one vote?

No. The 2017 Capital Bond Program will be on the ballot as 10 individual propositions in accordance with legal requirements. Voters will be asked to consider each proposition separately on November 7, 2017.

Why are the propositions lettered instead of numbered?

State law requires that local propositions be lettered and state propositions be numbered.

What is the tax rate impact of the 2017 Bond Program?

The City's tax rate has two components: the Maintenance and Operations (O&M) tax rate used to support the general fund and the debt service tax rate used for repayment of bonds. The City's debt service tax rate is \$22.24¢ per \$100 valuation. Based on property tax value assumptions, if the 2017 Capital Bond Program is approved, the City's debt service tax rate will remain the same.

How were bond projects selected?

Beginning in May 2016, the City Council was briefed on the City's infrastructure needs. In October 2016, the City conducted 31 public meetings citywide. Using input from these meetings, the Council created the Citizens Bond Task Force to review and select projects for the 2017 Capital Bond Program. The Citizens Bond Task Force presented its recommendations to the City Council on June 7, 2017. After deliberation and amendments, the Council adopted the \$1.050 billion bond package on August 9, 2017 and ordered the election for November 7, 2017.

Can specific projects and the amounts allocated change?

Yes. The City Council has the authority to add or delete specific projects and may adjust the amounts needed for specific projects.

STREETS AND TRANSPORTATION PROPOSITION A

This proposition will provide **\$533.981 million** for 1,027 projects, including upgrades to the City's aging traffic signal system and installation of new warranted traffic signals, critical bridge repairs, street reconstruction and resurfacing, and sidewalk and alley reconstruction throughout the City.







SYSTEM-WIDE PROJECTS

Traffic Signal Synchronization Project \$20,000,000

Phase 1 implementation of upgrades to the City's traffic signal system.

Traffic Signal Installations \$18,350,000

Installation of warranted traffic signals at 63 locations citywide.

Sidewalks and ADA Ramps \$6.240.000

Funding for the City's 50/50 cost share sidewalk replacement program and installation of ADA-compliant barrier-free ramps.

Bridges

\$6,300,000

Funding to address critical bridge repairs throughout the City.

Garland Road/Gaston Avenue/East Grand Avenue Improvements \$1,100,000

Construction of safety improvements at the intersection of Garland Road, Gaston Avenue and East Grand Avenue. The Texas Department of Transportation is providing \$4,500,000 in match funding.

Rail Road Crossing Quiet Zones

\$543,000

Installation of infrastructure improvements to create quiet zones at multiple railroad crossings citywide. The Texas Department of Transportation is providing \$2,200,000 in match funding.

Prairie Creek Bridge Construction \$9,200,000

Construction of a new four-lane divided roadway, including a new bridge over the Union Pacific railroad tracks south of Forney Road, and sidewalk and bicycle facilities. The North Central Texas Council of Governments and private donors are providing \$9,913,563 in match funding.

LBJ/Skillman Street Improvements \$6,500,000

Lighting and streetscaping improvements at the LBJ/Skillman Street interchange. The Texas Department of Transportation is providing \$65,000,000 in match funding.

US 75/Mockingbird Lane/ Lovers Lane Improvements \$1,100,000

Pedestrian and bicycle safety improvements, including traffic signals, sidewalks,crosswalks and lighting, between Mockingbird Lane and Lovers Lane. The Texas Department of Transportation and North Central Texas Council of Governments is providing \$4,456,656 in match funding.

Riverfront Boulevard Reconstruction \$4.600.000

Reconstruction of Riverfront Boulevard, including bicycle facilities, between the Union Pacific railroad tracks and Cadiz Street. Dallas County is providing \$4,600,000 in match funding.

Davis Street from Clinton Avenue to Cockrell Hill \$4,000,000

Reconstruction of Davis Street. including bicycle lanes. Dallas County is providing \$3,200,000 in match funding.

Cockrell Hill Road Construction \$1,900,000

Construction of a new four-lane divided roadway from La Reunion Parkway to Singleton Boulevard, including a new bridge over the Union Pacific railroad tracks and new traffic signals at Singleton Boulevard. The Texas Department of Transportation is providing \$1,900,000 in match funding.

Wheatland Road Construction

\$1,800,000

Construction of a new four-lane undivided roadway from University Hills Boulevard to the city limits. The North Central Texas Council of Governments is providing \$3,200,000 in match funding.

McKinney Avenue/Cole Avenue Two-Wav Conversion

\$8.000.000

Conversion of the existing one-way roadway to a two-way roadway. The project is receiving \$12,800,000 in match funding from the North Central Texas Council of Governments and local public improvement district funds.

SoPAC/Katy Trail Drainage and Erosion Control

\$700.000

Construction of drainage and erosion control improvements along the SoPac/Katy Trail. The Texas Department of Transportation is providing \$250,000 in match funding.

Dolphin Road from Spring Avenue to Haskell Avenue

\$2.000.000

Conversion of the existing fourlane undivided roadway to a fourlane divided roadway. The Texas Department of Transportation is providing \$4,000,000 in match funding.

Walnut Hill Lane Resurfacing

\$2,200,000

Resurfacing of Walnut Hill Lane between Marsh Lane and Midway Road.

Forest Lane Resurfacing \$1,100,000

Resurfacing of Forest Lane between Cromwell Drive and Marsh Lane.

10th Street/Clarendon **Drive Area Reconstruction** \$8,000,000

Reconstruction of existing streets and alleys to meet city standards.

Ewing Avenue from I-35E to Clarendon Drive

\$6.000.000

Expansion of Ewing Avenue to a four-lane divided roadway with sidewalks and bicycle lanes.

Canada Drive "Complete Streets" Reconstruction

\$7.600.000

"Complete Streets" reconstruction of Canada Drive to a four-lane divided roadway, including sidewalks and dedicated bicycle facilities, between Westmoreland Road and Hampton Road.

Commerce Street "Complete Streets" Reconstruction

\$9.700.000

"Complete Streets" reconstruction of Commerce Street to a two-lane two-way street, including sidewalks and bicycle lanes, between Good Latimer Expressway and Exposition Avenue.

Chevenne Road from Lake June Road to Big Thicket Drive

\$7.101.000

Reconstruction of Chevenne Road to a four-lane divided roadway with sidewalks.

Pemberton Hill Road from **Great Trinity Forest Way to** Lake June Road

\$13,980,000

Reconstruction of Pemberton Hill Road from a two-lane undivided asphalt road to a four-lane undivided concrete street with sidewalks and bicycle lanes.

Merit Drive from Churchill Way to LBJ

\$3.000.000

Reconstruction of Merit Drive. including sidewalks.

Casa View "Complete Streets" Reconstruction

\$6.300.000

"Complete Streets" reconstruction of Gus Thomasson Road from a sixlane roadway to a four-lane roadway with wider sidewalks. pedestrian lighting and landscaping.

UT Southwestern Medical District

\$7.500.000

Infrastructure improvements in the UT Southwestern Medical District. including sidewalks, streets and pedestrian lighting. The North Central Texas Council of Governments and private donors are providing \$13,500,000 in match funding.

Petition Projects \$12.592.000

Improvements to streets, alleys and sidewalks submitted to the city via the property owner petition cost share program.

Alley Reconstruction \$6.500.000

\$2,500,000 in funding for alley reconstruction in District 11 and \$4.000.000 for District 12.

District-Specific Projects \$350,075,000

PARK AND RECREATION PROPOSITION B

This proposition will provide **\$261.807 million** for more than 160 parks and recreation projects, including enhancements to the City's signature parks (Klyde Warren, Dallas Zoo, Dallas Arboretum), development of Crawford Park in the southeastern part of the City, rehabilitating recreation centers, playgrounds and existing trails, and completion of Phase 1 and 2A of the Aquatics Master Plan.

Downtown Parks \$35,000,000

Development of: Carpenter Park, Harwood Park and the West End Plaza. Parks for Downtown Dallas is providing \$43.6 million in match funding.

Circuit Trail \$20,000,000

Development of the Trinity Forest Spine Trail, the Trinity Skyline Trail Link, Baker Pump Station Gateway and the Circuit Trail Connection. The Circuit Trail Conservancy, Dallas County, and the North Central Texas Council of Governments are providing \$23 million in match funding.

Lake Highlands Trails \$2.300.000

Connection of Phase 1 of the Lake Highlands Trail to the White Rock Creek Trail and from Lake Highlands High School to Watercrest Park. The North Central Texas Council of Governments is providing a Transportation Alternatives Program grant of \$4.1 million.

Construction of a sidewalk connection along Garland Road from East Lawther Drive to Gaston Parkway.

Construction of six new Family Aquatic Centers at Fretz Park, Samuell Grand Park, Crawford Park, Kidd Springs Park, Lake Highlands North Park and Tietze Park.

Aquatics Master Plan Phase 2A \$13.200.000

Construction of a Neighborhood Family Aquatics Center at the Exline Recreation Center and improvements to the Bahama Beach Waterpark.

White Rock Lake Trail \$3,500,000

Completion of the White Rock Lake Trail improvements from the Bath House Cultural Center to Sunset Bay.

ADA/Code Compliance \$150.000

Renovation of park amenities to ensure compliance with the ADA and other regulatory codes.



Timberglen Trail \$4.165.000

Construction of a new trail from Timberglen Park to the Preston Ridge Trail.

Crawford Memorial Park Phase 1

\$7,700,000

Development of a signature park in southeastern Dallas, including the creation of a lake and reconstruction of the southern loop trail.

Flag Pole Hill Park Phase 1 \$400,000

Implementation of Phase 1 of the Flag Pole Hill Park master plan, including extension of the loop trail, parking improvements, and site furnishings.

Flag Pole Hill Playground \$165.000

Construction of an inclusive playground at Flag Pole Hill Park. The Jordan Speith Foundation is providing \$290,000 in match funding.

Singing Hills Recreation Center \$8,000,000

Addition of a gym to the Singing Hills Recreation Center and construction of a connection to the Camp Wisdom DART rail station.

Bachman Recreation Center Renovation\$3.900.000

Renovation of the Bachman Recreation Center interior, including restrooms, finishes and the control room, as well as implementation of ADA improvements.

Interior renovations to the Thurgood Marshall Recreation Center, including modifications to the control desk, game room, fitness room, and repairs/ replacement of finishes.

Midtown Park \$6.000.000

Acquisition of land and initial funding for the planning of Midtown Park located northwest of LBJ and Preston Road. The Dallas Midtown Park Foundation is providing \$6 million in match funding.

White Rock Lake Park **Stone Tables** \$280.000

Restoration of the historic stone tables, development of ADAaccessible parking and additional site improvements. The White Rock Conservancy is providing \$280,000 in match funding.

Dallas Zoo \$3.500.000

Critical parking enhancements and improvements to accommodate attendance growth. The Dallas Zoological Society is providing \$3.5 million in match funding.

Dallas Arboretum \$1.000.000

Construction of additional restrooms to accommodate attendance growth. The Dallas Arboretum is providing \$1 million in match funding.

Bachman Lake Skate Park Phase 1 \$4.000.000

Creation of a new major skate park at Bachman Lake Park.

Southern Gateway Public Green \$7,100,000

Construction of structural support to accommodate a new deck park at I-35 and Ewing. The **NCTCOG** Regional Transportation Council is providing \$40 million in match funding.

Kleberg Trail

\$1,200,000

Development of a linear hike and bike trail from the Buckner DART rail station to the new Crawford Memorial Park. Dallas County is providing \$1.2 million in match funding.



Northaven Trail

\$2.615.000

Connection of the Northaven Trail west of US Hwy 75 to the White Rock Creek Greenbelt Trail and installation of amenities. The Texas Department of Transportation and Dallas County are providing \$16 million in match fundina.

Dallas Water Gardens \$7.500.000

Development of a new water garden park in the Cedars Neighborhood. The Dallas Wetlands Foundation is providing \$10 million in match funding.

Klyde Warren Park \$10.000.000

Expansion of Klyde Warren Park. The Woodall Rogers Park Foundation is providing \$10 million in match funding.

Exterior Renovations at Five Recreation Centers

\$1.600.000

Completion of roofing and waterproofing improvements at Fretz Park, Harry Stone, Hattie R. Moore, K.B. Polk, and Umphress Recreation Centers.

Interior Renovations at **Golf Course and Five Recreation Centers** \$3,900,000

Interior renovations, including restrooms and HVAC, plumbing electrical and mechanical improvements at Grover C. Keeton Golf Course and Martin L. King, Jr., Mildred Dunn, Pike, Ridgewood/ Belcher and Tommie Allen Recreation Centers.

Partnership Land Acquisition and Match Funding \$5.000.000

Leveraging of match funding through private/public partnerships to purchase future park land.

Neighborhood Parks \$86,232,000

Funding has been allocated to each council district to address neighborhood park improvements, rehabilitation and maintenance. Please visit www.dallasbond.com to see the full list of projects specific to your district.

FAIR PARK PROPOSITION C

This proposition will provide \$50 million to rehabilitate 12 facilities at Fair Park.

African American Museum \$2,000,000

Resolution of water intrusion, repair of interior finishes, maintenance of the condenser water system, and completion of mechanical and electrical repairs.

Hall of State \$14,410,000

Cleaning/restoration of exterior wall and plaza, installation of exterior drainage and lighting, and architectural repairs to the roof, exterior doors and windows and other interior and exterior features. Additional repairs include the sump pump, elevator and miscellaneous plumbing, electrical and mechanical issues, as well as efforts to address dehumidification.

Music Hall \$4,300,000

Repair of the elevator, paving, exterior lighting and interior electrical issues, as well as replacement of old plumbing pipes and improvements for security and ADA compliance.

Texas Discovery Garden \$300,000

Replacement of the chiller/cooling tower and pump at the facility.

Food and Fiber Building \$1.500.000

Structural stabilization and repair of damaged finishes.

Coliseum

\$9,500,000

Water infiltration repairs, as well as repairs to restrooms, flooring and plumbing, along with electrical and mechanical improvements.

Tower Building \$3,500,000

Water infiltration repairs, as well as interior renovations and plumbing, mechanical and electrical improvements.

Centennial Building \$4.400.000

Repair of the roof, conservation of the bas relief mural and electrical and mechanical improvements.

Pan American Arena \$3,480,000

Exterior restoration of the Poultry area, as well as repair of the interior doors. Renovation of the concrete columns and stucco in the Sheep and Goat area. Repair of the concrete, stucco, doors, columns and ventilation of the electrical and elevator rooms in the Police Mounted Unit area. Repair of the arena roof and louver.



Science Place 1 Phase 1 \$5,110,000

Water infiltration repairs, completion of mold testing, replacement of plumbing fixtures, water heater and aged mechanical equipment and installation of security equipment.

Aquarium Annex \$600,000

Repairs of roof and complete façade, replacement of some interior finishes and plumbing fixtures and installation of upgrades to the fire alarm system, as well as new security and telecom systems.

Magnolia Lounge \$900,000

Replacement of roof, interior lighting, heat pumps and fan coil units, repair of the façade and installation of a security system.

FLOOD PROTECTION AND STORM DRAINAGE PROPOSITION D 2 System-Wide Projects 83 District-Specific Projects

This proposition will fund \$48.75 million for 85 flood protection, storm drainage and erosion control projects throughout the City.







Erosion Control \$14,023,000

These projects will prevent current and future erosion damage in neighborhood creeks and drainage outlets at 27 locations.

Storm Drainage \$18,307,000

These projects involve upgrading and replacing existing storm drainage lines and installing new lines to improve storm drainage at 34 locations.

Flood Management \$16,420,000

These projects will improve drainage to prevent flooding and relieve properties that suffer repetitive flood loss at 24 locations.

LIBRARY FACILITIES PROPOSITION E

This proposition will provide **\$15.589 million** for three system-wide library projects.

Vickery Meadow Branch Library

\$7,700,000

Design and construction of a new branch library to serve the Vickery Meadow/Midtown area at 8255 Park Lane.

Forest Green Branch Library

\$7,790,000

Replacement of the existing Forest Green Branch Library with a new facility.

J. Erik Jonsson Central Library

\$99,000

Funding for major maintenance of the plumbing and roof at the Central Library at 1515 Young Street in downtown.

TOTAL \$15,589,000





CULTURAL AND PERFOMING ARTS FACILITIES PROPOSITION F

This proposition will provide **\$14.325 million** to rehabilitate nine of the City's cultural and performing arts facilities. Projects include interior and exterior renovations ranging from accessibility improvements to waterproofing and electrical repairs.

Bath House Cultural Center \$1,500,000

Completion of interior renovations including improvements to restrooms to ensure ADA compliance, as well as plumbing improvements and kitchen renovations.

Dallas Heritage Village \$250,000

Refurbishment and renovation of this historic house, including roofing and security improvements.

Dallas Museum of Art \$6,000,000

Completion of exterior improvements, including waterproofing and building drainage, as well as mechanical updates and replacement of the fire alarm panel.

Kalita Humphreys Theater \$525,000

Completion of electrical improvements, repairs resulting from water damage, and repair/ replacement of the rooftop chiller and ductwork.

Meyerson Symphony Center \$3.800.000

Replacement of the roof, elevator and reverberation door controller system, as well as water infiltration repairs.

Oak Cliff Cultural Center \$110,000

Replacement of the heating ventilation and air conditioning system.

Sammons Center \$900,000

Repair of the façade and roof.


Dallas Black Dance Theatre \$900,000

Waterproofing, exterior restoration of windows and doors, and repair of cracks.

South Dallas Cultural Center \$250,000

Installation of erosion control at the Robert E. Cullum entrance, repaving and re-landscaping, and completion of upgrades to security and fire systems, including security cameras and improved exterior lighting.

PUBLIC SAFETY FACILITIES PROPOSITION G

This proposition will provide \$32.081 million to address 16 public safety projects throughout the City, including security enhancements at the Jack Evans Police Headquarters and seven police substations, as well as replacement of two aging fire stations and construction of a new fire station.

Fire Rescue Training Center \$150.000

Repair/replacement of site pole lights and bases, installation of new LED lighting and a complete rewiring.

Fire Station #36 Replacement \$6,990,000

Replacement of the existing fire station with a new facility. currently located at 3241 North Hampton Road.

Fire Station #46 Replacement \$7,525,000

Replacement of the existing fire station with a new facility, currently located at 331 East Camp Wisdom Road.

New Fire Station \$6,900,000

Construction of a new fire station at South Jim Miller Road and Loop 12.

Fire Station Renovations \$1,222,000

Completion of waterproofing, HVAC, plumbing, electrical and mechanical improvements at 12 fire stations (#5, #8, #9, #11, #12, #13. #18. #24. #25. #43. #51 and #53), the Training Center, and the Life Safety & Professional Standards Bureau.

Jack Evans Police Headquarters \$1,250,000

CITY HALL AND CITY SERVICE AND ADMINISTRATIVE FACILITIES PROPOSITION H

This proposition will provide \$18.157 million to rehabilitate multiple City-owned facilities. Projects include waterproofing and restroom accessibility improvements at City Hall and expansion of the West Dallas Multipurpose Center to meet the service needs of the community.





Mosquito Abatement Equipment and Storage Building \$325.000

Construction of a new 2,000 sq. ft. storage building for mosquito abatement chemicals, power washing equipment, and interior and exterior lighting. This will eliminate the need for mosquito abatement crews in northeast Dallas to travel to southwest Dallas for supplies.

Electrical Panel Replacements \$1,300,000

Replace electrical panels at 37 City facilities.

City Hall Interior and Exterior Renovations \$7,000,000

Replacement of the existing roof, parapet flashing, skylights, and roof drains, improvements to the garage water infiltration system, renovations to the public-facing restrooms to ensure ADA compliance, and replacement of the Federal Pacific electrical panels.

Oak Cliff Municipal Center Renovation Phase 1 \$2,000,000

Completion of interior renovations, including restrooms, common areas, mechanical systems and office space.

West Dallas Multipurpose Center Expansion \$2,500,000

Expansion of office space to include a Community Court and leasing space to partners who provide additional services. Electrical panels will also be replaced during the expansion.

Interior Renovations at Nine Facilities \$1,802,000

Completion of waterproofing, HVAC, plumbing, electrical and mechanical improvements at nine City facilities.

Accessibility Improvements \$3,230,000

Planning, design and implementation of accessibility improvements at various City facilities.

TOTAL \$18,157,000

ECONOMIC DEVELOPMENT PROPOSITION I

This proposition will provide \$55.4 million for commercial corridors, transit-oriented development, mixed-use developments, mixed-income housing and neighborhood revitalization throughout the City.

Revitalization

These projects will focus on:

- Development (or redevelopment) in commercial corridors in need of revitalization because of changing market dynamics.
- Revitalization and adaptive reuse of underutilized or obsolete commercial properties.
- Developments that foster neighborhood revitalization.

Transit-Oriented **Development**

These projects are typically developed within a 1/4 mile of the DART rail or directly connected to a bus station.

Mixed-Income Housing

These developments help support affordable housing throughout the City.








HOMELESS ASSISTANCE FACILITIES PROPOSITION J
