- ❖ Agrees to take all remedial measures necessary to bring the plans and all construction completed under the permit for the project into conformity with requirements of the City of Dallas codes, ordinances, and standards as well as all other applicable laws.

Nothing in this rule shall be construed to prohibit the City from requiring additional certifications in the Owner/Tenant Certification Statement.
