Dear Colleague:

You are invited to comment on the proposed ordinance to become Chapter 57, "Dallas One-and-Two-Family Dwelling Code," of the Dallas City Code, which will be discussed at the Building Inspection Advisory Examining and Appeals (BIAEA) Board Meeting noted above.

The proposed types of revisions consist of the following:

- 1. The carrying forward of previous Dallas amendments, referred to as "Dallas Carryovers."
- 2. The carrying forward of previous North Texas Council of Government Regional amendments, referred to as "COG Carryovers."
- 3. New Dallas amendments.
- 4. New North Texas Council of Government Regional amendments.
- 5. Various minor editorial corrections.

A document will be made available denoting the designated revisions.

Should the BIAEA Board approve the proposed ordinance, the Building Inspection staff will recommend an effective date of April 10, 2023, for the approved revisions.

You are invited to submit written comments on this or any other agenda item, or to attend the BIAEA Board Meeting and present your views. If you wish to contribute to the discussion, please note the following:

- 1. Regarding written comments and presentations:
 - a. You should submit these via e-mail to shahla.layendecker@dallas.gov to be received by the applicable due date.
 - b. Comments are to be received by <u>October 25, 2022.</u> These written comments will be forwarded to the BIAEA Board before the meeting and will also be posted on the Building Inspection web site shortly after the deadline for submission. Written comments that are not submitted by this deadline will not be considered at the meeting.
 - c. Rebuttal comments, from the proponent noted in this letter, are to be received by <u>November 5, 2020</u>. They will be forwarded to the BIAEA Board before the meeting and will also be posted on the Building Inspection web site shortly after the deadline for submission. Written rebuttal comments that are not submitted by the deadline will not be considered at the meeting.
 - d. Visual presentations, in PowerPoint format only, are to be received by <u>November 5</u>, <u>2022</u>. These will be forwarded to the BIAEA Board before the meeting and will also be posted on the Building Inspection web site shortly after the deadline for submission. Presentations that are not submitted by the deadline cannot be viewed at the meeting. Note: Videos will not be posted on the web site.
 - Presentations will be retained with other records of the meeting.
 - e. Building Inspection staff will post to the Building Inspection web site, on November 18, 2022, memos by the Building Inspection staff, responding to the previously received public comments.
 - f. If you miss the deadlines for submission of written comments and visual presentations, your verbal comments can be presented at the meeting.
 - g. Proposed ordinance, written public comments, visual presentations, and responses by Building Inspection staff for this agenda item are all available on our website.

2. Regarding verbal comments and presentations:

Please plan to speak for not more than ten minutes. As noted above, visuals must be in PowerPoint format and will be shown during the meeting.
