- 1. The urban form setback requirement is amended, reduced from 20' to 15' and kicking in for the portion of a structure that exceeds 54' (not 36')
- 2. Bonus FAR and height applies for mixed-use projects that have at least 50% of floor area under residential use and not less than 50% of the ground floor area under retail or personal service uses
- 3. Transfer of development rights for historic preservation is allowed from any sub-district to subdistricts 2, 2A, 3, and 3A only
- 4. Lots with frontage on Lamar or Beliview are permitted 100% ground coverage conditional upon provision of enhanced pedestrian amenities along those rights-of-way. See Section 51P-317.112.1 for minimum amenity standards required in order to qualify for all enhanced pedestrian amenity incentives. Property located in Subdistrict 3B, Tract 1 is permitted 85% lot coverage.
- 5. An additional list of urban trees are permitted for meeting the street use requirement.
- 6. In sub-districts 2, 2A, 3A and 3B, up to 50% of site trees may be provided in the public right-ofway (in addition to required street trees) or the equivalent cost may be paid into the Cedars Public Open Space and Landscape Fund. For properties with frontage on Lamar or Bellview within subdistrict 3A, the site tree requirement is waived if enhanced pedestrian amenities are provided
- 7. Required parking lot trees must be placed so that no parking surface greater than 60,000 square feet in area remains uninterrupted by a row of large canopy trees.
- 8. The minimum clear sidewalk width is 7.5 feet for properties within sub-district 3A with frontage on Lamar and Bellview.
- 9. For properties with frontage on Lamar or Bellview, the permeable surface requirement is waived conditional upon provision of enhanced pedestrian amenities along those rights-of-way.
- 10. Parking reduction is conditional upon provision of enhanced pedestrian amenities along the rights-of-way connecting the site to the DART station.
- 11. Remote parking distance is increased conditional upon provision of enhanced pedestrian amenities along pathways connecting remote parking to the site served.
- 12. A maximum residential density of 160 dwelling units/acre is permitted in sub-district 1. 13. A maximum residential density of 90 dwelling units is permitted in Subdistrict 3B Tract 1.
- 14. For a legacy building in Subdistrict 3C, if a side yard is provided, no minimum setback is required.
- 15. Side Yard: Minimum side yard is 5 feet for duplex structures; 10 feet for multifamily structures 36 feet or less in height and no minimum in all other uses.
- Rear Yard: a minimum 10 feet rear yard for duplex structures; 15 feet for multifamily structures 36 feet or less in height and no minimum in all other uses.
- 16. The maximum floor area ratio in the CA-1(A) districts may be increased to 24 to 1 by the use of the building setback bonus provisions in the "additional provisions" listed.
- 17. Minimum lot area per dwelling unit is as follows:
