## **NEW CASE PRESENTATION:**

Involved Officers: (1) White Male Suspect: (1) Black Male

On February 9, 2015, at approximately 12:33 p.m., the residence located at 6756 Shadow Creek Drive was burglarized. The owner of the residence observed two suspects fleeing from the location with property taken during the burglary. As the owner chased the suspects, who were on foot, he fired several shots at them. The suspects continued to flee on foot at which time the homeowner got into his dark blue Dodge truck in an attempt to catch the suspects. The homeowner located the suspects at the corner of Riverside and Bonnie View Road which is approximately 1.5 miles from the burglary location. After locating the suspects, the homeowner again fired several rounds at the suspects. The suspects then fled southbound on Bonnie View Road where the homeowner momentarily lost sight of them. The homeowner drove around the area searching for the suspects.

The Involved Officer, who was working an off-duty job in full police uniform, was alerted to the shots being fired and went to investigate. While investigating the incident, the Involved Officer encountered an individual running southbound in the 7400 block of Bonnie View Road. As the Involved Officer detained the individual in the grassy area adjacent to the roadway, the homeowner jumped the curb driving toward the Involved Officer at a high rate of speed. The Involved Officer perceived the speed and direction of travel of the truck as a threat to himself and the individual he had detained so he discharged his weapon, striking the homeowner. The homeowner was transported to Baylor Hospital by Dallas

Fire and Rescue where he was pronounced deceased. No officers were injured during this incident.

A juvenile suspect matching the description from the burglary at 6756 Shadow Creek Drive was located and detained. This juvenile had property on his person that was taken during the burglary. The second suspect remained at large.
