



## Background

 Mountain Creek Lake Park is a City of Grand Prairie park within the City of Dallas.

## Background

- The Mountain Creek Lake Park is part of the Grand Prairie Parks System.
- The park is owned and maintained by the City of Grand Prairie.
- Grand Prairie City staff receives complaints and service requests regarding the park from surrounding Grand Prairie residents.
- Grand Prairie Police Department is unable to respond to criminal activities or code compliance issues because the park is not within the city of Grand Prairie.
- The majority of users of the park are Grand Prairie residents.
- Between 2012 and 2018, there 79 calls to 911, including two robberies of an individual and an assault



#### Request

• The City of Grand Prairie requested a boundary adjustment to move the park within the Grand Prairie city limits.





### **Boundary Adjustment Process**

- Texas Local Government Code Sec. 43.015 Authority of Adjacent Municipalities to Change Boundaries by Agreement:
  - Adjacent municipalities may make mutually agreeable changes in their boundaries of areas that are less than 1,000 feet in width.
- The boundary adjustment process includes two steps:
  - Council authorizes the City Manager to execute a boundary adjustment agreement.
  - Council adopts an ordinance adopting the boundary adjustment following the requesting city's Council approval.



### **Recent Boundary Adjustments**

- City of Irving in 2016 Irving received a 6.5-acre parcel in exchange for the City of Irving providing water services to a 22acre single-family development within the City of Dallas.
- City of Rowlett in 2015 City of Rowlett purchased Elgin B. Robertson Park – 257 acres were placed into the City of Rowlett through nine boundary adjustments.
- City of DeSoto in 2014 Dallas received a 12-acre parcel for a 4.5-acre parcel to DeSoto.
- City of Balch Springs in 2010 Balch Springs received 3.3 acres for the construction of a Dallas Independent School District middle school. DISD was a co-requestor.



### **Next Steps**

- City Council consideration to authorize the City Manager to execute a boundary adjustment agreement with the City of Grand Prairie.
- City Council consideration of and ordinance adopting the boundary adjustment.
