Definition

- Shared Mobility Vehicles Include:
 - Bike Share
 - Electric Scooters
 - Electric Bicycles
 - Other Motorized Mobility Devices

Bike Share Program Update

- Staff has been regularly meeting with the bike share representatives since February 2018
- The initial results of the bike share pilot program were briefed to the MSIS Committee on February 26, 2018
- Staff is developing regulation and permit language in coordination with the bike share companies

Bike Share Program Update

- Example elements of the framework for the permit language:
 - Setting parking standards and company response times
 - Requirements for data sharing
 - Expectations for safety and educational outreach
 - Virtual dockless parking

Electric Scooters and Bicycles

- The mobility industry has additional mobility options in their fleets such as
 - Electric scooters
 - Electric assist bicycles
- LimeBike and Bird expressed interest in deploying dockless electric assist vehicles in Dallas
- Staff is currently meeting with industry representatives to develop standards and regulations

Possible Code Impacts

Dallas City Code: Sec. 28-41.1.1 Restrictions on the use of motor assisted scooters, pocket bikes, and minimotorbikes.

Texas Transportation Code: Subchapter E
Motor - Assisted Scooters
Sec. 551.352. Operation on roadways and sidewalks.

Next Steps

- Finish developing the permit and fee structure language
- Full briefing to the MSIS Committee on April 9, 2018 for consideration of the draft permit and fee structure for all alternative mobility vehicles
