**A RESOLUTION RECOGNIZING FREEDOM FROM
DOMESTIC VIOLENCE IS A FUNDAMENTAL HUMAN RIGHT**

WHEREAS, the City of Dallas seeks to enhance the public welfare by declaring that freedom from domestic and family violence is a fundamental human right; and

WHEREAS, world leaders and leaders within the United States recognize that domestic violence is a human rights concern; and

WHEREAS, the United Nations has recognized domestic violence as a human rights issue; and

WHEREAS, the United Nations Special Rapporteur on Violence Against Women has stated that “violence against women is the most pervasive human rights violation,” and that responses to violence should recognize human rights as a premise and further urged the United States to reassess laws and policies for protecting domestic violence survivors; and

WHEREAS, more than one in three women and more than one in four men in the United States will experience rape, physical violence, and/or stalking by an intimate partner at some point in their lives, according to the U.S. Centers for Disease Control; and

WHEREAS, children are adversely affected by violence in the home, whether they are physically or verbally abused themselves or simply witness the violence; and

WHEREAS, the Texas Council on Family Violence found that more than one in three Texas women (38%) have experienced intimate partner violence in their lifetime; and

WHEREAS, in 2014, the Dallas Police Department Domestic Violence Unit reported 14,036 family violence calls resulting in 1,277 aggravated assaults, 17 murders. The unit investigated 12011 DV cases of which 90 were robbery offenses, 110 sexual assault offenses, 154 violations of protective orders, and 3,944 arrests; and

WHEREAS, in 2013, the DFW metroplex had 38 domestic violence homicides, the most of any metro-area in the state of Texas, and further, Dallas County has the highest per capita female murder rate in the state at 1:62,752, according to the Texas Council on Family Violence; and

WHEREAS, the 2013 Metro Dallas Homeless Alliance Point-in-Time Homeless Count found 2,972 people living on Dallas streets or in shelters. 24% of the homeless population was children, and 14% of the adult population listed domestic violence as their reason for homelessness; and

WHEREAS, local police and sheriffs' departments, courts, cities, counties, social services agencies, and other local government entities constitute the first line of defense against domestic and family violence; and

WHEREAS, police and sheriff's departments, courts, cities, counties, social service agencies, and other local government entities incur significant monetary costs due to domestic and family violence; and

WHEREAS, survivors of domestic and family violence experience physical injuries, long-term psychological damage, financial instability, difficulty finding safe housing and other challenges, some of which directly or indirectly relate to services provided by the City; and

WHEREAS, the Dallas Domestic Violence Task Force was created by community leaders, including members of the Dallas Police Department, Dallas County and Municipal Court Judges, the Dallas County District Attorney's Office, leaders of various non-profit groups, and community leaders, in order to help identify and implement improvements in a coordinated system for response to acts of domestic and family violence in the City; and

WHEREAS, the Texas Constitution provides that a crime victim has the "right to be reasonably protected from the accused throughout the criminal justice process"; and

WHEREAS, the recognition that domestic and family violence are human rights issues will raise public awareness and encourage domestic and family violence education in communities, the public and private sectors, and within governmental agencies; Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

Section 1. That the City Council joins world leaders and leaders within the United States in recognition of domestic violence as a human rights concern and declares that the freedom from domestic and family violence is a fundamental human right.

Section 2. That this resolution shall serve as a declaration assuring the residents of the City that the City government bears a responsibility to secure this human right on behalf of all of its residents.

Section 3. That the Dallas Domestic Violence Task Force shall continue to identify the gaps and barriers in the City's service delivery to survivors of domestic violence and provide annual executive summaries over the next three years on the challenges faced by survivors of domestic violence and recommendations on how to improve delivery of services to those survivors by participating members of the general and executive task force committee agencies, non-profit organizations and government partners.

Section 4. That all City departments, offices, and courts shall cooperate with the Dallas Domestic Violence Task Force in the compilation of its reports.

Section 5. That the City is committed to respond diligently to acts of domestic and family violence, and that all of the City's departments shall incorporate the principles embodied in this resolution into their policies and practices.

Section 6. That this resolution shall serve as a charge to all local agencies to incorporate these principles into their policies and practices.

Section 7. That a copy of this resolution shall be sent to the Dallas County District Attorney, the Dallas County Sheriff's Department, the Dallas Police Department, the Dallas County Courts, City departments, and other local agencies as necessary to comply with this resolution.

Section 8. That this resolution shall take effect immediately from and after its passage in accordance with the Charter of the City of Dallas, and it is accordingly so resolved.

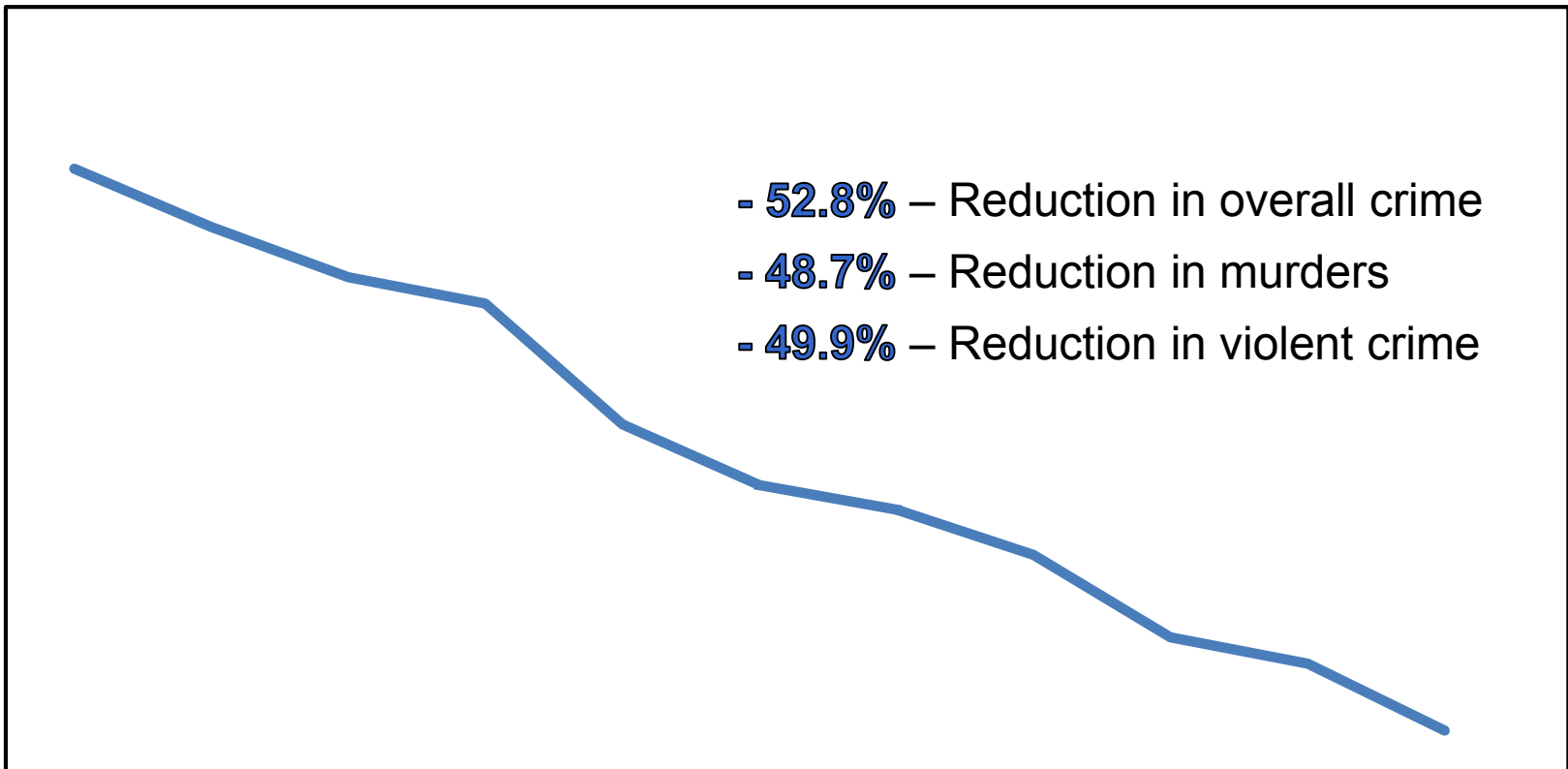

Significant Criminal Enforcement Activity

Investigative (District 7)

September 8th, 2015 – Detectives were investigating a burglary at 2500 Quinto Drive based upon information received pertaining to a child on campus in possession of stolen property. After interviewing multiple witnesses, they received confessions and arrested two juveniles for multiple burglaries in the area. Property was recovered from suspects, a local pawn shop, and from individuals who had unknowingly purchased the illicit items.



Significant Criminal Enforcement Activity

Patrol (District 7)

September 12th, 2015 – Officers responded to 4100 Scyene Road where a carjacking of an individual at gunpoint occurred. Officers quickly located the stolen vehicle and after a brief pursuit, arrested four suspects for aggravated robbery.



Significant Criminal Enforcement Activity

METRO (District 6)

August 26th, 2015 – After receiving developing information a specific vehicle was possibly involved in multiple robberies within the area, officers conducted surveillance. While being watched, the vehicle traveled to 9800 Dale Crest Drive, where suspects attempted to rob someone by force. Uniformed officers intervened, arresting the suspects for robbery and recovering property.



Significant Criminal Enforcement Activity

Patrol (District 12)

September 13th, 2015 – Officers were dispatched to a burglary of a motor vehicle at 3901 Accent Drive, where they were able to apprehend the suspect in the act. The suspect was also in possession of a firearm and cocaine.



Significant Criminal Enforcement Activity

Narcotics (District 2)

September 11th, 2015 – Narcotics detectives executed a search warrant at a club located at 4300 Live Oak Street. The detectives seized 3.7 pounds of cocaine and \$94,000. Four people were arrested on felony drug distribution charges.

Enhancing Pedestrian Safety

While a majority of pedestrian fatalities in the City are due to pedestrian error, the City of Dallas has implemented several measures to enhance pedestrian safety over the past two years.

These measures focus on enhancing visibility of pedestrian and school related traffic control signs and pavement markings; enhanced pedestrian signal heads and increased pedestrian crossing times at signalized intersections; and installation of beacons, pedestrian signals, and similar measures at specific locations.

Enhanced Crosswalks

- All new and restriped crosswalks in the City are now “ladder” type crosswalks
- Ladder crosswalks are more visible and longer lasting
- Over 1,000 such crosswalks have been installed in the past two years

Enhanced School Signs

- All new and replacement school signs in the City are fluorescent yellow-green, which provide increased visibility and retroreflectivity
- Over 1,800 fluorescent yellow-green school signs have been installed in the past two years

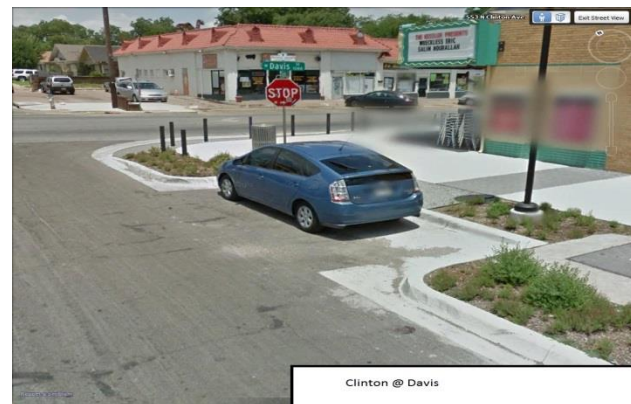

- All new “Stop” and “Yield” signs in the City use more retroreflective sheeting to provide enhanced night-time visibility
- In addition, larger stop and yield signs are being installed at multi-lane approaches
- Over 1,300 new Stop signs have been installed in the past two years

Countdown Signal Heads

- All new and replacement pedestrian signal heads in the City are now “countdown” type
- This type of signal heads have been shown to reduce pedestrian accidents by 25%
- In addition, all new and retimed signals have longer pedestrian crossing times
- Over 400 countdown pedestrian signal heads have been installed in the past two years

Purpose

The Crime Stoppers Program is designed to illicit information from citizens to help solve crimes.

Success for the program relies upon three components:

- 1) Police
- 2) Media
- 3) Citizens

Identity of citizen providing the crime tip always remains anonymous.



Development of Crime Stoppers Programs

- National program was created in 1976, in Albuquerque, New Mexico, as a result of a murder investigation
- Program encourages citizens to assist police with fighting crime by providing information on crimes and criminals
- North Texas Crime Stoppers Program began in 1980 and is operated by the North Texas Crime Commission
- Dallas Police Crime Stoppers Team is located in the Jack Evans Police Headquarters, staffed by one sergeant and three detectives

Program Structure

- Crime Stoppers Reward Committee is comprised of civic and business leaders that provide direction for the financial and promotional activities of the program
- Funding comes from a portion of fines levied by Dallas and Collin County courts, private donations, and fund raising
- The Crime Stoppers Board meets monthly to evaluate arrests and determine monetary rewards to be paid for each specific case





How It Works

- Calls are received by the DPD Crime Stoppers tip line
- DPD Crime Stoppers Detectives document and manage the investigative follow-up for each tip
- Calls are accepted for any publicized requests for information. North Texas Crime Stoppers Program maintains a website for requested information at: <http://www.ntcc.crimestoppersweb.com>

- During the investigation, detectives requested information from the public
- On May 26, 2015, a crime tip was received. The suspect was arrested on May 28, 2015, in Stone Mountain, Georgia
- The tipster was awarded \$2,500 by the North Texas Crime Commission

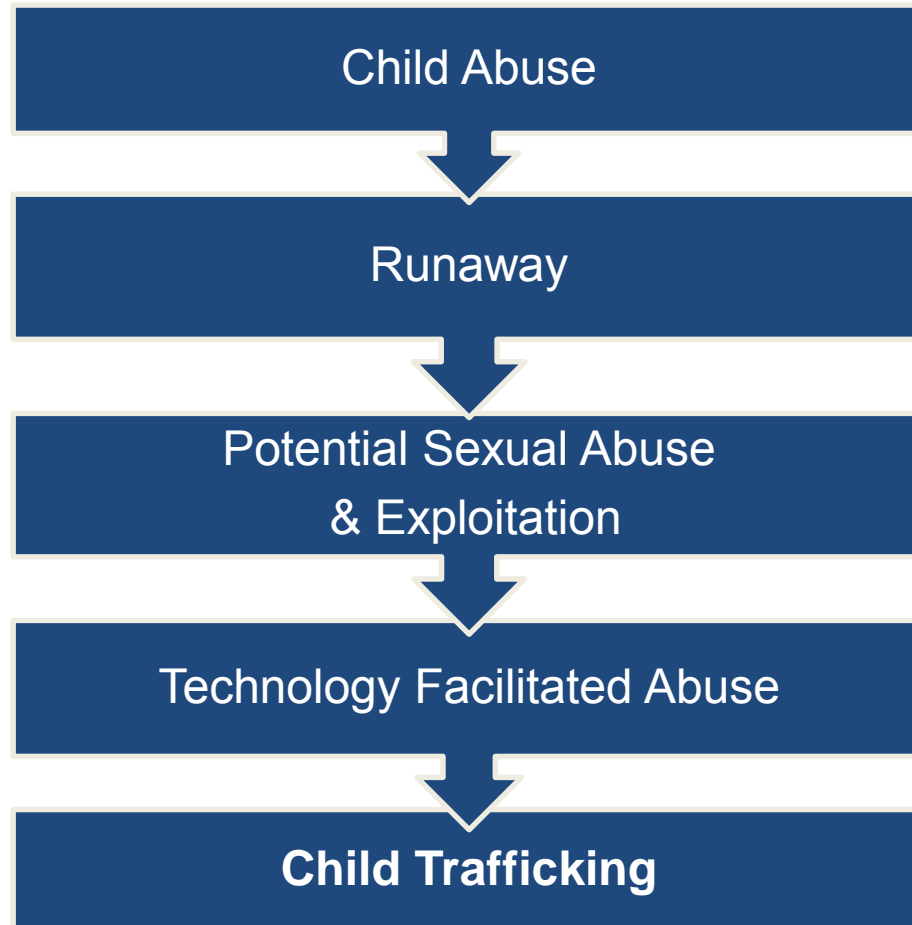
Goals

- Reduce the number of runaways
- Leverage community resources
- Prevent child sex trafficking
- Reduce sex assault cases and related offenses

Scope of the Problem

- City of Dallas named one of the 13 top cities for the victimization of children through sex trafficking
- Average 2,600 (reported) runaways a year
- On average identify approximately 150 – 250 high risk victims per year
 - 60% reported runaways
 - 40% “throwaways”
 - Approximately one-half of high risk victims are eventually identified as child victims of sex trafficking

Cycle of Child Trafficking



Challenges Identifying Victims

- Locating the Victim
 - Rarely will “victims of domestic trafficking” self report
 - Chronic runaways
 - Fear/distrust in system (Trafficker Grooming)
- Traditional investigative models not effective
 - Traditional interview policies not effective
- System/Societal Perceptions
- Requires a proactive, relentless approach

Challenges Technology

- Technology facilitated trafficking is a game changer (content & volume)
- Provides a platform to disguise as:
 - Legitimate
 - Enables the old to look younger
 - Young look older
 - Hide child victims
 - Crosses all social and economic lines
 - New points of contact – recruitment & delivery

Community Partnerships

- Trafficking victims are not easily identified, DPD utilizes and trains:
 - Other Federal, State, and Local Law Enforcement Agencies
 - Vice
 - Patrol
 - Juvenile Department
 - CPS
 - Shelters
 - Medical/ER
 - Community

- Two phase operation designed to target enforcement on the internet
- **Phase 1**
 - Provide resources and outreach
 - Posting of law enforcement decoy ads

On Thursday, August 27, 2015, at approximately 1:45 p.m., Witness #1 drove the suspect to a location in the 1600 block of Fitzhugh Avenue to purchase drugs. While at the location, the suspect became involved in a disturbance at which time the suspect produced a handgun and threatened the individuals. At some point during the disturbance, the suspect received a cut to his hand. Witness #1 then drove the suspect to a residence located at 3610 Penelope Street. The suspect entered the residence and encountered Witness #2. After engaging in a confrontation with the suspect, Witness #2 exited the residence and called for police assistance. When Witness #2 reported the confrontation, he also informed the 9-1-1 call taker the suspect was setting the residence on fire. A Robbery in Progress call sheet was generated and officers, along with Dallas Fire-Rescue, were dispatched to the location.

When Officers #1 and #2, in full police uniforms and driving a marked police vehicle, arrived at the location, the suspect walked from behind the residence which was on fire. The suspect, who was verbally non-compliant, reached into his pockets and tossed some items to the ground. Officers #1 and #2 followed the suspect and Witness #1 as they walked to their vehicle that was parked on the street. At this point, other officers and Dallas Fire-Rescue were arriving.

When the additional cover officers arrived, an attempt was made to place the suspect in handcuffs. The suspect became violent and resisted the officers attempt to handcuff him. Officers #3, #4 and #5, who were also in full police uniforms, deployed their TASERS which were ineffective. The suspect remained combative and entered the vehicle from the driver's side and climbed into the front passenger seat.

After Officers #3 and #4 observed the suspect holding a handgun, Officer #4 yelled, "Gun." Officer #3 discharged his duty weapon, striking the suspect. Dallas Fire-Rescue paramedics began treating the suspect and found a box cutter in the suspect's waistband. The suspect was pronounced deceased a short time later at Baylor Medical Center. No officers were injured.

A black gun was found in a sliding compartment under the front passenger seat of Witness #1's vehicle. The gun resembled a semi-automatic pistol, but it was a pellet gun.

Listed below, is the response to a follow-up item discussed during the Public Safety Committee meeting held on Monday, August 24, 2015.

Concern: Call Response Time - Data for call time, how long does a call typically take and how long are officers taking in markouts.

Response: A call for police service is averaging 61.71 minutes. This is the average time officers spend on all calls. Some calls are handled quickly and others require officers to remain at the scene for extended period of time working motor vehicle accidents, conducting follow-up investigations and making arrests.

Markouts by officers are averaging 43.63 minutes. Markouts are taken by officers for conducting routine investigations, traffic stops, security checks, and incidents that are on-viewed by officers during routine patrol.
