




#### **Total Violent Offenses**








#### **Total Murder Offenses**


#### **Total Sexual Assault Offenses**


#### **Total Aggravated Assault Offenses**





  - Contraband in Correctional Facility (Misdemeanor B)
  - Driving While License is Invalid (Misdemeanor B)

# Beyond HB2391

Additional Dallas guidelines as discussed by Dallas County and DPD:

- Valid state issued ID on person
- No prior convictions that would enhance charge
- Provide a thumbprint
- 17 years of age
- Must sign citation/summons
- Video the encounter from contact through release, when possible



- DPD experiences between 100-120 Class A & B marijuana arrests each month
- DPD experiences an average of 147 Class B theft offenses per month

Effective September 1, 2015, the amount for Class B Theft changed to \$100 or more, but less than \$750

- The previous amount was \$50 or more, but less than \$500

The arrest numbers do not factor in the valid ID and residing in county criteria

# Jail

- The pilot program will not reduce DPD's jail costs for Class A or B arrests, unless accompanied by a Class C arrest
- Class C arrests result in an intake fee and a housing fee
  - Housing fee is two days maximum

# The Summons

#### **Dallas County**

- Design, create, and print the summons
- Law enforcement agency orders citation/summons from County
- Court Process

#### **Dallas Police Department**

- · Sergeant witness field test and initial weight in the field

History

- The Dallas Police Department created the Nuisance Abatement Unit in 1991
- It was formed as a supplemental community-based policing strategy to abate historical criminal activity on properties
- The process is governed by Chapter 125 of the Texas Civil Practice and Remedies Code
- A 2005 House Bill amended the statute to require notification and meetings with property owners

### Definitions

- Chapter 125 of the Texas Civil Practices and Remedies Code defines a criminal nuisance as:
  - A person who maintains a place to which persons habitually go for the following purposes and who knowingly tolerates the activity and fails to make reasonable attempts to abate the activity maintains a common nuisance

## **Abatable Activity**

- Discharge of a firearm in a public place as prohibited by the Penal Code
- Reckless discharge of a firearm as prohibited by the Penal Code
- Engaging in organized criminal activity
- Delivery, possession, manufacture, or use of a controlled substance
- Gambling, gambling promotion, or communicating gambling information as prohibited by the Penal Code
- Prostitution, promotion of prostitution, or aggravated promotion of prostitution

## **Abatable Activity**

- Compelling prostitution
- Commercial manufacture, commercial distribution, or commercial exhibition of obscene material
- Aggravated assault
- Sexual assault/Aggravated sexual assault
- Robbery/Aggravated robbery
- Unlawful carrying a weapon
- Murder/Capital murder
- Continuous sexual abuse of a young child

### **Abatable Activity**

- Massage therapy or other massage services in violation of Chapter 455; Occupations Code
- Employing a minor at a sexually oriented business
- Trafficking of persons
- Sexual conduct or performance by a child
- Employment harmful to a child

### Mission

- The Nuisance Abatement Unit will marshal all administrative, legal, and community resources to:
  - Deny criminals use of real property as a base of operations
  - Secure property owner cooperation in removing the criminal elements
  - Secure property owner compliance with all applicable building, fire and health codes
  - Remove or seize blighted property

## Partnerships

#### **Dallas Fire Rescue**

 2 Fire Code Inspectors are assigned to the Criminal Nuisance Abatement Unit to assist with property inspections and take enforcement action as warranted

#### Department of Code Compliance

 2 Code Compliance Inspectors are assigned to the Criminal Nuisance Abatement Unit to assist with property inspections and take enforcement action as warranted

#### City Attorney's Office

 The City Attorney's Office advises and provides support to DPD throughout the SAFE case process. Assistant City Attorneys are often called upon to attend accord meetings and to assist in addressing the code aspect of a SAFE case particularly in cases where crime at a location is abated but code violations remain. As a last resort, the City Attorney's Office files lawsuits in State District Court when efforts to obtain voluntary compliance fail

- Property review is a result of:
  - Citizen complaints
  - Information generated by patrol officers and/or detectives
  - Routine review of offenses in a geographic area
  - Routine review of activity generated by the Narcotics Division



- A site must have a minimum of three (3) or more site specific instances of abatable criminal activity within the past twelve (12) months for case activation
- Additional considerations:
  - Size, occupancy, and use of site
  - Calls for service
  - Reasonable attempts by site's owner to abate criminal activity

# Process

- Post identification procedures:
  - Unannounced operation at location to include DPD, DFR and Code
  - Notification letter to owner/management company
  - Accord meeting with owner or representative to discuss crime and administrative violations. City personnel work with property owners to develop a plan towards compliance
  - 30 day re-inspection

# Process

- Post identification procedures continued
  - DPD, DFR and Code will monitor progress on administrative violations as well as site specific crime
  - Voluntary compliance will result in a closed case in as little as 120 days
  - Non-compliance can result in civil penalties and legal action up to and including one year closure of property



- 7 Dallas Police Department detectives (one assigned to each patrol division)
- 1 Office Assistant
- 2 Dallas Fire Rescue Inspectors
- 2 Code Compliance Inspectors
- Additional DPD officers are used as needed during property inspections

# Legal Action

- During FY 13-14 and FY 14-15 the City Attorney's Office has filed six nuisance lawsuits arising out of SAFE cases
- Four of those cases resulted in property closure (one on a temporary order), and a total of \$100,000 in civil penalties and attorneys' fees. Three of the six cases are awaiting <u>final</u> trial
- Since the end of FY 14-15 there have been an additional eight nuisance lawsuits filed as a result of SAFE cases
- In each of those eight cases the City is seeking property closure, and all are awaiting final trial

# Summary

- Criminal nuisances are defined in Chapter 125 of the Texas Civil Practices and Remedies Code
- The nuisance abatement process is a joint effort between DPD, DFR, Code Compliance and the City Attorney's Office
- Goal is voluntary compliance
- Non-compliance can result in fines and legal action against property owner

On November 9, 2015, at approximately 12:09 A.M., Officers #1, #2 and #3 were working in an off-duty capacity, in full police uniforms, at Kalua Discotheque, 2435 West Northwest Highway. The suspect was escorted from the club by an employee after causing a disturbance. The suspect retrieved his vehicle from the valet and while seated in the driver's seat, the officers made contact with him. The contact between the suspect and the officers was not confrontational. After making contact with the suspect, the officers began walking towards the rear of the parking lot.

At this point, the suspect put his vehicle in reverse and backed straight into Officer #1. Officer #1 was able to get out of the way of the vehicle without being seriously injured. The suspect then turned his vehicle in the direction of Officer #2 and Officer #3. As the suspect turned the vehicle in the direction of Officer #2 and Officer #3, the suspect accelerated rapidly, running over Officer #3. The suspect then put the vehicle in reverse and ran over Officer #3 a second time. Officer #1 and Officer #2 discharged their duty weapons striking the suspect multiple times. The suspect drove a short distance through the parking lot crashing into a tree and a parked vehicle before being taken into custody.

Officer #3 was transported to Parkland Memorial Hospital by Dallas Fire-Rescue with multiple serious injuries. The suspect was also transported to Parkland Memorial Hospital with multiple gunshot wounds. The suspect is expected to survive.

The IDM grant is part of the national traffic safety plan from the National Highway Traffic Safety Administration. These funds allow for the increased enforcement of DWI laws during specific date spans throughout the year. The target dates for FY 2016 are:

- December 15, 2015 January 9, 2016,
- March 1, 2016 March 27, 2016,
- June 21, 2016 July 12, 2016 and
- August 16, 2016 September 11, 2016

These enforcement actions are intended to reduce injury and fatality crashes. Alcohol is a major contributor to 31.1% of all fatality crashes in Dallas YTD 2014. The Traffic Section of the Dallas Police Department has utilized grant funding as part of its overall traffic safety plan for many years. The Traffic Section reviews the targeted sites for enforcement annually to ensure that officers are deployed in an effective manner.

The Dallas Police Department is seeking the support and recommendation of the Public Safety Committee to authorize the acceptance of the Impaired Driving Mobilization (IDM) Grant. This item will be placed on the December 9, 2015 City Council Agenda.



- SUBJECT: Upcoming Agenda Item 28: Authorize Supplemental Agreement No. 1 to the contract with Gensler for design and construction document services for security improvements to the lobby desk area at the Jack Evans Police Headquarters, located at 1400 South Lamar Street, and to perform seven building assessments to identify security enhancements at the Police Substations (list attached)

On Saturday, June 13, 2015 the Jack Evans Dallas Police Department (DPD) Headquarters was attacked by a lone gunman. It was found during the post incident evaluation that a security study of the existing building and site should be performed to identify potential enhancements that may better protect officers, personnel, and the public. A professional services contract was authorized with Gensler by AA15-6345, dated Monday, July 20, 2015.

Supplemental Agreement No. 1 to the contract will provide for design and construction document services necessary for initial improvements to the lobby desk and first floor windows at the Jack Evans DPD Headquarters. Additionally, it will provide for security reviews of current building and site conditions at the seven DPD substations and recommend enhancements that might be made at the facilities.

The Public Works Department is seeking the support and recommendation of the Public Safety Committee to authorize supplemental agreement no. 1 to the contract with Gensler. This item will be placed on the December 9, 2015 City Council Agenda.



- SUBJECT: Upcoming Agenda Item 69: A public hearing to receive comments on the reinstatement of the Dallas juvenile curfew ordinance, which provides daytime and nighttime curfew hours for minors

The Juvenile Curfew Ordinance, Dallas City Code Section 31-33, is due for reinstatement. The original curfew ordinance was adopted on June 12, 1991, by the Dallas City Council. The Texas Local Government Code requires that before the third anniversary of the adoption of a juvenile curfew ordinance and every third year thereafter, the City of Dallas must review the ordinance's effects on the community and on the problems the ordinance was intended to remedy, conduct public hearings on the need to continue the ordinance, and abolish, continue or modify the ordinance, or else the ordinance will automatically expire. The ordinance expired on May 1, 2015.

In order for the ordinance to be reinstated, there must be two public hearings prior to a final vote by the City Council. The two public hearings are scheduled for December 9, 2015 and January 13, 2016, before the City Council with the final vote occurring on January 13, 2016.

The Dallas Police Department is seeking the support and recommendation of the Public Safety Committee to accept this renewal and continue with Dallas City Code Section 31-33 Juvenile Curfew Ordinance. This item will be placed on the December 9, 2015 City Council Agenda.

Authorize a net increase in the contract with Tiseo Paving Company for additional and deductive work associated with the excavation of trash and debris in abandoned basement structures discovered during construction along Cesar Chavez Boulevard between Commerce Street and Pacific Avenue and replacement with select fill material suitable for a roadway base - Not to exceed \$290,206, from \$15,282,670 to \$15,572,876 - Financing: 2012 Bond Funds

#### BACKGROUND

This item is submitted as an addendum item in order to avoid further construction delays on the Cesar Chavez Boulevard roadway construction project.

On September 28, 2011, Resolution No. 11-2548 authorized a construction contract with Tiseo Paving Company for street paving, storm drainage, streetscape, landscape, traffic signal, water and wastewater improvements on Cesar Chavez Boulevard and Pearl Expressway. This action will authorize a change order to the contract with Tiseo Paving Company for additional and deductive work associated with the excavation of trash and debris in abandoned basement structures discovered during construction along Cesar Chavez Boulevard between Commerce Street and Pacific Avenue and replacement with select fill material suitable for a roadway base.

The planned improvements on Cesar Chavez Boulevard from Commerce Street to Elm Street entail converting the existing four-lane one-way roadway to a six-lane divided boulevard. Right-of-way needed for the improvements was acquired from former surface parking lot properties located at 2125 Commerce Street, 2221 and 2226 Elm Street, and 2222 Pacific Avenue. While demolishing the parking lots, the construction contractor encountered abandoned basements filled with trash and debris not suitable for a roadway base.

#### **BACKGROUND** (Continued)

Prior to constructing the new roadway, the trash and debris needs to be removed and replaced with select fill material.

This action will authorize an additional \$290,205.57 to the construction contract with Tiseo Paving Company. The actual cost to remove and replace the trash and debris in the basements with select fill is \$1,023,364.50. In order to keep the total construction contract within the 25% increase of the original contract amount allowed by State statute, work and construction items are being deleted and/or reduced in the construction contract for a net deductive amount of (-\$733,158.93). The breakdown for the deductive amounts are as follows: (1) paving, drainage and traffic signal work on Pearl Street between Live Oak Street and Pacific Avenue is being deleted from the project for a net deductive amount of (-\$662,575.10); (2) drainage and traffic signal/communication item quantities on Cesar Chavez Boulevard are being adjusted to account for overruns and underruns for a net deductive amount of (-\$59,411.83); and (3) sidewalk quantities for work adjacent to Klyde Warren Park that was previously change ordered into this project are being adjusted to account for underruns for a net deductive amount of (-\$11,172.00).

The street improvements on Pearl Street between Live Oak Street and Pacific Avenue that are being deleted from this contract in order to create the needed capacity in the contract are planned to be constructed later as part of a separate contract. Construction along this section of Pearl Street was already on hold as the roadway is being redesigned to accommodate planned improvements to John W. Carpenter Park. The proposed redesign of Pearl Street will reduce the street cross-section from the originally planned six-lane divided roadway to a four-lane divided roadway. A traffic study recently conducted concluded that the lane reduction would still maintain an acceptable level-of-service for traffic. The proposed redesign will serve to slow vehicular traffic and create a more pedestrian friendly roadway conducive to the urban park environment envisioned for the future improved John W. Carpenter Park. A Thoroughfare Plan amendment will be needed for the proposed roadway modifications and staff anticipates the amendment will be brought to City Council for approval consideration in early 2016. Construction on Pearl Street is estimated to recommence late summer of 2016 and be complete an estimated six months later.



- SUBJECT: Upcoming Agenda Item (G): Authorize (1) acceptance of the 2015 Homeland Security Grant from the Department of Homeland Security, which includes the Urban Area Security Initiative and the State Homeland Security Grant Program to provide funding for equipment acquisition, planning and training activities to enable the City to respond to natural and man-made disasters for the period September 1, 2015 through May 31, 2018; and (2) execution of the grant agreement

In September of 2015, the Department of Homeland Security announced its grant funding for the 2015 award year, totaling over \$1 billion for the nation. As a designated recipient of this funding, the City of Dallas has applied for and been awarded \$5,861,375 to build our capacity to prevent, protect against, respond to, and recover from a terrorist attack or natural disaster. There is no local match requirement for this grant.

The Homeland Security Grant Program (HSGP) is comprised of several grant programs and we received awards under two of those categories. Together, these grants fund a range of preparedness activities including planning, salaries, equipment purchase, training, exercises, and management and administration costs.

Under the Urban Areas Security Initiative (UASI), the City of Dallas has been awarded \$5,861,375. UASI focuses on the unique planning, equipment, training, and exercise needs of high-threat, high-density urban areas, with specific carve outs for law enforcement activities and management and administration of the grant. It assists us in building sustainable capacity to prevent, protect, respond, and recover from acts of terrorism.

This award will be used to fund:

- Enhancements to the City's communications systems
- Planning and execution for a backup Emergency Operations Center
- Sustainment and maintenance for prior year's projects
- Planning, training and exercise of emergency management and first responder personnel

Under the State Homeland Security Grant Program (SHSP), the City of Dallas has been awarded \$2,500. SHSP is designed to aid local governments in assisting with state-wide strategies.

From 2003-2014, the Department of Homeland Security has awarded the City of Dallas over \$85 million in grant funds under the HSGP. These funds are awarded based on an analysis of a region's risk level and the effectiveness of the grant application.

Staff is seeking the support and recommendation of the Public Safety Committee to authorize the acceptance of the 2015 Homeland Security Grant and execution of the grant agreement. This item will be placed on the January 6, 2016 City Council Agenda.
