This program will allow for the penalty enhancement of any additional family violence offenses and disqualify the individual from the purchase of possession of a firearm. This presentation gave an overview of the family violence conviction reporting process, the benefits of the program, its purpose, background, and the next steps. City Marshal indicated over the last three or four years there have been 2200 cases that were filed in municipal court.

3. Request to Initiate a Compliance Date for Nonconforming Use

Action Taken/Committee Recommendation(s):

The committee was briefed on the Request to Initiate a Compliance Date for a Nonconforming Use in discussion of a resolution requesting the Board of Adjustment to authorize compliance proceedings for Jim's Car Wash, located at 2702 Martin Luther King Jr. Boulevard, Dallas, Texas. The owner of the car wash was present, he was allowed time to speak and comment. Mr. Davenport stated he has worked with the City of Dallas for the last 25 years adhering to all rules and is open to questions by council and staff. This briefing was a source of a five-signature memo as an upcoming agenda item for the October 24, 2018 council agenda meeting. Director Sweckard then began the briefing emphasizing he would be discussing the process for initiating a compliance date for a nonconforming use to prepare members for the upcoming agenda item. Councilmember Felder expressed concerns about the safety of the location and numerous cars at the location during non-business hours.

4. RIGHT Care Program Update

Action Taken/Committee Recommendation(s):

Staff briefed the committee on the Rapid Integrated Group Healthcare Team (RIGHT) Interdisciplinary Pilot Program. This is a three-year grant funded program supported by the W.W. Caruth Jr. Foundation with Meadows Health Policy Institute oversight. The program was launched on Monday, January 29, 2018, as a multidisciplinary emergency response team to manage individuals experiencing behavioral health crisis in the Dallas Police South Central District. The response team includes a DFR paramedic, DPD Police officer and Parkland Hospital Mental Health clinician. All team members have received special training. Some of the objectives include hospital and emergency room diversion for behavioral health patients as well as linking these individuals to specialized care aimed at treating their condition. Staff discussed the program data and success stories arising from RIGHT Care response. This program has received national attention as Stakeholders-State/National level-interested individuals such as U.S. congressional members Senator John Cornyn and Pete Sessions who have visited Dallas to be briefed on how RIGHT Care functions and its impact to public safety. Councilmember Greyson asked about program extension beyond South Central, Chief Coatney responded DFR intends to bring this forward in the next budget cycle for expansion of the program. Using measurements in coordination with Dallas Police, the team intends to find out where the next focus area(s) would be.
