Strategic Priority Statement

Provide opportunities that enhance the standard of health, comfort, and happiness of Dallas residents









Organizational Structure



City of Dallas

- Dallas Animal Services
 - Exceeded both Dallas 365 performance targets (through July):
 - Field impoundments for all animals up 18% year-over-year (meeting goal)
 - Dog-only field impoundments up 22% year-over-year
 - YTD live release rate (LRR) at 85% vs. goal of 81%
 - Surpassed a 90% LRR in four different months in FY19
 - unprecedented for DAS
 - Loose dog bites down 7% year-over-year



- Code Compliance
 - Launched the Community Clean! initiative aimed at reducing illegal dumping, litter and high weeds in focused neighborhoods through regular community-led cleanups
 - Enhanced the Code Officer training program to provide comprehensive and hands-on field training
 - Implemented a community-based Code Academy to increase accessibility and participation and leverage partnerships



- Park and Recreation
 - Initiated the Fair Park management and operations contract to activate the park as a year-round destination
 - Implemented TRec (Teen Recreation) for teens ages 13-17 within Dallas, focused on specific program areas: 1) arts and culture, 2) community engagement and service, 3) health and wellness 4) leadership and life skills and 5) technology/STEM
 - Opened Phase I-A Aquatic Centers at Kidd Springs, Lake Highlands North, and Tietze and six spraygrounds at Timberglen, Nash-Davis, Kleberg-Rylie, K.B. Polk, Grauwyler, and Jaycee Zaragoza parks

- Dallas Public Library
 - Increased annual library visitors (2%) and circulation (6%) over FY18
 - Initiated Radio Frequency Identification (RFID) technology implementation for greater efficiency in managing library materials and improved customer service in tracking items
 - Procurement completed in June 2019
 - Complete equipment installations in FY20 and complete tagging more than 3 million materials in FY21
 - Implemented fine-free library in May 2019



Office of Arts & Culture

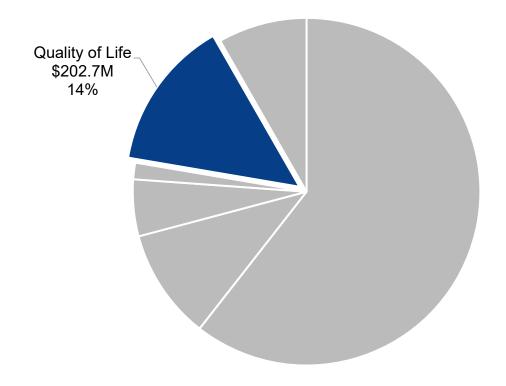
- Adopted the 2018 Cultural Plan and updated Cultural Policy and began implementation to align with new priorities: equity, diversity, space, support for artists, sustainability, and communication
- Initiated design for a multiform theater at the Latino Cultural Center
- Completed equity, diversity, and inclusion updates to the Cultural Operating Program (COP), specifically related to board and staff diversity, expanding access to events citywide, and revised funding limits to benefit smaller artistic organizations
- Completed updates to the ArtsActivate 2020 grant program to improve equity through expanded offerings in Dallas neighborhoods outside the urban core



- Office of Environmental Quality and Sustainability
 - Established Dallas as an environmental leader by developing a comprehensive environmental and climate action plan (CECAP) targeted for adoption by April 2020
 - Approved the 2019 Water Conservation Plan to provide to the state; one of the largest conservation initiatives, the ICI rebate program, is on track to add significant water savings
 - Adopted the City's first green energy policy, setting a benchmark of 100% renewable energy use for City operations and making Dallas the largest U.S. city using 100% renewable energy



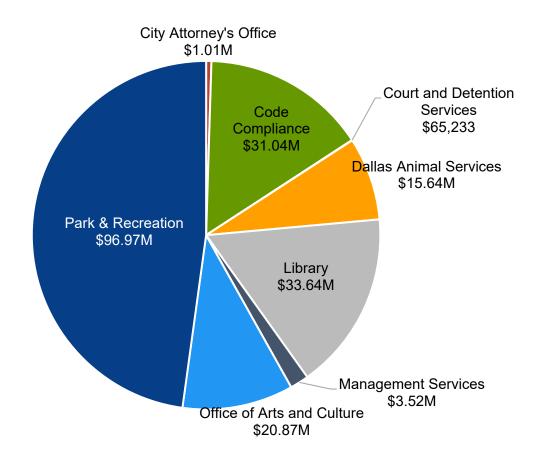
FY 2019-20 Budget by Strategic Priority



General Fund only



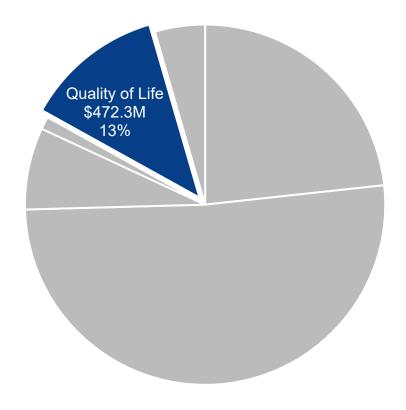
Strategic Priority Budget by Department

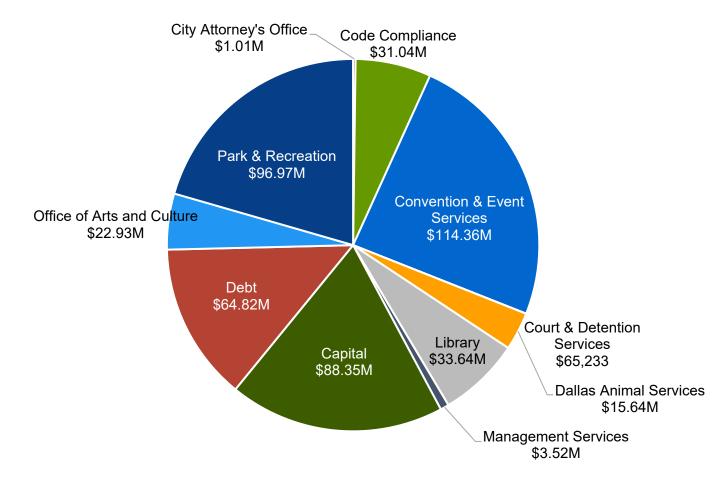
FY 2019-20 Budget by Strategic Priority

FY 2019-20 Budget Highlights

- Boost recreational programming for teenage residents with a focus on arts and culture, community service, health and wellness, leadership and life skills, and technology
- Increase security in parks and on trails by adding 11 positions to the Park Ranger program over the next three years: four in FY20 (\$286,000), four in FY21, and three in FY22
- Engage residents in the Community Clean! initiative to reduce illegal dumping, litter, and high weeds in focus neighborhoods through regular community-led cleanups



FY 2019-20 Budget Highlights

- Expand Internet access, a basic 21st-century need for education and employment, to more residents by making mobile hot spots available for checkout at high-need libraries
- Augment overnight animal service response by scheduling officers to be on duty seven nights a week instead of four
- Create pop-up cultural centers to bring cultural activities to areas of the city without easy access to arts programming

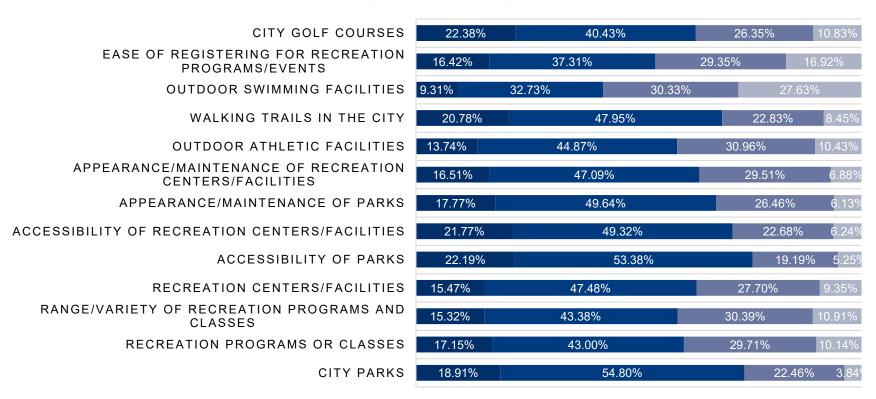


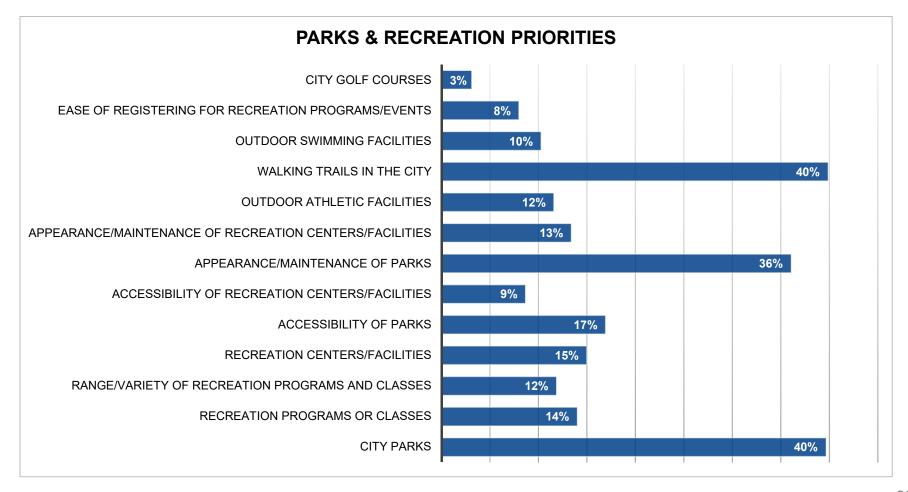
PERCEPTIONS OF PROBLEMS IN THE CITY

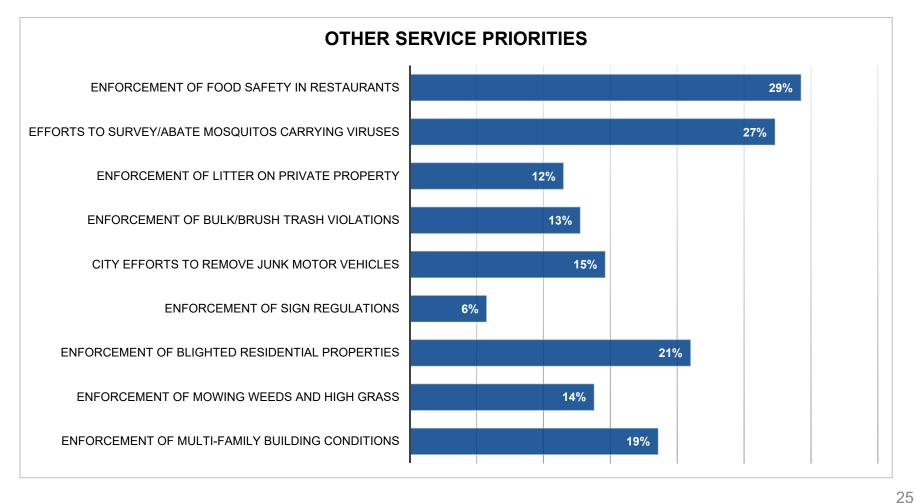




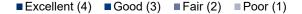

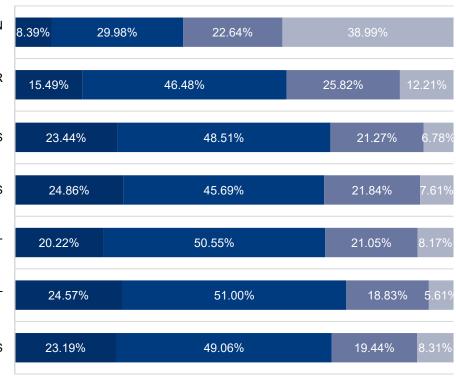
