SUBJECT: Public Safety Committee – Follow Up Responses on Swiftwater Rescue and Juvenile Curfew Ordinance

Listed below are the responses to follow up items discussed during the Public Safety Committee meeting held on Monday, November 9, 2015.

Question:

What is the total number of prosecutions undertaken since the enactment of the Juvenile Curfew Ordinance?

Response:

Court and Detention Services provided citation data that included open and closed prosecutions. The total number of citations that have been issued since the enactment of the Juvenile Curfew Ordinance is 37,977. For calendar year 2014, 610 citations were issued and for calendar year 2015 (January thru April), 145 citations were issued. A more detailed matrix will be provided at a later date.

Question:

What are the areas that continually produce Swiftwater Rescue calls?

Response:

From January 1, 2015 to November 11, 2015 Dallas Fire-Rescue responded to a total of 50 incidents within the City of Dallas that included "Water Rescue with Boat", "Underwater Recovery", and "Swiftwater Rescue". They are attached for your review.

The critical areas included:

- 3 incidents @ 1400 block California Crossing Road
- 3 incidents @ 7300 W. Kiest Boulevard
- 3 incidents @ 2300 Middlefield Road
- 2 incidents @ 1680 and 2340 W. Northwest Highway
- 14 incidents @ White Rock Lake/White Rock Trail areas (Lawther, Mockingbird, White Rock Road

The first four areas are due primarily to the flooding which occurred during May and June. The large number of incidents at White Rock Lake is a combination of both recreational boaters requiring rescue and people getting caught unexpectedly on the White Rock Trail by rapidly rising water.
