SUBJECT FY 2021-22 Adopted Budget

Once again, I want to thank each of you for your participation and commitment to the City's budget development and approval process.

On Wednesday, September 22, the City Council completed all steps required to adopt the FY 2021-22 operating, capital, and grants/trusts budgets. After receiving the City Manager's recommended budget on August 10, the City Council considered 42 amendments of which 16 received a majority support. Attached is a summary of the 16 amendments that have been incorporated into the adopted budget. We will update both the on-line and printed budget document to reflect the adopted budget and make those available during October.

Also on Wednesday, in support of the adopted budget, the City Council set the property tax rate for FY 2021-22 at 77.33¢ per \$100 valuation. This is 0.3¢ less than the FY 2020-21 tax rate of 77.63¢ and makes this the sixth consecutive year since FY16 that the City Council has lowered the tax rate. Dallas County Tax Office anticipates sending tax bills to property owners the second week of October.

As we do every year, we will closely monitor revenues and expenses, performance metrics, and significant budget initiatives and report to you monthly through the Budget Accountability Report (BAR). This report is provided to the Government Performance and Financial Management Committee, as well as to the entire City Council.

SUBJECT D2 Eastern End Alignment - Zone B Progress Update #4

Background

On March 24, 2021, the City Council passed a resolution (<u>CR 21-0535</u>) in support of the Dallas Area Rapid Transit (DART) D2 project. The resolution included a map (copy attached and <u>linked</u>) that separated the alignment into two zones; Zone A, where the alignment is set with no significant changes, and Zone B, the eastern end of the alignment where discussions with DART, North Central Texas Council of Governments (NCTCOG), Texas Department of Transportation (TxDOT), and other stakeholders are continuing. The goal of these continued discussions is to explore potential refinements, enhancements and/or modifications to D2 in Zone B (hereafter referred to as "alternatives") to address community concerns and optimize the project's interface with IH-345. This process involves the following key steps:

- Document and discuss key issues
- Develop alternatives based on input from agencies and stakeholders
- Evaluate and compare key factors to enable decision-makers and elected officials to clearly understand the differences in potential impacts, benefits, costs, scope, and schedule
- Develop an agency staff recommendation and a draft interlocal agreement

Section 6 of the resolution contained a provision for elected and appointed officials of the City, DART, NCTCOG, and TxDOT to be briefed on a regular basis to document progress and stakeholder feedback.

Progress


The first progress memorandum to City Council on <u>April 23, 2021</u>, provided information on the creation of a work plan and schedule (Attachment 2). The second progress memorandum to City Council on <u>May 21, 2021</u>, outlined work that had been completed to identify issues, develop the range of Zone B alternatives to be evaluated, and begin drafting the evaluation process and parameters. The third progress memo on <u>July 30, 2021</u> provided an update on the first level screening of alternatives.

The first public/stakeholder meeting was held on August 5, 2021 (<u>link</u> to presentation), during which staff from the various agencies presented the results of the first level screening. It was recommended that eight out of the 18 alternatives should be advanced to second level screening.

Fourteen comments or questions were received during the public meeting, and 18 comments were received during the public comment period that followed the meeting from August 5 to August 26, 2021. Numerous comments expressed a preference for a



particular option with the majority supporting Option 3-7a or 3-1a. Several comments expressed opposition to options in Family 1.



Next Steps

A second stakeholder meeting is schedule for <u>September 29, 2021</u> to present the results of the second level screening of alternatives.



The partner agencies will continue to meet and are committing the necessary resources to guide this process so that any recommended refinements, enhancements, and/or modifications to Zone B are finalized no later than December 2021.



New Updates

Encampment Resolution (Cleaning) Schedule September 23, 2021

OHS Street Outreach team is gearing up for the start of the Dallas R.E.A.L. Time Rapid Rehousing (DRTRR) Initiative on October 1st by using 311 data and sites identified in the field to develop the outreach and resolution via housing approach briefed to City Council on August 4th. During this time, they will continue to engage with unsheltered residents through normal street outreach, connecting people with the needed resources, such as: getting IDs, working with Community Courts on expunging eligible tickets and offenses from their records, identifying medical needs, and getting them access to the Coordinated Access System (CAS).

Please see the attached schedule for homeless encampment cleaning the weeks of September 20th – September 24th and September 27th – October 1st. Please note that these will be for debris removal and outreach only.

City Manager's Corner

In partnership with Toyota's Production System Support Center and a cross departmental team of City employees trained in process improvement, the Budget and Management Services Process Improvement Team has completed its first project – Building Permit Customer Service Improvement. This complex business process was an ambitious one for the brand-new PI Team, and we are proud to announce that the customer service team in Sustainable Development and Construction, under the leadership of Patrick Blaydes, has reached its goal of increasing the number of calls with satisfactory responses for our customers by 14 percent. Initially, only 76 percent of calls were being handled timely and satisfactorily; others were on hold too long, abandoned by customers, or answered unsatisfactorily, requiring customers to try calling again. At the end of the project, more than 90 percent of calls were answered timely and satisfactorily, with a 57 percent reduction in customers waiting on hold over 15 minutes. The PI Team began by identifying pressing business needs and conducting time studies, using this information to implement visual management and encourage data-driven decision making. They also categorized and prioritized calls, engaged employees through daily and weekly huddles, and redesigned processes to take advantage of improvements generated by the time study analysis and employee feedback. The Call Center is now on track to continue these positive trends and employees are empowered to use the tools they learned to continue making small changes for the better, delivering a Service First customer experience to residents and builders. The team will brief the Government Performance & Financial Management committee on the project and results at their October meeting.

New City Enterprise Contact Center (ECC) Going Live

On the evening of Friday, September 24th the City's new Enterprise Contact Center (ECC) comes online. Beginning at 8:00 p.m. Friday, the Information and Technology Services (ITS) Department begins the cutover from the current end-of-life Contact Center to the new ECC. Over the weekend, ITS, working with City departments, will phase over users to the new ECC with the new Contact Center fully operational by Monday, September 27th.

The new ECC represents a wholly redesigned and modernized call center infrastructure. It will provide a secure, stable, adaptable, and scalable platform that allows City Departments to deliver contact center services to the residents and businesses of Dallas. It will include Natural Language Programming (NLP) to allow easier interaction with residents and businesses in both English and Spanish. City Departments will use Workforce Management and Data Analytics capabilities to predict and anticipate work scheduling requirements. There will be greater support for remote operators and allow the City more options to respond to events such as natural disasters or pandemics in a more efficient manner. And it will provide Call Recording capabilities to meet regulatory requirements of the different departments.

During the transition to the new ECC you can expect minor, intermittent service disruptions as City Departments are phased into the new platform. While these

disruptions are expected to be limited in duration, callers may experience short, intermittent problems while using the Interactive Voice Response (IVR) system and attempting to access certain Contact Centers during the cutover period as departments are transitioned from the old contact center to the new ECC.

During this transition weekend, should City staff receive reports of residents experiencing problems in reaching Department call centers, please refer to the phone number provided in the announcement sent to City staff on Thursday, September 23, 2021 for support.

City Departments using the new ECC include 311, WIC, HR/PER, PKR, ITS (Orion Phone Team), AVI, SDC (DEV Building Inspections), DPD, DWU Water Collections and Libraries. If you have any questions or for more information, please contact Chief Information Officer Bill Zielinski.
