SUBJECT **Street Feeding Update**


The purpose of this memorandum is to provide the City Council with an update on the rise in street feeding we anticipate over the coming weekend.

Resolution on Street Feeding

OHS expects an uptick in street feeding this weekend, leading to higher levels of trash and potential traffic-blocking activities in certain areas of town. To counter this, we are working with Code Compliance, the Dallas Police Department, and Street Cleaning on an interdepartmental approach to abating the potential for debris and traffic-blocking activities. This process will cover Young Street through Cadiz Street and include the following:

- DPD Personnel on site Sunday, April 4th to ensure that the flow of traffic is not impeded
- Additional trash bins located on:
 - 1500 MLK JR. Blvd
 - 1700 Cadiz Street
 - 1502 Canton Street (Both Star Parking lots)
 - Corsicana Street & South Ervay Street
 - Marilla Street & Canton Street
- Additional Street Cleaning Department staff on standby to deal with any debris that does not fall within the Dallas Downtown Inc. cleaning boundaries.

Please direct requests relating to donations or volunteer opportunities to support our homeless outreach efforts, to 311. This will help OHS Staff ensure that information for volunteer centers or charitable organizations is being disseminated according to specific areas of interest to residents. OHS is working on an education campaign around sustainable donations to target this issue, which will be rolled out soon. SUBJECT **Response to Questions from the March 23, 2021 Advanced Water Metering Technology Briefing – Dallas Water Utilities**

This memorandum is in response to a question raised during the March 23, 2021 briefing, Advanced Water Metering Technology, as to the security of meter read data.

Dallas Water Utilities (DWU) has used automated meter reading since our initial pilot in 2008. DWU uses a Fixed Network Application Server (FNAS) which collects meter reads. The meter reads are stored in a dedicated secure server by our vendor Itron, where they remain until retrieved by DWU. DWU accesses the FNAS application through a password-protected login to select the meter reads as needed from the server for billing.

As part of the City's external financial audit, SAP and billing processes are reviewed annually.

Dallas Water Utilities places the security of customer data at the forefront of all business decisions. As we proceed with hiring an Advanced Water Metering Technology consultant, security of data will be a consideration in the feasibility study and in all future decisions of the utility.

SUBJECT **COVID-19 Vaccine Distribution Dashboard Updates**

On February 25, the Office of Data Analytics and Business Intelligence (DBI) briefed the Ad Hoc Committee on COVID-19 Recovery and Assistance on updates to the City of Dallas' bilingual COVID-19 dashboard. The [dashboard](#) includes pages on testing, number of cases, and anonymous demographic data on vaccine recipients including race, ethnicity, gender, age, and ZIP code.

The COVID-19 global pandemic is evolving, and the City's COVID-19 dashboard continues to evolve in response. To provide our residents with the most up-to-date and relevant information, DBI recently updated the dashboard to include state-wide data showing all the vaccinations distributed in Texas and the percentage of people aged 16 and older vaccinated by county. This important statistic will show our progress towards community immunity, which is currently estimated to be between 70 to 85 percent.¹ Dallas County currently has 15.4 percent of residents 16 years of age or older vaccinated.

As of March 20, the data source for COVID-19 cases and mortality on the dashboard is Johns Hopkins University. This change was made for several reasons: 1) Johns Hopkins University is considered the gold standard in COVID-19 cases and mortality data; 2) it eliminates the delay in reported mortalities; and 3) by reducing to fewer, more automated sources, possible errors are eliminated. Careful observers of the Dashboard will notice an increase in our current total counts of cases because the Johns Hopkins University data includes both confirmed and probable cases, whereas the dashboard previously displayed only confirmed cases. For example, in the DFW region, the case count went from 644,862 to 766,576, increasing by approximately 120,000.

In switching to the Johns Hopkins University data and implementing custom coding scripts, the DBI team has successfully automated the COVID-19 dashboard, eliminating the need for manual updates and saving 16 hours of staff time per day. This automated process represents best practices in data science, reduces chance of introducing error, and enables staff to shift focus toward analysis and new projects.

[Encampment Resolution Schedule March 30th, 2021](#)

The Office of Homeless Solutions (OHS) has scheduled the following sites for homeless encampment cleaning the weeks of March 29th-April 2nd and April 5th-April 9th. Please note that these will be for debris removal and outreach only. For encampment resolution, the Parks Department, OHS, and the Dallas Police Department initiated an encampment removal at Cottonwood Trail on March 29th, which was completed on March 31st.

The OHS Street Outreach teams have continued to engage with individuals to provide notice of clean-up and connect to resources and shelter. The OHS Street Outreach Team has:

- Engaged a total of 63 unsheltered residents
- Linked 14 unsheltered residents to MLK Community Service program through Night Court to expunge existing tickets. This helps remove barriers for recovering IDs
- Referred 1 Veteran to the American GI Forum for housing through the Veteran Outreach Program
- Referred 5 residents to Our Calling for shelter and a COVID-19 vaccination
- Referred and provided transportation to 1 unsheltered, pregnant resident to the Hannah House Maternity program

Friday, March 26th: Univision 23 (Erika Torres Caraban) - Is your fire department teaming up with any agency/organization such as Meals on Wheels to help vaccinate seniors? Are there any new efforts/events coming up to help make sure all seniors who want to get vaccinated are vaccinated as eligibility for the covid-19 vaccine opens up to all adults in Texas on Monday but those 80years and older remain the priority?

City Response - I can't confirm any efforts at this point in time. I know there have been discussions with the City's Office of Emergency Management about how to go about getting the vaccine to our homebound citizens, like those served by Meals on Wheels, but nothing has been confirmed.

Friday, March 26th: NBC 5/Telemundo (Joanna Molinero) - I was reaching out you for information on a residential 2-alarm fire on 9930 Brockbank Dr. [2021078081](https://www.dallasfire-rescue.com/2021/03/26/2021078081).

City Response - Units were assigned to the call at 17:19, after 911 calls reporting a fire at a one-story home on the 9900 block of Brockbank Drive in Northwest Dallas.

While there was an initial offensive attack, efforts shifted to a defensive posture and a second alarm was transmitted.

It is unclear whether anyone was inside when the fire began, there were no injuries reported as a result of the fire.

The fire was declared extinguished at 18:40, and the cause of the fire is undetermined.

Monday, March 29th: All local media outlets – Can you send information on the multi-alarm fire DFR is responding to on Forest Lane? Thank you.

City Response - On Monday, March 29th, at 5:29 p.m., Dallas Fire-Rescue responded to a 911 call for a structure fire at the Forest Cove Apartments, located at 9600 Forest Lane, in Northeast Dallas.

When firefighters arrived at the two-story apartment complex, they observed fire coming through the roof of a two-story apartment building. With the fire being in its advanced

stages, it wasn't too long before a second alarm response was transmitted. Though there was brief attempt at an offensive attack, fire conditions forced attack teams to pull out and take a defensive posture. The fire spread to three neighboring buildings, resulting in the transmission of third, fourth and fifth alarms before approximately 100 firefighters were ultimately able to bring the fire under control. Personnel are still on scene digging through debris in search of remaining hot spots.

A total of 52 apartments, among the four buildings involved, were destroyed by fire. Though there were no injuries reported, there was one resident who had to be taken to a local hospital for a medical emergency unrelated to the fire. There is no confirmed number of residents displaced as a result of the fire, but the American Red Cross and the Salvation Army were notified to provide assistance where needed. Thankfully, the apartment complex was able to provide alternate living accommodations to its residents.

The cause of the fire is currently undetermined, and at least three of the four buildings involved look to be a total loss.
