#### Dallas Love Field Earns GBAC Star Accreditation

Dallas Love Field has earned the Global Biorisk Advisory Council STAR Accreditation for its commitment to cleaning and disinfecting, biohazard and infectious disease mitigation and highly informed cleaning staff. GBAC STAR is the gold standard for prepared facilities and the cleaning industry's only outbreak prevention, response and recovery accreditation for facilities.

GBAC Star accredited facilities are those whose staff is implementing the industry's highest standards for cleaning and disinfection of infectious agents like the novel coronavirus. The STAR Facility program has 20 elements, including creating plans and guidelines for personal protective equipment requirements, choosing appropriate cleaning and disinfecting chemicals and continuous improvement. DAL is the second City facility to earn accreditation, joining the Kay Bailey Hutchison Convention Center.

The Community Police Oversight Board (CPOB) and the Office of Community Police Oversight (OCPO) celebrated it's one-year anniversary last month. CPOB Chairman Jesuorobo Enobakhare, Jr. and OCPO Director Tonya McClary briefed the full City Council at the October 7, 2020 meeting to discuss the purpose of the office, board structure, duties, functions and accomplishments during their inaugural year. The CPOB also hosted its monthly meeting on October 13, 2020 virtually. Highlights of the meeting included a moment of silence to honor black women that have been killed by law enforcement locally and nationally, names of slain women were read by CPOB members and OCPO staff, and a special recognition proclamation from Mayor Eric Johnson that was read by Walter "Changa" Higgins, Chair of the Dallas Community Police Oversight Coalition. The Board finalized the dates to receive applications and vote on community members to join their five subcommittees. 



<u>Wednesday, October 28<sup>th</sup></u>: Spectrum News (Oscar Almaraz) - Hello, My name is Oscar Almaraz, and I am a photojournalist with Spectrum News. I'd like to know I you can send me the names and come tact information of anyone who we can contact in regard to the possibility of protests or riots during election night.

City Response – In the interest of security, the department respectfully declined the interview request, and issued the following statement instead – Dallas Fire-Rescue is committed to the safety of the citizens and guests of this City during the upcoming election day. Therefore, the department has made plans to have adequate staffing in place should planned peaceful demonstrations evolve into something more dangerous. We have worked closely with the Dallas Police Department, as well as the Office of Emergency Management, and other local, State and Federal partners, to help ensure a safe environment for our first responders as well as those individuals and groups who simply wish to peacefully express their First Amendment Right of free speech among others. Additionally, back-up EMS and Fire Operations resources have been pre-designated in case the need arises, and to prevent any disruption of service to the rest of the city.

<u>Thursday, October 29<sup>th</sup></u>: Lake Highlands Advocate (Elizabeth Ucles), Univision 23 (Sandy Moncada) and KRLD (Bailey Friday) - I'm reaching out about an active structure fire at 9600 Plano Road from today Oct. 29. Could you provide details on when the fire started, what properties were affected, cause and any other relevant details?

<u>City Response</u> - At 10:20, Dallas Fire-Rescue units were dispatched to a 911 call for a structure fire at the Heavenly Christian Academy, located at 9625 Plano Road, in East Dallas.

When firefighters arrived at the location, they observed heavy smoke coming from the front of a one-story commercial strip shopping center. They deployed handlines and moved in for a quick attack; locating and extinguishing the fire in approximately one hour.

There were an unknown number of faculty and students at the school when the fire began. Thankfully, everyone was able to make it out safely before firefighters arrived; resulting in no injuries to report of.

According to investigators, the fire was accidental in nature, and most probably began as the result of an unspecified mechanical malfunction of the clothes dryer located in a rear laundry room of the business. Thankfully, the fire damage was limited to the business or origin.

<u>Friday, October 30<sup>th</sup></u>: **DFW Scanner (John Burgdorf) -** Hi Jason, we are publishing an article on how to reduce the threat of house fires during the winter months. As a fire department official, I'm hoping you can help us educate others by answering a few questions below:

- 1) What are some of the leading causes of house fires during the winter months?
- 2) What steps do you recommend for people to stay safe and reduce the threat of a house fire during winter?

<u>City Response</u> - While there are a number of causes for house fires, like cooking, candles smoking and Christmas Trees, in the winter months (December, January and February), the leading cause is heating equipment; with space heater leading the way in causing 40% of heating fires during those months. Dallas Fire-Rescue recommends keeping anything that can burn at least three feet away from heating equipment, establishing a "kid-free" zone to prevent injuries to little ones, turning heating equipment off when leaving the room or going to bed, and most importantly, making sure you check you smoke alarms monthly. Additionally, we recommend having your heating equipment and chimneys cleaned and inspected by a qualified professional.

<u>Monday, November 2<sup>nd</sup></u>: All Local News Desks – Any info you can send us on a 2 alarm fire at 11053 Strayhorn Drive?

<u>City Response</u> - On Monday, November 2nd, at 11:20 a.m., Dallas Fire-Rescue units were assigned to a 911 call for a structure fire at a home, located at 11053 Strayhorn Drive, in East Dallas.

When firefighters arrived at the large two-story residence, they observed thick black smoke coming from the roof. First arriving companies were met in the front yard by the homeowner informing them that the five people who were inside had already made it out safely. Upon making entry, they found heavy fire in the attic of the home. Due to the advanced nature of the fire, crews were pulled out, a request for second-alarm was transmitted and defensive suppression efforts began. It wasn't long after that point that the roof began to partially collapse into the home.

Approximately 50 firefighters responded to the scene and worked to declare the fire extinguished in just over an hour. The fire left behind significant damage, but thankfully there were no injuries to report of.

Though most of the fire was located in the attic upon arrival, investigators have not been able to determine a point of origin. As it currently stands, the cause of this fire is undetermined.

City Building Inspectors check for accessibility items in the field required by the Dallas Building Code's (International Building Code as amended) accessibility chapter. The responsibility lies with the State's Texas Accessibility Standard plan reviewers and inspectors. On permit applications, the City makes sure that projects are registered with the State, so the review and the inspection occur through their third-party program. Please note that the City of Dallas does not issue business permits, so that is not applicable."
