SUBJECT Update on CARES Act Funding

In response to City Council's request during the Ad Hoc Committee on COVID-19 Recovery and Assistance yesterday, this memo provides a status update on CARES Act funding. As of November 3, the City has received \$335.1 million through the various CARES Act programs.

The largest amount the City has received is the \$234 million from the U.S. Treasury Coronavirus Relief Fund (CRF). We allocated this entire amount on April 22—please refer to the <u>June 17</u> and <u>August 19</u> City Council briefings for more details.

As a reminder, all CRF funds must be spent by December 30, 2020. We report CRF expenditures to the U.S. Treasury quarterly; to date, we have submitted reports for the period ending June 30 and the period ending September 30. As of November 3, we have spent or encumbered \$102.6 million, about 44 percent of the total.

To ensure the City meets the December 30 deadline, we review each department's spending plan regularly and reallocate funds as needed. Last week, the City Manager approved the reallocations outlined in the table below.
