SUBJECT **January 12, 2022 City Council FINAL Agenda - Additions/Revisions/Deletions**

On December 30, 2021, a DRAFT City Council Agenda for January 12, 2022 was provided for your review. This memorandum outlines any additions, revisions or deletions made to the FINAL agenda after the distribution of the DRAFT agenda. In addition, we have highlighted agenda items which have been briefed to the City Council and/or Committee by briefing memorandums.

Additional items and deletions to the DRAFT agenda are outlined below, including *revisions* to the FINAL agenda are underlined in blue and *deletions* are strikethrough in red. A brief explanation for revisions along with staff's contact information is provided.

On January 12, 2022 City Council will consider the following agenda items:

Agenda Item No. 2: Authorize a construction services contract for interior and exterior restoration of the Juanita J. Craft Civil Rights House located at 2618 Warren Avenue with Nouveau Technology Services, L.P. dba Nouveau Construction and Technology Services, L.P. through Sourcewell Contract TX-NT-101619-NCT - Not to exceed \$1,137,298.03 - Financing: Juanita Craft Civil Rights House & Memorial Garden Fund (\$272,372.00), Capital Construction Fund (\$350,879.96), Park and Recreation Facilities Fund (2006 General Obligation Bond Fund) (\$54,046.07), and Gifts & Donations Fund (\$460,000.00)

This item authorizes the restoration of the Juanita J. Craft Civil Rights House, which was originally constructed in 1926 and donated to the City of Dallas by the Honorable Juanita J. Craft. The house is designated a City of Dallas Landmark in honor of the woman who made many contributions to the civil-rights movement.

The restoration of the Juanita J. Craft Civil Rights House is the first step in the larger initiative to re-open the Juanita J. Craft Civil Rights House and Memorial Garden for use as a public historic site open to the public on a regular basis under the management of the Office of Arts and Culture (OAC). On November 10, 2021, City Council approved a contract for the fabrication and installation of an interpretive museum. Upon completion of the museum, this will be the only publicly accessible house museum to honor Ms. Craft, a former City Council member and grass-roots community organizer who had a profound influence on her community, and the country as a whole.

The City was awarded a \$500,000 African American Civil Rights (AACR) Preservation Grant toward the rehabilitation and repair of the Juanita Craft House and adjoining garden located near the Wheatley Place Historic District. In addition, the Junior League of Dallas (JLD) established a partnership with OAC to restore the Juanita J. Craft Civil Rights House and Memorial Garden as their Centennial Anniversary project. A donor fund entitled "OAC Juanita Craft House and Garden Fund of Community Foundation of Texas" has been established enabling private donors to provide funding as well, in accordance with the City of Dallas Cultural Plan and Policy.

The Audelia Road Branch Library's roof has developed leaks and water infiltration has been detected inside of the building causing wet wall and ceiling tiles. The Audelia Road Branch Library has undergone two roof assessments that support the need for roof replacement including new roof drains, new metal coping and waterproofing as necessary along the exterior storefront windows to protect the interior of the library from water and moisture entry.

Agenda Item No. 4: Authorize a two-year construction services contract, with two one-year renewal options for job order contracting for waterproofing and roofing repairs, replacements, alterations and improvements with Chamberlin Dallas, LLC through The Interlocal Purchasing System Contract No. 21060302 - Not to exceed \$4,000,000.00 - Financing: Capital Construction Fund (subject to annual appropriations)

Job order contracting (JOC) is an alternative contracting method authorized by the state legislature that provides an option to address construction, repair, rehabilitation, and alterations at City owned buildings. JOC in many cases allows projects to be initiated and completed faster than traditional construction delivery methods. No quantity or value of work is guaranteed to the contractor. This contract is focused on roofing and waterproofing.

Agenda Item No. 5: Authorize ~~Supplemental Agreement No. 1 to the service~~ [a service](#) contract with LJ Power, Inc. for facility electrical infrastructure upgrades and sitework for the installation of eight generators at designated City facilities through The Local Government Purchasing Cooperative Contract No. ~~577-18~~ [657-21](#) - Not to exceed \$1,651,461.00, ~~from \$1,627,633.50 to \$3,279,094.50~~ - Financing: Capital Construction Fund

This item authorizes the facility electrical infrastructure upgrades and sitework needed to support the installation of eight generators at City facilities that were designated to be warming/cooling centers for residents impacted by power outages during extreme weather events. The locations were identified by staff using equity, demographic and other data along with input from the City Council. The locations provide a warming/cooling centers within relatively close proximity to all areas of the city. The generator purchases were approved by City Council on September 9, 2021, in consideration of the lengthy manufacturing lead times. These locations provide a warming/cooling site within proximity to all areas of the city:

- Audelia Road Branch Library, 10045 Audelia Road - 200 kW generator
- Beckley-Saner Recreation Center, 114 West Hobson Avenue - 400 kW generator
- Jaycee Zaragoza Recreation Center, 3114 Clymer Street - 300 kW generator
- Kleberg-Rylie Branch Library, 1515 Edd Road - 150 kW generator
- Marcus Park Recreation Center, 3003 Northaven Road - 250 kW generator
- Mountain Creek Library, 6102 Mountain Creek Parkway - 150 kW generator
- Pleasant Oaks Recreation Center, 8701 Greenmound Avenue - 350 kW generator

The policy of the City of Dallas is to involve certified Minority and Women-owned Business Enterprises (M/WBEs) to the greatest extent feasible on the City’s architecture & engineering, construction, goods, and professional services contracts. The City’s Business Inclusion and Development Policy (BID Policy) is overseen by the Business Inclusion and Development (BID) division of the Small Business Center, which is providing this summary of M/WBE participation for the January 12, 2022 City Council Agenda.

As a reminder, the M/WBE goals that became effective on October 1, 2020 are:

Agenda Item No. 37 Authorizes a three-year master agreement for tapping machines, water meter security locks, and parts for the Water Utilities Department. These machines and parts are delivered directly from the manufacturer leaving no opportunity for M/WBE participation.

On January 12, 2022, the following Office of Procurement Services item will be considered by City Council:

File ID: 22-96: Authorize a one-year subrecipient agreement to provide essential needs, and economic and financial stability support services to low-to-moderate income residents impacted by the COVID-19 pandemic for the Office of Community Care - CitySquare in the amount of \$715,363.80, Friendship West Baptist Church in the amount of \$458,250.00, Services of Hope Entities, Inc. in the amount of \$471,132.00, and The Chocolate MINT Foundation in the amount of \$100,000.00, most advantageous proposer of seven - Total not to exceed \$1,744,745.80 - Financing: 2020 CARES Act Relief CDBG #3 Fund (subject to annual appropriations)

Background

This item was previously scheduled to be considered by City Council on December 8, 2021, but was removed from the agenda due to a scoring issue related to the procurement process. Once this issue was identified, staff recognized that the updated scoring changed the initial ranking of the awards and therefore the recommended awards amounts. This update impacted the rankings of the projects under the Making Food Accessible service category. As a result of this assessment, staff is awarding an additional contract to an organization whose rank changed from 4 to 2 as a result of the update. Staff is able to make this additional contract using funding previously allocated for administrative costs for subrecipients due to lower than projected administrative costs from multiple CARES CDBG contracts.

In 2020, the City of Dallas received a third allocation of CDBG funding from the CARES act to be used for services responding to the COVID 19 pandemic, titled CV-COVID-19. A total of \$1.95M was allocated for a variety of client services programming, titled the “CDBG Drivers of Poverty”, within which \$1,519,745.80 was allocated to the Client Assistance Program specifically to provide essential items and services to individuals who have been economically impacted because of the COVID-19 pandemic and the remainder to child care services. The City of Dallas Office of Community Care (OCC) was seeking multiple Subrecipients through a Request for Proposal (RFP) to offer several service types, all aimed at supporting economic stabilization and financial stability.

SUBJECT **Upcoming Office of Community Care and Office of Procurement Services Agenda Item – December 8, 2021**

The City of Dallas Office of Community Care (OCC) sought agencies through a request for proposal process to serve as subrecipients for the purpose of administering the CV-COVID-19 Drivers of Poverty Program throughout Dallas city limits to residents economically impacted because of the COVID-19 pandemic. The program targets low-income clients who are among the identified populations highlighted by the 2017 Mayor’s Task Force on Poverty. Service Types sought included Client Assistance Programs that provide 1) food and other essentials, 2) transportation assistance, 3) health care financial assistance and services, and 4) mental health financial assistance and services.

The Evaluation Committee individually scored each service category, as provided below. Awards are based on scoring rank within a service category by target population.



SUBJECT **DPD Fleet Budget Amendment – Follow-Up to January 3 Environment and Sustainability Committee Meeting**

During the January 3 Environment and Sustainability Committee meeting, councilmembers asked questions about public safety fleet electrification. Staff is deeply committed to advancing the goals of CECAP and building an environmentally sustainable fleet operation; however, we do not have current plans to purchase electric public safety vehicles. Working with the National Renewable Energy Laboratory, we are studying alternative fuel vehicles for future fleet purchases and planning implementation as quickly as possible without sacrificing the high service levels we expect from our public safety fleet day-in and day-out.

Specifically, the Committee discussed a FY 2021-22 budget amendment directing staff to move funds from Dallas Police Department (DPD) overtime to DPD fleet purchases (amendment #4, sponsored by Councilmember Bazaldua). This amendment, adopted in the FY 2021-22 budget on second reading on September 22, received 8 straw votes in support on September 1 (recorded [here](#), with discussion beginning at the 6:30:40 mark, around 9:56 p.m.).

The motion was silent on electrification, although Councilmember Moreno broached the topic of electric/hybrid vehicles during the discussion. In response, Donzell Gipson, Director of Equipment and Fleet Management, and I briefly discussed the operational challenges of early adoption electrification for a public safety fleet, the lack of a suitable hybrid sedan option, and officer preference for internal combustion vehicles, beginning at 10:12 p.m. at the 6:48:17 mark. A lengthy discussion on the source of funds – DPD overtime – lasted nearly an hour. The City Council did not amend the motion with direction on electrification or any other topic, and it received 8 straw votes in support around 10:46 p.m.

Honorable Mayor and Members of the City Council,

As you were briefed Wednesday, Jan. 5, Communications, Outreach and Marketing (COM), Dallas Police Department (DPD), and Transportation (TRN) have been working collaboratively for months on communications to reduce speeding and eliminate pedestrian deaths and fatal and severe car crashes through an initiative called Vision Zero. Below is a summary of efforts thus far to share messages and graphics that all City departments, including the Office of the Mayor and City Council (MCC) and partner agencies can use to spread the message.

October 2021 DPD, COM, and the Office of Special Events (OSE) partnered with Red Bull to create special [public service announcements](#) (PSAs) discouraging street racing, highlighting the safe, family-friendly Red Bull Show Run featuring a Formula 1 car on a closed track in the Harwood District and urging residents to leave speeding to professionals.

November 2021 DPD Chief Garcia, Transportation Director Khankarli and COM Director Cuellar participated in CM Blackmon's live streamed conversation about pedestrian safety and DPD's bilingual graphics discouraging speeding were shared via COM and MCC.

December 2021 Subject matter experts from TRN were interviewed in English and Spanish about the Vision Zero initiative/campaign by reporters from [WFAA](#) and [Univision 23](#) to encourage public participation in the Vision Zero public engagement process.


January 2022 Public service announcements deterring speeding and promoting roadway safety produced by the [Dallas Police Department](#) and the [North Central Texas Council of Governments](#) (NCTCOG) started being broadcast daily on the City's government access channels, and bilingual info graphics were shared for distribution by MCC, DPD, and TRN as well as through the City's broadcast and digital channels.

New Updates

Temporary Inclement Weather Shelters

The Office of Homeless Solutions activated the opening of temporary inclement weather shelters (TWIS) in the City of Dallas on Saturday, January 1, 2022 and Sunday, January 2, 2022, based on the National Oceanic and Atmospheric forecast, in accordance with Chapter 45 of the City Code. Those experiencing homelessness were directed to Oak Lawn United Methodist Church (UMC) and OurCalling.



Both sites performed rapid response Covid testing with those testing positive sent to the City Covid Quarantine site opened for inclement weather sheltering at Reverchon Park Recreation Center with approval from the Parks Department. The second night of inclement weather shelter, capacity at Oak Lawn and OurCalling was reached, so an overflow shelter for Covid negative individuals was also opened at the Bachman Lake Recreation Center. After the closure of inclement weather shelter, Covid positive guests were transferred to hotel partners under the management of Catholic Charities, with assistance from OHS staff, as needed. These guests will remain in hotels for the duration of their quarantine period.



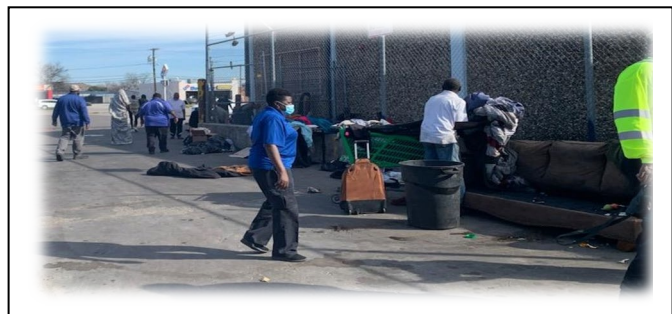
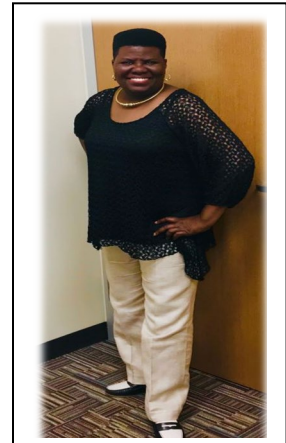
Through a tremendous amount of preparation and planning, this well-organized operation provided shelter for our unsheltered neighbors this weekend and is prepared to do so again later in the week should temperatures trigger Chapter 45 of the City Code. This work would not have been possible without support from the Office of Emergency Management, the Parks Department, Dallas Fire Rescue, Oak Lawn UMC, OurCalling, Stewpot, Metro Dallas Homeless Alliance (MDHA), Downtown Dallas Inc., Catholic Charities, Austin Street Center, Kessler Park UMC, CitySquare, and all of the area homeless services providers. Collectively, they provided medical services, meals, and transportation throughout this period.

Lisa Blouin has been a City of Dallas employee for over fifteen years, since moving from New Orleans' parish and the devastation of Hurricane Katrina. She started her career working with the homeless population at the DRC Homeless Shelter, as an intake coordinator, which gave her the opportunity to get to know individuals on a one-on-one basis. Lisa credits this position in building the soft skills needed to build relationships with individuals suffering from mental illness and/ or substance abuse. Her ability to build and maintain relationships has allowed her to successfully assist over one thousand individuals with obtaining their ID's, SS cards, and birth certificates. Lisa has also assisted over three hundred individuals in obtaining housing through the Rapid Rehousing, HOWPA, and SPC Programs. She is currently employed as an Office of Homeless Solutions Street Outreach and Advocacy Specialist, working directly with unsheltered homeless to get them into shelters and/or housing. Lisa also works closely with Community Courts to get tickets expunged and allow for individuals to start on a clean state. In Lisa's own words, "Working with this new program, the [Dallas R.E.A.L. Time Rapid Rehousing Initiative], has really made a difference with the homeless population. We can move them from the streets into housing. I really enjoy what I do, it's my passion. I am the voice for the homeless and I can make things happen."

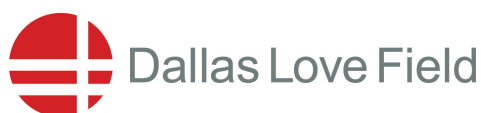

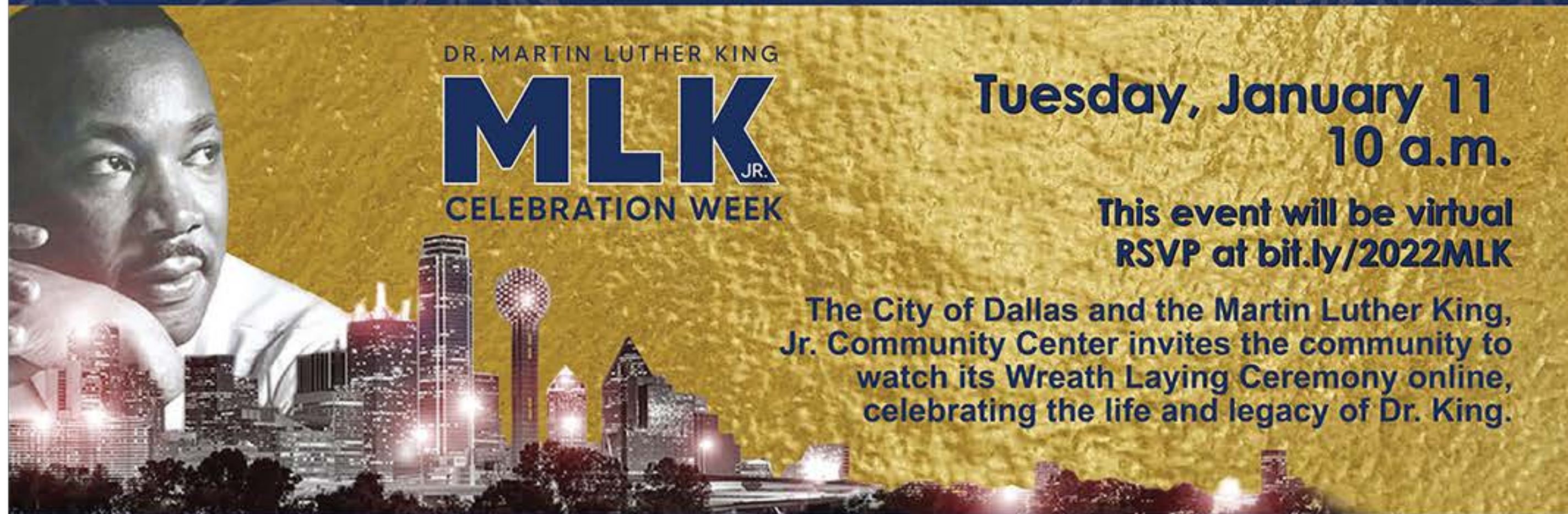

Dec. 30, 2021 - (Univision, Dallas Morning News, KRLD, WFAA) Do you have any information on a gas leak at the Highland Hill Apt, 5800 Highland Hills Dr., in Dallas? Univision has recently become aware of this situation and in the past, the same location was victim of a gas explosion. How is the city getting involved in this situation? Are you working with the owners of the apartment complex to remedy the ongoing issue? Thank you for your time and hope to hear from you soon.

City Response: Those are questions best directed to Atmos. Thanks.

Jan. 2, 2022 – Lourdes Vasquez (WFAA) Can you provide information on how many people were housed at the shelters overnight? Also, will the shelters close on Monday but reopen Thursday if need be?

City Response: 178 were sheltered last night; shelters are expected to be open through at least Monday night in keeping with City policy as noted below.

In accordance with [Chapter 45](#) of the Dallas City Code, the city makes an inclement weather shelter declaration and opens temporary inclement weather shelters during the winter in the temperature is forecasted by the National Oceanic and Atmospheric Administration's National Weather Service to be 36 degrees Fahrenheit in wet weather and 32 degrees Fahrenheit in dry weather for 3 hours or more.

Jan. 3, 2022 (Dallas Morning News, Spectrum 1) Is it possible to get a number of City of Dallas employees out due to COVID-19? Is there a chart/graph which has been tracking the number of Dallas employees out due to COVID since the pandemic started?

City Response: The City doesn't track this information for civilian employees as we are still in Phase 3 of Return to Work plans with many still working remotely.

DPD and DFR PIOs are copied to provide this information for uniformed personnel.
