SUBJECT **Sales Tax Receipts**

The June 2022 sales tax receipts from the State Comptroller's Office are \$38.6 million and represents a 12.7 percent increase in total collections compared to the same reporting period last year. Over the most recent 12 months, sales tax receipts have increased by 19.4 percent.

• June 2021 actual	\$34,254,068
• June 2022 budget	\$32,397,037
• June 2022 actual	\$38,602,297

For FY 2021-22, we originally budgeted \$344.3 million for sales tax revenue anticipating a slower recovery from the COVID-19 related recession. However, the economy is rebounding more quickly and strongly than we projected. The budget was increased to \$364.3 million in the mid-year budget ordinance approved by the City Council on May 11. Our current year-end forecast is \$375.5 million. We will continue to work with our economist, Dearmon Analytics, LLC, to update our forecast as additional information becomes available and will continue to keep you updated.

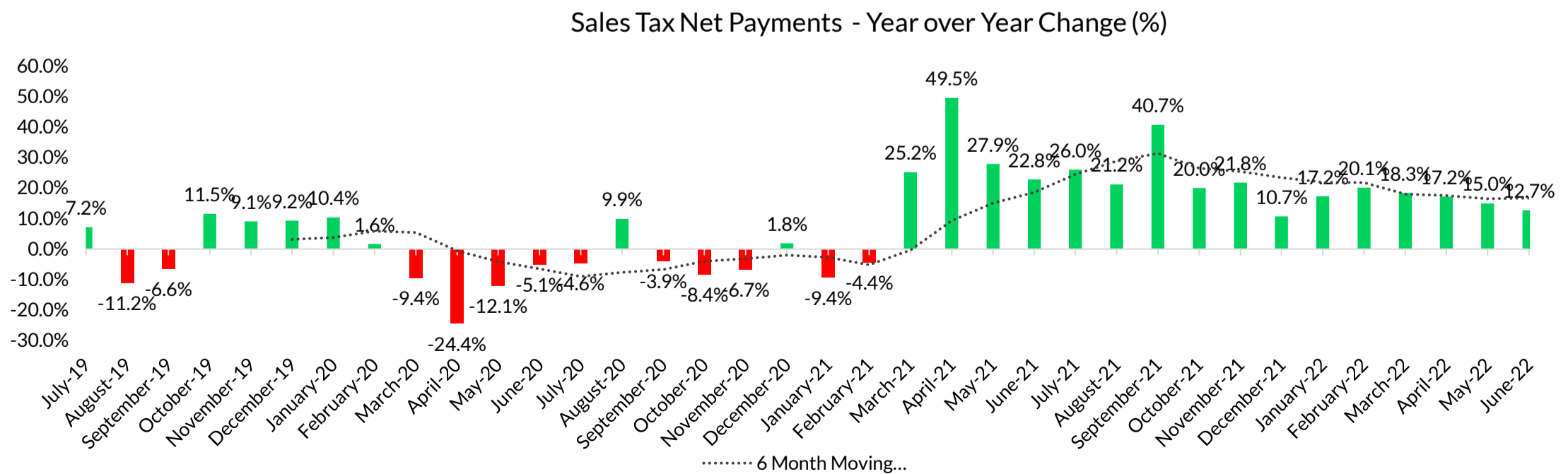
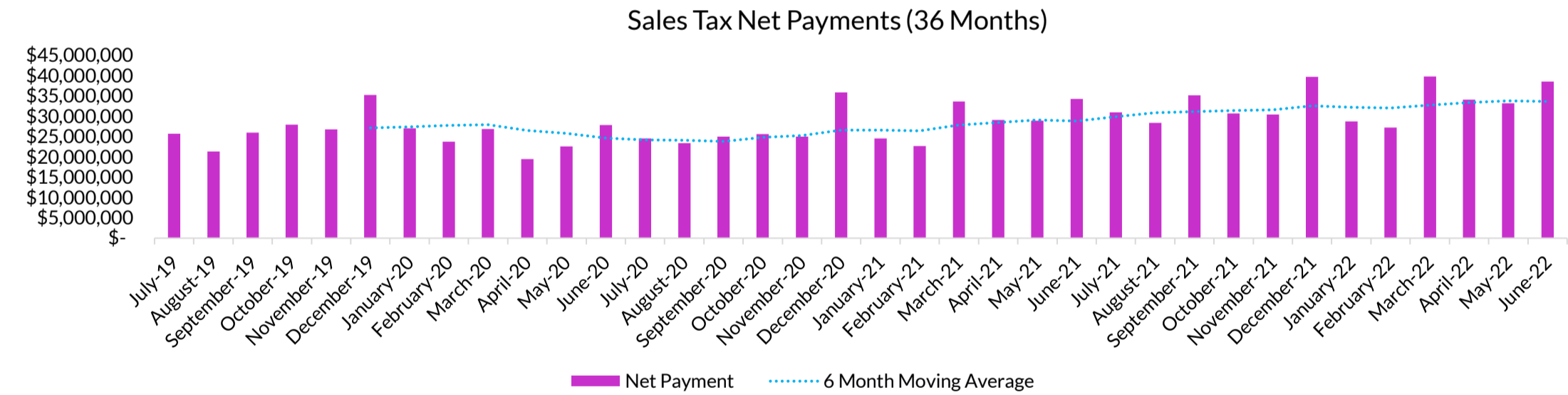
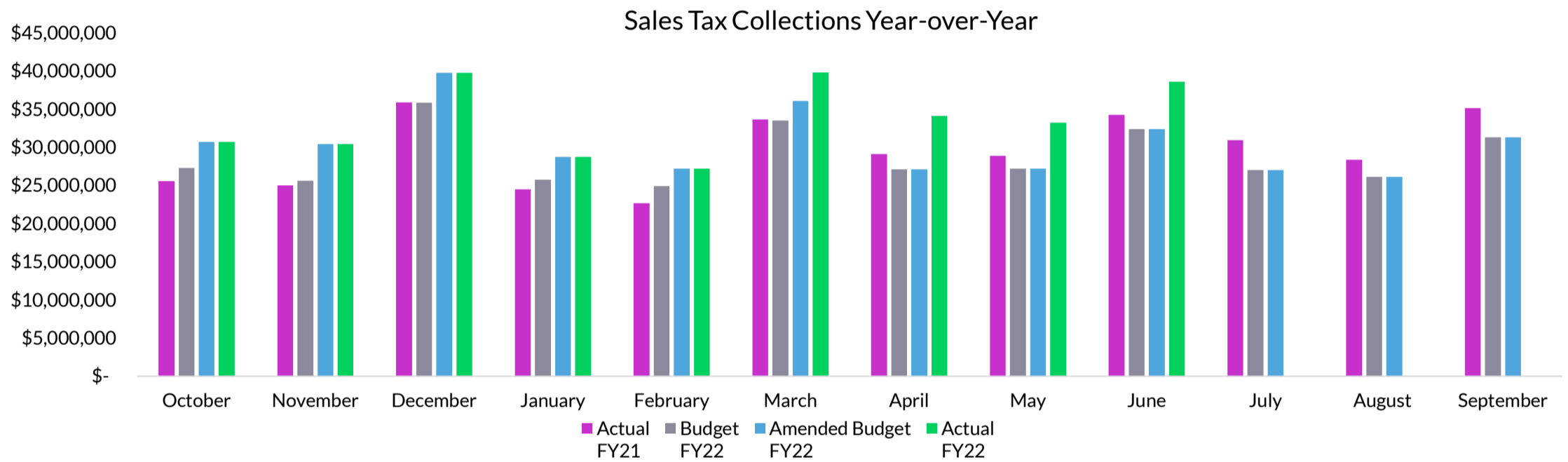

SUBJECT **Recent News Reports on the Status of Dallas Police Squad Cars at Hensley Field**

In recent days, the media has aired multiple news reports concerning the status of Dallas Police squad cars at Hensley Field. Specifically, overhead footage from a helicopter displayed the layout of parked “new” Dodge Chargers and Chevy Tahoes and the storyline suggested that the release of these vehicles to active duty were delayed because of “chip” shortages or supply chain issues.

At the time of the reports, 38 Chargers were on the ground at Hensley Field. All 38 of the Dodge Chargers are cleared for deployment and are tied to an activation plan for assignment to Patrol. Earlier this week, (5) Chargers, as pre-planned, were placed into service at Central Patrol and the remaining 33 will activate in the coming weeks as we schedule the retirement of older or unrepairable squads. For these 38 vehicles, there is no “chip” shortage or supply chain issue.

The 10 Tahoes at Hensley Field were purchased as replacement vehicles for SWAT and require additional specialized equipment to complete the police upfit requirements. Availability and timing of receiving this hardware has resulted in a greater than anticipated delay in these vehicles being assigned to SWAT. Currently, the supplier estimates the delivery of this equipment for the week of August 15, 2022, and after receipt of the equipment, the install and release of the Tahoes to SWAT is projected to be 45 days.

SUBJECT **Census Tracts – Municipal Input and Planning for Redistricting**

During the August 8<sup>th</sup> Workforce, Education and Equity Committee meeting, staff received an inquiry regarding determination of census tract boundaries leading up to the redistricting process. The question centered on low-income populations that may span a single census tract, which may lead to reduced government program services and funding eligibility for areas with the greatest need. Many government programs, services and funding are allocated based on a formula data determined by census tracts.

As noted during the meeting, cities are given an opportunity to provide input on how census tracts and blocks are drawn prior to the redistricting process. Local Update of Census Addresses Operation (LUCA) is the only time that tribal, state and local governments can review and comment on the U.S. Census Bureau's residential address list for their jurisdiction. The City also participates in LUCA-related training and workshops once the process is underway for the 2030 Census. In addition, the North Central Texas Council of Governments (NCTCOG) participates in the Census' Participant Statistical Areas Program (PSAP) on the City's behalf. The PSAP allows participants to review and verify selected statistical area boundaries for census data tabulation following U.S. Census Bureau guidelines and criteria.

The Office of Government Affairs will work collaboratively with involved departments, including the Office of Data Analytics and Business Intelligence (DBI), regarding data impacting the census and redistricting processes to determine those neighborhoods that need to be considered and perhaps redrawn. Please note, the DBI Office had not yet been formed at the time of the start of the 2020 redistricting process and underscores the critical value in having data analytics integrated into city operations.

SUBJECT **RAISE Grant Award – NCTCOG and DART**

On August 9, 2022, the U.S. Department of Transportation (USDOT) announced Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant awards, which includes a \$25M grant to the North Central Council of Governments (NCTCOG) for Improved Bicycle/Pedestrian Routes to Rail & Transit Technology. RAISE discretionary grants, which were originally created under the American Recovery and Reinvestment Act as TIGER grants, can be used for a wide variety of projects.

As part of the RAISE grant awarded to the NCTCOG, the projects specific to the City of Dallas will fund construction of over 30 miles of missing sidewalk in the half-mile radius of Dallas Area Rapid Transit's (DART) 8th & Corinth, Morrell, Illinois, and Kiest Stations, and extend the Cedar Crest Trail approximately 1.5 miles. The projects will also improve transit accommodations with new technology, upgrades, and safety features at nearby bus stops on DART's route 217 and Blue Line light rail stations including Kiest, VA Medical Center, and Morrell Stations.

The City of Dallas, along with other agencies, worked collaboratively with NCTCOG on the grant application to USDOT and we are appreciative of the support of the efforts to improve mobility and safety for the residents of Dallas.

SUBJECT **Status Update on the Upgrade of the Development Services Electronic Plan Review System**

On the evening of Thursday, August 4, the Information and Technology Services (ITS) Department, along with Development Services (DEV) and the City's vendor, Avolve, began work to re-platform and upgrade the electronic plan review and submission system, ProjectDox, from version 9.1 to version 9.2. ProjectDox is the City's electronic plans system where residents and businesses electronically upload plans and documentation associated with building permit requests. City staff reviews the electronic plans and provides automated direct communications to the permit applicant through the system.

As part of the upgrade to ProjectDox 9.2, the software application was moved from an on-premises application operated out of the City's data center to a Software-as-a-Service (SaaS) application hosted by the application vendor. This change provides greater stability and improved performance for users by simplifying the technical architecture. Additionally, the upgrade provides improved workflows and greater usability for both internal and external users.

The combined City project team completed validation testing of the upgraded ProjectDox system on Sunday, August 7, and the new system was available for users beginning this morning at 8:00 a.m. (Go-Live). While the transition was successful, there is a known and documented issue with the upgraded software that may have an impact on a subset of users until the issue is resolved. The issue impacts only current, pending permit applications and will not affect newly submitted requests.

The issue occurs because the City's vendor has not completed the synchronization of data to the new system. As a result, if a user attempts to access a file or document on a project, they may receive an error message indicating the item is not available. The user will receive this error message on a subset of items until the system synchronization has been completed. The error message does not prevent users from taking other actions in the system. The synchronization is ongoing, and the vendor estimates that it will be fully completed by the end of the day on Tuesday, August 9, at which time the issue will be resolved.

In the interim, the City will provide information to ProjectDox users on the issue and provide them instructions for reporting the problem. Upon report, ITS will work with the system vendor to manually synchronize the files to the project. The vendor is providing a dedicated resource to expedite these requests.

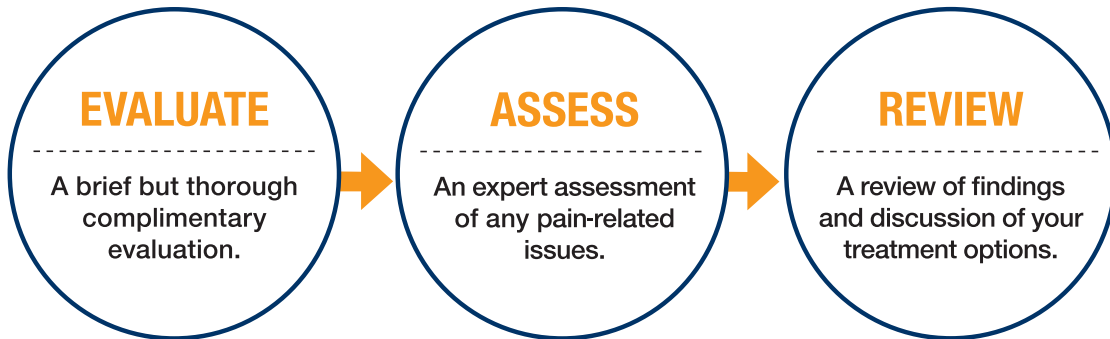
