### **SUBJECT** Traffic Signal Infrastructure and Data Management Presentation – Follow-up from April 6, 2022 City Council Briefing

During the April 6, 2022 City Council Briefing, the Department of Transportation provided a presentation on the City's traffic signal infrastructure, including an overview of planned approaches to implementing new functions of the Advanced Transportation Management System (ATMS) and managing the associated data exchange. This memorandum serves as follow-up on the inquiries or questions that were received during the briefing.

Question 1: How do the Office of Risk Management (ORM) and the City Attorney's Office (CAO) handle recouping costs from traffic signal equipment that is damaged by drivers, either through accidents or hit-and-run incidents? How does money that is recouped through insurance or a lawsuit get funneled back for addressing the damaged infrastructure? (Mendelsohn)

Answer: On a quarterly basis, ORM receives and reviews police reports for subrogation opportunities. If a driver's name and/or contact information is not listed on the report, it is considered a hit and run, and we are unable to pursue subrogation. ORM does not track hit and runs. Furthermore, if the driver does not have insurance, recovery is difficult. While the City does have insurance, certain perils must occur to trigger policy coverage. Once the policy is triggered, the City has a \$750,000 insurance deductible.

ORM does not currently have any pending subrogation claims that have been forwarded to CAO for review and assistance. Below is a table of traffic signal subrogation claims and the amount of money that was recovered.

ORM has identified opportunities to improve the current subrogation process. One of our adjusters is currently obtaining a Certified Subrogation Recovery Professional (CSRP) designation and will assist in the City's subrogation claims. ORM is also developing standard property damage reporting procedures and training for all City departments. Finally, we are developing a subrogation module in Origami, our risk management software.

Question 2: How many developments require the developer to pay for a new traffic signal, or part of a new traffic signal? How many of these developments are delayed in receiving their final permits due to supply chain issues or contractor delays? (Atkins)

Answer: There are approximately 80 traffic signals that are being improved by private development projects throughout the City; the majority of these are partial upgrades/

modifications to the signal equipment based on impacts to one specific intersection corner. Given the limited scope of the upgrades, the impact of supply chain issues or contractor delays has been minimal to date.

Question 3: What is the City's plan for addressing data monetization? Will Ericsson be paying the City for the data that the City owns, and Ericsson has access to? (Schultz)

Answer: The current agreement with Ericsson does not allow them to sell the City's data or monetize it in any way. Ericsson is simply the platform provider. Various City departments are coordinating to develop a data management and monetization policy that will outline responsibilities of any third party that desires to have access to the Ericsson ATMS system, and require payment based on data usage.

Question 4: Does the Department of Transportation have data justifying the cost of new traffic signals and the ATMS system as it relates to safety and mobility? (Ridley)

Answer: Yes; new traffic signals are only installed if a traffic study is completed showing that the location meets at least one of the traffic signal warrants as outlined by the Federal Highway Administration.

Replacements of traffic signals at existing locations are often funded through grant programs, such as the Texas Department of Transportation's Highway Safety Improvement Program (HSIP) which prioritizes locations primarily based on crash data.

Lastly, the ATMS system provides the City with the opportunity to holistically monitor and manage, in real time, the efficiency and safety of surface traffic.

### SUBJECT Questions from the March 29, 2022 Transportation and Infrastructure Committee Meeting

On March 29, 2022, the Transportation and Infrastructure Committee was briefed on Dallas Water Utilities - Integrated Pipeline Project (IPL). Tarrant Regional Water District (TRWD) provides regular updates on the progress of the project which we will be sharing with the Council on a quarterly basis which is attached. The following information is provided in response to questions asked during the meeting.

### Provide a breakdown of the M/WBE participation and company business locations on the projects to date.

Please find attached year to date information from TRWD on the M/WBE participation for the IPL Project. The total breakdown for local firms is \$219,987,046 and \$45,805,358 for non-local.

#### Does TRWD have a local preference policy?

Yes, the attached "Fair Opportunities Purchasing and Contracting Policy" was amended in 2016 and is included in the original contracting documents for the IPL Project. This document is Appendix A in TRWD's Fair Opportunities Purchasing and Contracting Policy recently revised by the TRWD Board and adopted effective April 1, 2022. The area of local business, as defined by TRWD includes a broader definition of "local" such that all areas where work is performed. The excerpt below is from the document:

"Local Business - IPL will refer to businesses that maintain an office within the following counties where the majority of the contract activities will be performed or delivered (Tarrant, Dallas, Anderson, Collin, Denton, Ellis, Freestone, Henderson, Jack, Johnson, Kaufman, Navarro, Parker, Rockwall, or Wise) as "local business." If more than 50% of the business is owned by individual residents residing within the county where the majority of contract activities will be performed or delivered, this would also be considered a "local business"."

## What will be done to recruit and assist Dallas' local and M/WBE companies in future contracts?

The City will be working with the TRWD and our staff to develop a robust outreach and education initiative for upcoming work that is estimated to be "on the street" within the next several years. As the timing for awards becomes closer, we anticipate even more interest by our local community. TRWD has requested that the City provide a list and contact information for our chambers of commerce and contracting agencies so that they

will receive all notices for solicitation of projects Building on existing efforts, the City will hold work sessions, vendor registration training and assistance, symposiums on best practices with insurance and bonding agencies, learning sessions with lending and credit agencies, and provide opportunities for businesses to make business to business connections for partnering opportunities.

Additionally, the project to connect the IPL to Bachman Water Treatment Plant, estimated to be approximately \$500M, is scheduled to begin over the next several years and this project is separate from the IPL and will be awarded through DWU's Capital Improvement Program.

### Provide a schedule for bond issuances in 2022 and 2025. Also, provide the bond RFQ.

Tarrant Regional Water District (TRWD) applied for SWIFT funding from the Texas Water Development Board for the October 2022 revenue bond issuance to take advantage of lower interest rates. We have verbal approval with formal approval due this month for the October sale of approximately \$250M. As we get closer to the 2025 bond issuance, depending on market conditions, TRWD will either apply for state funding or go out for bids.

#### Fair Opportunities Purchasing/Contracting Policy

#### 1.0 PURPOSE

The Tarrant Regional Water District (TRWD), which includes TRWD/Dallas Integrated Pipeline Project (IPL) will strive to ensure that all businesses, regardless of size, economic, social or ethnic status have an equal opportunity to participate in TRWD's procurement processes. For purposes of incorporating these entities, we will refer to TRWD as the District.

The District is committed to promoting full and equal opportunity for all businesses to supply the goods and services needed to support the mission and operations of the District, and seeks to encourage the use of certified Diverse Businesses (DB or DBs) through the use of race, ethnic, and gender neutral means.

It is the Policy of the District to involve certified DBs as feasible in the procurement of goods, equipment, services and construction projects while maintaining competition, competitive prices and quality of work standards.

The District affirms the good faith efforts (GFEs) of firms who recognize and practice similar business standards.

#### 2.0 NOMENCLATURE

The District will refer to certified Diverse Businesses as minority-owned, woman-owned, socially disadvantaged, economically disadvantaged, small, service-disabled, and/or historically underutilized businesses (HUB).

The District will refer to suppliers, vendors, contractors, consultants, and other companies engaged or retained to provide outside services of any nature as "contractors." Similar companies engaged by such contractors will be called "sub-contractors, and/or suppliers."

#### 3.0 Contracting Policy

It is the Policy of the District to demonstrate a good-faith effort (GFE) to provide for meaningful participation by Diverse Businesses. The District, its contractors, their subcontractors and/or suppliers, as well as all vendors of goods, equipment and services, shall not discriminate on the basis of race, color, creed, gender, age, religion, national origin, citizenship, mental or physical disability, veteran's status or political affiliation in the award and/or performance of contracts.

All vendors, suppliers, professionals and contractors doing business or anticipating doing business with the District shall support, encourage and implement affirmative steps toward a common goal of establishing equal opportunity for all citizens and businesses.

Such GFEs include the following:

A. Identify opportunities for DB involvement and encourage businesses to qualify for and submit offers on District requirements for goods and services.

B. Divide the work to be contracted into smaller portions where technically and economically feasible.

C. Make plans and specifications for prospective work available to DBs in sufficient time for review.

D. Ensure that DBs are aware of opportunities to participate in District purchases and contracts. Actively and affirmatively solicit offers for contracts from DBs, including circulation of solicitations to affiliated associations when possible.

E. The District will use and recognize the State of Texas (Texas Unified Certification Program and all participating entities) certifications in conjunction with the implementation of this policy. Of those aforementioned recognized certifications, the District reserves the right to review the certification status of any vendor applying to do business with the District. This review will be accomplished to determine the validity and authenticity of the vendor's certification as a DB.

F. Diverse Businesses that are selected as prime contractors will be given credit for the portion of the actual work performed. The DB prime contractor remains responsible for meeting the subcontracting goal requirement, or for making a good faith effort to do so.

G. Use the services of, and cooperate with those organizations providing technical assistance, and training in connection with DB participation.

H. Encourage the formation of joint ventures, partnerships, or other similar arrangements among contractors where appropriate.

I. Ensure that provision is made to provide payments on a timely basis as specified in individual project contracts.

J. Evaluate projects, in excess of \$50,000 in the planning phase to determine opportunities to set specific DB goals. The project goal shall be reasonable, expressed as a percentage of total contract, and shall be based on the following considerations:

- Specific sub-contracting opportunities required to complete the project
- Availability of DBs in the identified areas needed

K. Provide potential contractors a copy of TRWD's *Fair Opportunities Purchasing/Contracting Policy.* Clearly communicate that the District expects all contractors to demonstrate good faith in actively soliciting DB sub-contracting and supplying opportunities, and following the District's outreach policies.

L. The intentional misrepresentation of facts by a firm or bidder may result in the barring of receipt of bids and or quotations from the firm or bidder for a specified period of time which may be determined on a case-by-case basis.

**NOTE 1:** Nothing in this Policy shall be construed to require TRWD to award a contract other than in a manner that complies with all applicable law and, in the Board's judgment, will be most advantageous to TRWD and result in the best and most economical completion of TRWD proposed projects, improvements, facilities, works, equipment, and appliances. Provided however, in cases of tie bids from responsible bidders, awards will be made according to the following principles:

- a) In cases of tie bids for service and procurement contracts, local businesses may be awarded contracts over non-local businesses to the extent allowed by law.
- b) If the foregoing principles do not resolve cases of tie bids, the Board of Directors of TRWD will provide direction to determine the award of the contract. In cases of tie bids for service contracts between (i) two or more local businesses, or (ii) two or more non-local businesses, TRWD may consider all factors that will be most advantageous to the District, including the impact on the ability of TRWD to comply with and promote the policies contained herein.

**NOTE 2:** Tarrant Regional Water District and the City of Dallas Water Utilities (DWU) have partnered to finance, plan, design, construct and operate the IPL Project.

Due to the multiagency participation in this project, please see **Appendix A** for additional Policy requirements related to the IPL Project.

#### 4.0 Reporting Procedures

All contractors are to report sub-contracting and/or supplying activities with DBs with each invoice submitted for payment, during the life of their contract. Verified certifications are to accompany documentation, along with participation percentage of total contract, as well as specific dollar amount spent through DBs. The District reserves the right to conduct a third party audit of all reports prepared by awardees.

The Finance Director shall maintain responsibility for tracking and monitoring DB participation and shall train and advise all departments of the District's Fair Opportunities Purchasing/Contracting Policy.

The department issuing the contract shall maintain responsibility for verifying all certifications with the appropriate certifying agency and for establishing expectations with contractors.

#### 5.0 Review of Policy

The Finance Director for the District shall present a report quarterly and annually to the Board of Directors.

This Policy shall be reviewed by the TRWD Finance Director annually, and amended or ratified as appropriate.

#### (Appendix A) <u>IPL</u>



Tarrant Regional Water District (TRWD) and the City of Dallas Water Utilities (DWU) have partnered to finance, plan, design, construct and operate the Integrated Pipeline (IPL) Project. #### The policies below are in addition to the policies that are discussed under TRWD:

#### 1.0 PURPOSE

The IPL leadership is committed to an active process of Diverse Business and local business development that will strengthen the business community through the construction of the project.

#### 2.0 NOMENCLATURE

**Local Business** - IPL will refer to businesses that maintain an office within the following counties where the majority of the contract activities will be performed or delivered (Tarrant, Dallas, Anderson, Collin, Denton, Ellis, Freestone, Henderson, Jack, Johnson, Kaufman, Navarro, Parker, Rockwall, or Wise) as "local business." If more than 50% of the business is owned by individual residents residing within the county where the majority of contract activities will be performed or delivered, this would also be considered a "local business".

Percentage goals are provided as a baseline for inclusion of Diverse Business/Local business participation. It is the intent of IPL to provide DB/Local vendor (business) development through the construction of the project. Both DBs and/or local businesses will be encouraged in the selection criteria to the extent allowed by law.

In an effort to provide DBs the opportunity to provide goods, equipment and services as the prime contractor, the IPL Team has established subcontracting goals of twenty-five percent (25%), and requirements for all prospective bidders to ensure a reasonable degree of DB participation. IPL will exclude the purchase price of all large diameter pipe sizes 120", 108", 96", and 84" from the prime contractor subcontracting goals.

IPL will purchase directly from the manufacturer major material items of the project including, but not limited to: mains, valves and pumps, where the opportunity to satisfy the overall DB project goals are limited. However, a Good Faith Effort will be made to encourage DB participation in the handling, distribution and delivery of such major material items to the project's construction sites. This supports the IPL's commitment to provide development opportunities for DB/Local business to complete work of substance that is sustainable. Encourage contractors to strengthen their own Equal Employment Opportunity Programs. Upon request, a contractor shall provide a compliance report that includes employment practices, policies, programs and statistics.

#### 3.0 CONTRACTING POLICIES

Please refer to TRWD's Policy page located on page 2 in addition to the following:

**Project Coordination Team:** TRWD/Dallas IPL will refer to the representatives from both TRWD and Dallas as selected in accordance with the TRWD/Dallas Contract as "Project Coordination Team". The project coordination team will provide guidance to the MHL Business Coordination Team.

**Minority/Woman Business Enterprise (M/WBE) & HUB/Local (MHL) Business Coordination Team:** TRWD/Dallas IPL Project will refer to the representatives who will be responsible for the implementation of this Policy as **MHL** Business Coordinator(s).

The MHL Business Coordination Team will be a liaison to the Project Coordination Team. The MHL Coordination Team will evaluate compliance with this Policy and award the 15 points allowable as applicable.

#### 4.0 Reporting Procedures

A status report of Diverse Business participation will be submitted quarterly to both TRWD Finance Director and the City of Dallas Executive Manager of Business Development and Procurement Services.

#### 5.0 Review of Policy

This Policy shall be reviewed by the City of Dallas DWU Director and the TRWD Finance Director annually, and amended or ratified as appropriate.

TRWD and Dallas, as partners in the Policy, reserve the right to jointly waive, modify, amend, or withdraw all or any part of this Policy at any time. This Policy is not contractual and creates no rights in any prospective contracting party.

#### 6.0 Policy Compliance and Disputes

The MHL Business Coordination Team shall be responsible to determine compliance with the policy. To ensure that the prime has complied with the TRWD/Dallas IPL Project Fair Opportunities Purchasing/Contracting Policy throughout the performance of the contract, MHL Business Coordination Team will be responsible for reviewing and approving M/MWBE & HUB participation levels prior to final payment to the prime contractor. The MHL Business Coordination Team must be able to reconcile the final report with appropriate documentation on file. If the difference cannot be reconciled, the MHL Business Coordination Team will convene a review committee with the prime contractor and request additional documentation to explain the discrepancy. Once all issues are resolved, the MHL Business Coordinator-TRWD will contact the project manager to recommend final payment.

#### **Failure to Comply**

The failure of a contractor to adequately comply with the TRWD/Dallas IPL Fair Opportunities Purchasing/Contracting Policy shall be considered in the award of contracts.

A contractor who fails to adequately document a subcontract with M/WBE & HUB firms to purchase significant material supplies from M/WBE and/or HUB firms may be denied award of the contract on the grounds of non-responsibility.

If, during the performance of the contract, the contractor is found not to be fulfilling commitments to utilize M/WBE & HUB subcontractors and no acceptable justification has been offered by the prime, this failure to fulfill commitments may be considered in the award of future contracts and may result in the denial of such future contract to the prime contractor.

A prime contractor may be disqualified for contract awards for a three year period upon the determination that the contractor:

- a. is non-responsible based upon poor performance
- b. is engaged in pass-through brokering
- c. is engaged in pay-rolling
- d. has been deficient in regards to other integrity issues

#### Disputes

All disputes regarding the administration of or compliance with the TRWD/Dallas IPL Project Fair Opportunities Purchasing/Contracting Policy will be directed to MHL Business Coordination Team. If resolution cannot be achieved, the prime contractor or subcontractor may file a formal complaint. The TRWD General Manager's Office will conduct a thorough investigation of the formal complaint.

In a timely manner, the General Manager's Office will notify, in writing, all concerned parties, including: the Director of DWU, MHL Business Coordination Team, and the Project Coordination Team, of the resolution to each complaint.

#### IPL PROGRAM GENERAL OPERATIONAL STATUS

The IPL System is currently able to deliver water from Richland Chambers Reservoir to the cross-connections with the existing Richland Chambers and Cedar Creek pipelines at the S2X12 Interconnect Facility near Joe Pool Lake and the future DWU connection point. The IPL System is also able to deliver water to the Arlington Outlet via the S1X10 Pressure Reduction Station, the KBR Bypass pipeline and the Line J Pipeline. Water can be delivered via the IPL system and the existing pipelines to the Rolling Hills Water Treatment Plant and to Lake Benbrook.







#### **SUBJECT Permitting Delays**

While the Department produced improved performance during the First Quarter of the Calendar year, due to the heavy current volume of permit applications, we are experiencing significant delays. This in part, has been the cause of the rise of complaints and questions of permit status, as there were 283 more permit applications submitted during the first quarter of 2022 than the last quarter of 2021.

This amount is effectively more than a normal month of business added to the volume of application for permits during the first quarter. When added to our existing cue of business, we have 391 permits in review. This means our target times for approval of 6 to 8 weeks will increase to 10 to 12 weeks.

We have 3 new hires who are now on board and we are drafting existing teammates in other divisions with zoning and plan review skills to help work down this volume. Additionally, our third-party provider partners have ramped up and will also contribute to expediting reviews.

We will issue an update on this situation on April 29, 2022.

RE: DART Silver Line Rail Project Design and Construction Requests and Considerations

Dear Ms. Lee,

First, please let me start with thanks for your and your team's continued partnership with the City of Dallas, to include design and delivery of DART's Silver Line Rail Project through North Dallas. While DART and the City of Dallas have continued to cultivate its strong partnership, I must acknowledge the safety concerns, that have been voiced by many Dallas residents, regarding the Silver Line's design and construction. It is my hope that through our continued partnership, we can work together to mitigate the public's concerns.

To address the safety concerns raised by the public, the City of Dallas formally requests that DART strongly consider the incorporation of the following in its Silver Line design plans, construction phase, and/or supplemental documents:

- 1. Grade separation at the Silver Line crossings at Dickerson St. and Meandering Way;
- 2. Drainage plans at the Hillcrest Rd. crossing and include inlets and a pump station large enough to ensure no ponding of water during rain events;
- 3. While not necessary for inclusion in the Quiet Zone Applications to be reviewed by the Federal Railroad Administration, DART shall include City-requested and field diagnosticidentified, enhanced safety measures in its design plans or other supplemental documents to be reviewed by the City of Dallas; and
- 4. City staff was recently informed that DART will need to close the intersection of Coit Rd. and Sugar Cane Way for approximately six months to reconstruct the intersection. During the Coit Rd./Sugar Cane Way intersection construction, DART must maintain emergency access (police, fire, and medical services) and add one additional, temporary entrance/exit for the residents of University Place.

Understanding that it may take a significant amount of work by the DART team to consider the City of Dallas' requests, I am requesting that DART provide me with responses to the requests and any pertinent information or analysis to substantiate DART's determinations on the requests no later than April 30, 2022. Once the City receives DART's response and information, I am requesting that we meet with you, members of the DART team, Council Members Narvaez, Schultz, and Mendelsohn, my team, and myself to determine a mutually acceptable path forward.

#### Application for Texas Water Development Board Financing – State Water SUBJECT Implementation Fund for Texas

I am pleased to announce that on April 11, 2022, the Texas Water Development Board (TWDB) approved the 2022 State Water Implementation Fund for Texas (SWIFT) program prioritization list, amount of funds available, and terms of subsidy for Dallas Water Utilities (DWU). With this approval, DWU received invitations to submit applications for financial assistance through SWIFT. SWIFT was created in 2013 by the Texas Legislature to provide affordable financial assistance for projects in the state water plan. The program provides low-cost financial assistance for planning, design, and construction. Through fiscal year 2021, SWIFT has committed approximately \$9.2 billion for projects across Texas.

DWU has four projects and programs on the prioritization list that represent \$378.2 million in planned capital improvements and include one multi-year commitment for DWU's water main replacement program. Our participation in SWIFT provides lower overall costs for financing projects for the design and construction of important infrastructure, benefitting DWU customers. Other benefits include:

- Low interest loans long-term, fixed rate loans offered at below-market rates, further reduced by tax-exempt subsidies of 14% to 25% based on the loan term
- No maximum funding limits and multi-year commitments •
- TWDB is a dedicated source of funding for DWU projects and frees up bond and • commercial paper capacity to use on other infrastructure improvements

DWU, through the City Controller's Office, will seek City Council approval on April 27, 2022 to authorize loan applications to TWDB ahead of the May 11, 2022 deadline. TWDB will consider approval of applications and authorize a bond sale and execution of financing agreements in Summer 2022. If funding commitments are secured, TWDB anticipates closing on the loans in Winter 2022.
