#### **SUBJECT Development Services Updates**

This memorandum is to provide you with an update on Development Services activities and progress.

#### CUSTOMER INITIATIVES:

Development Services (DEV) hosted staff customer service and professionalism training on Thursday, May 26, 2022. The Values of Service training module was presented to 18 staff members.

DEV is partnering with Building Services to redesign the Permit Service Center and Call Center. The project is currently in the design phase.

Staff has established and implemented a specific Building Official email address for escalated requests and faster resolution. All emails sent to <u>buildingofficial@dallascityhall.com</u> will route directly to the Chief and Deputy Building Officials. Customers will receive responses within 24-48 hours. This email address will be shared with the Development Advisory Committee and will be posted on the DEV website and social media channels.

DEV Executive staff will meet with the Dallas Builders Association (DBA) the week of May 30, 2022 to introduce the new Chief Building Official and Deputy Building Official to the DBA's leadership.

#### TECHNOLOGY:

The ProjectDox vendor was on-site May 25-26, 2022, to provide staff with an enhancement update and training. They also toured individual workgroups to identify potential business enhancements. A panel discussion was held to answer software functionality-specific questions. User Acceptance Training (UAT) for the ProjectDox 9.2 upgrade should be completed early Summer 2022.

DEV is currently exploring the purchase of a Customer Management Queuing System for the Permit Service Center and Call Center. Staff plans to have preliminary recommendations in the Summer of 2022.

ITS is working with DEV staff to complete programming of all training workstations in the new training center located at 400 S. Zang Boulevard (Oak Cliff Tower).



Staff has acquired a third-party software that allows the public to opt-in to receive communications from DEV that include newsletters, emails, and text messages, and DEV continues its partnership with Gartner to develop a Statement of Work (SOW) with the selected land management software vendor.

#### **HIRING AND RECRUITMENT:**

Hiring efforts have resulted in improved recruiting and onboarding. DEV continues to hold weekly meetings with Human Resources to receive status updates on recruitment efforts. Vacancies have been reduced to six (6) from the 41 critical open positions identified in February 2022. Staff is collaborating with the Matrix Consulting Group to request a comprehensive compensation study with a completion timeline of four (4) weeks.

#### **NEW SINGLE-FAMILY RESIDENCES, REMODELS/ADDITIONS PERMITTING**

The Residential Plan Review Team has issued 162 permits month-to-date with an average approval time of 55 calendar days. Staff continues to work overtime during evenings and weekends to expedite and clear the current residential backlog.

#### SUBJECT 2022 Pride Flag Ceremony

The City of Dallas has a diverse Lesbian, Gay, Bisexual, Transgender, and Queer or Questioning (LGBTQ+) community and is committed to supporting visibility, dignity, and equity for all people in the community. #### Period Access Dallas Program Launch

This Saturday, May 28 is World Menstrual Hygiene Day. This day highlights the importance of menstrual health and aims to erase the stigma that is attached to menstruation. As such, the Period Access Dallas (PAD) Team, has decided to launch our city program to coincide with this important day. Staff will distribute menstrual products to the 23 different libraries, community centers, and recreation centers located in Qualified Census Tracts (QCTs). QCTs are tracts with a poverty rate of at least 25% or in which at least 50% of the households have incomes below 60% of Area Median Income (AMI). This program will make available packages of menstruation management products as well as stock restrooms with free products. A map of the locations is available <u>here</u>.

In addition to the purchased products staff is working with non-profits and local partners to set up donation centers throughout the City. You can now go into your local Starbucks locations and donate products as well. Based on needs and quantity collected, the City is hoping to expand this program outside of targeted QCTs as well as look into eco and wallet friendly options. #### WIC and Formula Shortage Response

Texas WIC (Supplemental Nutrition Assistance Program for Women, Infants and Children) Local Agency 007 (City of Dallas WIC) has seen an increase in calls from families seeking assistance locating formula and clients at WIC clinics asking for help with formula. The WIC program does not manufacture or distribute formula directly and does not have access to formula beyond normal retail means, however WIC benefits to enable families to purchase formula from retailers. Due to the formula shortages being seen across the country (read more on that <u>here</u>), including locally in Dallas, Texas, WIC is working closely with WIC grocer partners to help ensure there are options for WIC families to purchase.

Texas WIC has added alternative options so families can find a formula at the store to meet their baby's needs without updating their WIC card, which can help families in this time because typically the WIC card only enables the family to purchase a specific size and brand from a specific retailer. Alternative WIC options for Similac Advance are available through the end of June. Alternative options for Similac Sensitive, Total Comfort and Spit Up are available through July. They're listed on TexasWIC.org at <a href="https://texaswic.org/about-wic/special-wic-food-updates">https://texaswic.org/about-wic/special-wic-food-updates</a>. If WIC clients cannot find the brands or sizes of formula that is currently written on their card, they can contact their local WIC office to update their card to a different can size or different type of formula (214-670-7200).

Additional safety information/background is below:

- If someone has purchased powdered baby or toddler formula with the brand names Similac, Similac PM 60/40, Alimentum, EleCare and EleCare Jr. the first thing they should do is check to see if their formula was affected at <u>https://www.similacrecall.com/us/en/product-lookup.html</u>. Look at the bottom of the can or container and find the lot number and enter it into the website.
- If recalled, do NOT use it and follow the manufacturer's instructions to get a replacement. Abbott Labs can be contacted at 1-800-986-8540.
- If formula was not included in the recall, families can still use it. Many stores are getting new supply of Similac products that were not affected by the recall.
- Because babies need a specific balance of nutrients, you should NOT water down infant formula, make homemade formula or give your baby cow's milk, goat's milk or other milk alternatives. Read more from a trusted pediatrician at <u>https://bit.ly/391xIN4</u>.

#### **ARPA Coronavirus Local Fiscal Recovery Funding**

As part of our \$355.4 million ARPA Coronavirus Local Fiscal Recovery Fund (CLFRF), the City Council approved \$16 million to provide for City Council districtspecific needs. The allocation includes \$1 million for each of the 14 City Council Members and \$2 million for the Mayor to determine the specific use. The broad categories of eligible uses outlined in the federal legislation include: 1) Respond to COVID-19 or its economic impacts; 2) Replace revenue lost due to COVID-19; 3) Provide premium pay for eligible essential workers; and 4) Invest in water, sewer, and broadband infrastructure. Additional eligible uses were identified in the memo distributed to you on May 13. #### **Okay to Say: Mental Health Public Awareness Campaign**




