

SUBJECT Mosquito Traps by District

On Monday, March 23, 2014, the Quality of Life & Environment Committee requested the address location of mosquito traps in the City of Dallas. The attached list reflects the hundred block location of the 90 fixed mosquito traps maintained by Code Compliance Services. The trap locations were selected based on prior West Nile Virus (WNV) activity, mosquito larval habitat (ponds, storm water drainage, etc.) and population density.

Similar to prior years, mosquito samples will be collected weekly May 1, 2015 – October 31, 2015 by Code Compliance Services staff and tested by Dallas County Health & Human Services and the Texas Department of State Health Services.

Subject Dallas Public Library to Add Hours at 6 Additional Locations

City Council approved the expansion of library hours in its adopted FY2014-15 budget. On January 2, 2015, seven Dallas Public Library locations began 7-day a week service: J. Erik Jonsson Central Library, Bachman Lake, Hampton-Illinois, Pleasant Grove, Polk-Wisdom, Renner Frankford, and White Rock Hills. Authorize a construction contract with Phoenix 1 Construction and Restoration, Ltd., for structural repairs and roof replacement at the Perot Museum of Nature & Science at Fair Park – Agenda Item #28, April 8, 2015

The Perot Museum of Nature and Science at Fair Park, formerly the Dallas Museum of Natural History, located at 3535 Grand Avenue was completed in 1936 for the Centennial Exposition. The three-story, approximately 32,000 sq. ft. facility was last renovated in 1988, and the roof replaced in 1997. Dallas voters approved funding for roof replacement and correction of a water infiltration problem at this facility in the 2006 Bond Program. The museum currently provides administrative office space and back of house curatorial support for the Perot Museum facility at Victory Park. After a qualifications-based selection process, JQ Infrastructure, LLC was recommended as the most qualified firm for design of the repairs to the facility.

Through a Competitive Sealed Proposal selection process, Phoenix 1 Restoration and Construction, Ltd. was identified as the best value proposer of two, to provide construction services for the museum. The 'design-to' construction budget for the planned scope of work is \$1.4M. Both of the two proposals submitted were within the established budget for construction.

This construction contract will address waterproofing and structural repairs at the south end Basement level, replacing approximately 2,300 square feet of the facility's existing basement floor slab that has subsided due to gradual desiccation of the sub-grade. The scope of repairs will also include the scheduled replacement of the roof. The existing roof is approximately 18 years old. Since it has two years remaining of its expected useful service life, it was determined to replace it now in conjunction with the other planned repairs.

Additionally, the scope of repairs at the Museum of Nature & Science facility will also include the following:

- Removal and replacement of the sub-grade exterior wall and loading dock entrance at the south end of the building
- 2. Removal and replacement of a portion of the sub-grade waterproofing membrane at the SW corner of the building
- 3. Stabilization of an existing concrete retaining wall on the east side of the loading dock driveway
- Surface re-grading at SE and SW corners of the building to correct improper drainage patterns contributing to moisture infiltration at the Basement
- 5. Installation of new groundcover at areas of where erosion of the topsoil has occurred
- 6. Installation of new trees on the west side of the building required for mitigation of trees removed in order to access repairs at the Basement
- 7. Removal and replacement of the entire roof membrane system
- 8. Replacement of damaged floor tile at the Lobby

On April 8, 2015, the City Council will consider authorizing a construction contract for the site package for the Briscoe Carpenter Livestock Center at Fair Park to J. C. Commercial, Inc., lowest responsible bidder of three, in the amount of \$2,687,777. Of this amount, \$1,200,000 will be funded by a FY2014 United States Economic Development Administration Grant and \$1,487,777 will be funded by 2006 Bond Funds.

This project is the first phase of construction for the \$14 million Briscoe Carpenter Livestock Center project which includes demolition, underground utilities, grading and paving at Fair Park. The building package will be awarded separately, and will be funded with State Fair of Texas funds and 2006 Bond Funds.

It is anticipated that construction of the site package will be completed before the 2015 State Fair of Texas and construction of the building package will be started after the 2015 State Fair.

BACKGROUND

On February 26, 2014, Resolution No. 14-0452 authorized the acceptance of the United States Economic Development Administration Grant in the amount of \$1,200,000 from the United States Economic Development Administration (EDA) for infrastructure and improvements to compliment the Briscoe Carpenter Livestock Center Project, Fair Park.

On February 19, 2015, three bids were received and J.C. Commercial, Inc. was the lowest responsible bidder in the amount of \$2,687,777 for the base bid. The scope of work includes site utilities, grading and paving for the Briscoe Carpenter Livestock Center. This project will be funded by the U.S. Department of Commerce, Economic Development Administration reimbursable grant in the amount of \$1,200,000 and 2006 Bond Funds will be used for the remaining portion of the project.

The building package will be procured separately and construction on that portion of the project is anticipated to begin after the 2015 State Fair of Texas.

SUBJECT Update on Octavio Medellin Window Installations

Next week, the first of the rescued and restored art glass windows by Dallas artist Octavio Medellin will be installed at Dallas Love Field. The first restored window, entitled *The Campanile Window*, will be suspended in four sections in front of the clerestory windows of the Ticketing Hall directly across from David Newton's 'Cultural Dallas' medallion, which includes a portrait of Octavio Medellin. Work will begin on April 1st, and is scheduled for completion on April 18th.

An important artist and teacher of many North Texas artists, Octavio Medellin taught at North Texas State Teachers College (now the University of North Texas), Southern Methodist University, and the Dallas Museum of Fine Arts School. In 1966, he opened the Medellin School of Sculpture in Dallas and continued teaching through 1979. Medellin's artwork is represented in exhibitions and museums including the Dallas Museum of Art, the Meadows Museum at SMU, the Amon Carter Museum of American Art in Fort Worth, the Witte Museum in San Antonio, and the Museum of Modern Art in New York. In 1996, the Dallas Visual Arts Center, now the Dallas Contemporary, honored Medellin with its prestigious Legends Award.

The Campanile Window is a historically-significant work by Mr. Medellin. The window was one of four installed in 1960 in the bell tower of the Trinity Lutheran Church on Gaston Avenue. The windows were scheduled for demolition along with the church in the spring of 2013 to make way for the new YMCA at White Rock. Octavio's student, artist David Hickman, alerted Craig Reynolds of BRW Architects and, through the efforts of city staff, members of the Cultural Affairs Commission, and the Dallas City Council, the YMCA of Metropolitan Dallas donated the windows to the City providing the opportunity to save this historically significant work. The blue and turquoise stained glass panels were restored and reconstructed by Michael Van Enter of Van Enter Studio. The remaining three windows are also being restored and will be installed in the front hall at the Dallas City Performance Hall at a break in their event schedule in July 2015.
