Trinity Watershed Management announces the annual fitness and recreation event, All Out Trinity, to be held Saturday, March 4, 2017 from 8:00 a.m. to 5:30 p.m. "Experience the Trinity" is the theme for this year's event and a variety of exciting activities are part of the line-up. This event draws over 6,000 participants each year to enjoy the amenities of the Trinity. The event's festival area is located at 300 Singleton Boulevard, Dallas, TX 75212 and the Ronald Kirk Bridge and Felix H. Lozada, Sr. Gateway as well as the westbound lane of the Margaret Hunt Hill Bridge. These areas give participants and the general public places to gather and view the iconic architecture of the bridges and the variety of cityscape views from the Dallas Floodway perspective.

All Out Trinity begins with an Opening Ceremony at 7:30 a.m. This is followed by the 13th Trinity River Levee Run and Glenn Carter Public Safety Challenge (a friendly competition between the Dallas Fire Rescue and Dallas Police Departments) starting at 8:00 a.m. featuring a 10K, 5K and 1 mile walk/run. This race is sponsored by the Trinity Commons Foundation, Dallas Running Club and the City of Dallas.



### SUBJECT Rental Home Registration & Inspection Program Update

This memorandum provides a second update on the implementation of the rental home registration and inspection program, a component of the Chapter 27 – Minimum Property Standards ordinance adopted by City Council in late 2016 and which took effect on January 1, 2017.

As you will recall from the update provided last December, the initial focus of the implementation has been on outreach and education. Our efforts have included:

- Letters to owners of approximately 9,000 potential rental homes within the Neighborhood Plus and Neighbor Up areas;
- Program pamphlets and flyers available through 7 Dallas Police Department Stations,
   7 code districts, 31 recreation centers and 25 libraries throughout the city;
- Online link for the program provided to Dallas County and the Dallas Housing Authority for distribution to landlords under their programs;
- Launch of the online registration portal;
- Letters issued to the 2016 registrants under the previous ordinance;
- Public Service Notices on citywide digital billboards; and
- Collaboration with Dallas City Hall On the Go! at various events;

Additionally, rental home property inspections were initiated earlier this month.

For the next implementation phase in early March, staff will expand outreach citywide to owners of 40,000 properties that have been identified as potential rental homes. The attached courtesy letter will be sent to these owners asking them to register their rental home property(s).

Staff will continue to provide you with updates. We anticipate expanding our focus from outreach and education to include enforcement in June 2017. At that time, code inspectors will start to issue formal warnings (notices of violation) to property owners of rental properties that have failed to register. These warnings will allow owners time to voluntarily comply with registration requirements or risk further enforcement, including citations.

#### THIS IS NOT A NOTICE OF VIOLATION OR CITATION

Dear Owner or Agent:
On September 28, 2016, the Dallas City Council approved the Single Family Rental Registration Program. The program is intended to ensure rental properties are registered while helping to foster clean and safe rental properties. The goal is to enhance the health, safety and quality of life for all residents of the City of Dallas. The Single Family Rental Program pertains to single family homes, duplex units or condominium units that are either leased or rented and occupied by someone other than the owner of the property.
The new Program began January 1, 2017 and requires owners or the owner's agent of rental properties (single family homes, duplexes and condo units) in the City of Dallas to register their properties, annually by submitting a registration

application, a non-refundable fee of \$43 and an annual Owner's Self Inspection checklist with affidavit for each dwelling or unit. The program also requires the City of Dallas to conduct a comprehensive inspection every five years. (Ref: Chapter

Currently, you can register your property(s) online by going to <u>dallascityhall.com/departments/codecompliance</u>. <u>Select the Single Family Rental Registration Icon and then click on the SFRP Registration house to access the VGOV program</u> which contains the online registration application. In the near future, the printable application can be submitted by mail or personally deliver to the Single Family Rental Program located at 3131 Dawson Road, 2<sup>nd</sup> flr, Dallas Texas 75226

To register successfully online, please ensure a complete application along with a copy of the owners picture ID, the Owner's Self Inspection Checklist with affidavit and the appropriate fee is submitted when registering your single family rental property. \*\* Incomplete applications and/or missing documents will not be accepted.
