SUBJECT Dallas County Interlocal Agreement for Older Adult Services Program

This memo is to provide an update on the Dallas County Older Adult Senior Nutrition Program being implemented at the Martin Luther King, Jr. Center and West Dallas Multipurpose Center.

On January 24, 2018, the Office of Community Care will seek authorization from the City Council to execute an Interlocal Agreement with Dallas County to operate its Senior Nutrition Program at the Martin Luther King, Jr. Center located at 2901 Pennsylvania Avenue and the West Dallas Multipurpose Center located at 2828 Fish Trap Road. The contract period for this program is October 1, 2017 through September 30, 2018, and will provide health, nutrition, recreation, education and social services programming to senior residents. A Request for Proposal will be issued in Spring 2018 by the Dallas Area Agency on Aging (DAAA) to extend and operate the Program after September 30, 2018. Dallas County is currently under contract with DAAA to administer the program. It is the intent of the City to respond to this RFP.

There is no cost consideration to the City. However, the City's primary responsibilities are to provide space at the Martin Luther King, Jr. and West Dallas Multipurpose Center from 8:30 a.m. to 2:30 p.m., Monday through Friday. The County's primary responsibilities are to operate the program to include providing a manager, administering and planning daily activities, coordinating and providing transportation for daily trips and special events, monthly reporting, and other duties necessary to implement the program.
