The Citizen Homelessness Commission's Housing Committee and the Office of Homeless Solutions are co-hosting three additional public meetings to further discuss Track 4, briefed to City Council on August 1, 2018, and the voter-approved 2017 Capital Bond Program: Proposition J (Homeless Assistance Facilities) prior to releasing the Notice of Funding Availability. The bond funds will be used to leverage public/private partnerships to increase the availability of supportive housing for the homeless; funds may also be used for day centers to provide the wraparound services. The meetings are scheduled for January 30th, and February 6th; further details are available in the flyer attached. [City Hall Power Shutdown on January 26, 2019](#)

As previously communicated on January 18, 2019, on Saturday, January 26, 2019, Dallas City Hall is scheduled for a main building power shutdown from the ONCOR statewide power grid, and the building will be switched over to operate on generator power starting at approximately 6:00 a.m. until approximately 4:00 p.m. This power shutdown will allow the building's medium-voltage Federal Pacific (FP) main switchgear and the Uninterruptable Power Supply (UPS) system to be removed and replaced by the contractor, Schneider Electric Buildings Americas. Since the switchgear and panels have never been replaced, these no longer meet the current electrical codes. The existing City Hall UPS system operates on outdated technology and the physical equipment is no longer available. The switchgear and panels are also past their manufacturer's suggested service life (approximately 20 years).

Critical Infrastructure including 911 (DPD), DFR, 311, OEM, DLF, and CIS backup systems will operate as normal with the generator power. City Hall, in general, will have no power available for daily operations and will be operating on emergency lighting. A command center will be located in the City Hall Emergency Operations Center on Saturday, January 26, 2019 to serve as the main point of contact to notify of any issues related to the power shutdown at City Hall. Building Services staff (approximately 10 electricians and 6 HVAC staff) will be on-site to respond to any building related issues. An internal announcement will be distributed to all City Personnel, requesting that they not come into work on Saturday, January 26, 2019, unless it is essential to do so.

Dallas Water Utilities Recognition from TCEQ


On January 11, 2019, Dallas Water Utilities was recognized as a “Superior” water system by the Texas Commission on Environmental Quality (TCEQ). DWU sustained this notable rating based on the results from TCEQ’s 2018 Comprehensive Compliance Investigation of Dallas’ water supply system. To earn this designation, a system must meet and maintain a higher set of standards than are required of all public water systems. These standards, including excelled efforts in protecting public health, ensuring reliable operations and water supply for the system’s customers, compliance with regulatory requirements and environmental stewardship, are required to be considered “Superior.” Dallas continues to be recognized by the TCEQ for its superior performance in exceeding state and federal drinking water standards. January 14, 2019; Jack Fink, CBS 11 Reporter: Has the city scheduled the two public hearings needed for a new teen curfew ordinance? If so, when are those scheduled, and when is it scheduled to go before the full city council for consideration?

January 17, 2019; Jack Fink, CBS 11 Reporter: Thanks! Any word when this goes before the full city council for a vote?

City Response: That date has not been scheduled yet.

January 17, 2019; Lori Brown, FOX 4 Reporter: Are the owners of the Atmos home explosion going to be required to demolish the home at some point? It is at 3534 Espanola Drive. Is it a code violation to have the exploded home still standing?

City Response:

If the Court finds that the property should be demolished the owner can either repair or demolish the structure. If the owner doesn't comply with the Court's order, the City can then demolish and put a lien on the property. The properties being vacant are not a violation of the City Code unless they are not secured and/or there are other Code violations.

January 18, 2019; Jack Fink, CBS 11 Reporter: Hi there, do you know when the teen curfew expires? Will it be in effect tonight or did it already expire? Thanks!

City Response: It is set to expire today.

Wednesday, January 16th: **All local media outlets** – May we have more information on an overnight house fire in Oak Cliff?

City Response - On Tuesday, January 15th, at 23:40, Dallas Fire-Rescue responded to a 911 call for a structure fire at a home, located at the 2700 block of Llewellyn Avenue, in South Dallas.

When firefighters arrived at the one-story residence, they observed fire coming from the front of the house. They quickly deployed hand-lines and mounted an offensive attack on the fire, and had it extinguished within 20 minutes.

Fire investigators were called out to the scene and were able to determine, through a systematic approach, that the fire was accidental in nature; and began as the result of a heat source being left too close to combustible materials.

According to the sole occupant of the home, a man in his 70's, he was using an electrical space heater to keep warm, while asleep on a couch in the living area of his home. He was awakened by the smell of smoke, and noticed a set of curtains, located near the space heater, consumed by fire. The fire spread from the living area of the home, and spread throughout, causing significant damage. Though he was able to escape the home uninjured, he was taken to a local hospital as a result of the exposure to the smoky conditions.

Wednesday, January 16th: **Karen Ballesteros (Telemundo) and Jimena Fraga (Univision)** – Would anyone be available for a Spanish on-camera interview about safety tips when using heaters or any other devices?

City Response – I connected them with Senior Fire Prevention Officer, Daisy Castaneda, who fulfilled both requests, for Spanish on-camera interviews, to air in the late afternoon and evening news casts.

Thursday, January 17th: **All local media outlets** – May we obtain more information on a major accident, involving an overturned school bus, on I-30 and Loop 12?

City Response: At 15:55 Dallas Fire-Rescue responded to a 911 call for a major accident at Interstate 30 and Walton Walker Boulevard, in West Dallas.

Dallas Police and/or Dallas Sheriffs are investigating the accident details, but it was reported to have involved as many as 4 vehicles; including a school bus which rolled onto its side and into a ditch.

DFR dispatched 6 rescue units, in addition to a number of other resources, to help mitigate the situation. A total of 11 people, 10 students and the bus driver, were on board the bus when the accident occurred. Nine of the students and the driver were taken to Parkland and Dallas Methodist hospitals with non-life-threatening injuries.

The last student was released to his/her parents.

Sunday, January 20th: **Catherine Park (NBC 5)** - Dallas, TX (Dallas County)| Technical Rescue| 1250 Moulin Rouge Dr| Bn6 on scene car into building full USAR response requested| 14:06 Do you have any information about a car into a building? Any injuries? What kind of building is it?

City Response - I'll let DPD advise you on how the accident occurred when and if that's determined.

All I can add is that when the USAR Team responded they extricated the driver of the vehicle and turned him over to paramedics where he was taken to a local hospital in what appeared to be stable condition.

After the extrication, they stabilized the structure so a tow truck could remove the vehicle without further compromising the structure. They also searched the first and second floor of the residence and confirmed that no one else was trapped or injured.
