REPORT OF THE CANVASSING COMMITTEE AND RESOLUTION AND ORDER APPROVING THE REPORT

January 19, 1981

TO THE HONORABLE MAYOR AND CITY COUNCIL OF THE CITY OF DALLAS:

We the undersigned, your Committee of the City Council, appointed on January 14, 1981, to canvass the returns of the Special Election held on January 17, 1981, for the purpose of submitting to the qualified voters of the City certain questions relating to the adoption of amendments to the City Charter, hereby report that the following propositions were submitted to the qualified voters of the City of Dallas, to-wit:

PROPOSITION NO. 1

TAX RATE LIMITATION

SHALL Chapter XIX, Section 23 of the Charter of the City of Dallas be amended to limit the advalorem tax rate of the city to a maximum of forty cents (\$0.40) per one hundred dollars (\$100.00) of assessed value and to limit the percentage of annual increase of assessed taxes levied on property between two adjacent years to a maximum of five percent (5%), not including additions or improvements to the property?

PROPOSITION NO. 2

CITY COUNCIL TERM LIMITATION

Shall Chapter III of the Charter of the City of Dallas be amended to limit service by a person as member of the city council other than Place 11 to three consecutive terms; and to limit service by a person as member of the city council, Place 11 to three consecutive terms?

PROPOSITION NO. 3

THOROUGHFARE PLAN REQUIREMENTS

Shall Chapter XV of the Charter of the City of Dallas be amended to require adoption of a thoroughfare plan; to require written notice of amendments to landowners within 200 feet of an area of change; and to require a public hearing before the plan may be amended?

PROPOSITION NO. 4

BOARD OF EQUALIZATION EXPANSION

Shall Chapter XIX, of the Charter of the City of Dallas be amended to increase the membership of the board of equalization to nine; to provide for division of the board into panels; and to lengthen the term of service of the board.

We have carefully canvassed the returns of the Special Election and find that the following number of votes were cast respectively, YES and NO on the four propositions:

RESOLUTION AND ORDER

WHEREAS, the Canvassing Committee of the City Council has filed its Canvassing Report of the Special Election held pursuant to Ordinance Nos. 16771 and 16800, and the City Council has duly examined the Canvassing Report and finds that it is in all things correct; Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

- SECTION 1. The City Council finds that the Special Election held on January 17, 1981, pursuant to Ordinance Nos. 16771 and 16800, was duly ordered and notice given in accordance with law; that the Special Election was held in the manner provided by law; that only duly qualified electors of the City of Dallas voted in the election; and that returns of the election have been made by the proper officials.
- SECTION 2. That the canvass of the returns of the Special Election and the tabulation of the votes cast YES and NO in answer to the propositions submitted on the official ballot, as stated by the Report of the Canvassing Committee, are hereby approved and adopted.
- SECTION 3. That a majority of the votes cast at the Special Election were against Proposition No. 1 as described in Ordinance No. 16771; therefore, it was defeated and is declared not to be adopted.
- SECTION 4. That a majority of the votes cast at the Special Election were in favor of Proposition Nos. 2, 3, and 4, as described in Ordinance No. 16800, and each of these Propositions is hereby declared and ordered adopted.
- SECTION 5. That it is hereby ordered that the amendments adopted by Proposition Nos. 2, 3, and 4 shall become a part of the Charter of the City of Dallas.
- SECTION 6. That Robert S. Folsom, Mayor, is hereby authorized to certify to the Secretary of State, an authentic copy of the charter amendments, showing the approval by the qualified voters in accordance with Article 1173, Vernon's Texas Civil Statutes.
- SECTION 7. That the City Secretary is hereby directed to record at length the Charter Amendments upon the records of the City of Dallas in the separate book that is generally known as the Home Rule Book, kept in his office for that purpose, in accordance with Article 1174, Vernon's Texas Civil Statutes.
- SECTION 8. That this Resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas and it is accordingly so resolved.
