# **CALL TO ORDER**

Mr. Johnson, co-chair, Dist. 3, called the Senior Affairs Commission (SAC) meeting to order at 12:08 p.m. in the absence of Mr. Garza. The meeting opened with a moment of silence.

# **APPROVAL OF MINUTES**

After reading the minutes from the February 9, 2015 Senior Affairs Commission (SAC), two corrections were made: Ms. Simpson stated that Robin Teig was cochair for Age Well Live Well, (there are three). Mr. Gart stated that Mr. Kleinman shared maps of where seniors live only. He had another source for contractors. After discussion of the SAC Goals and with the above corrections and/or additions, Ms. Simpson moved the minutes be accepted and Ms. Cohen seconded the motion. The minutes were unanimously approved by the members present.



# **DISCUSSION OF SAC SHORT & LONG TERM GOALS**

Spokesperson for this committee, Ms. Wick reviewed the attached short and long term goals identified by the committee members. The members discussed that the City Manager's goals and objectives should align with the SAC goals. The members agreed to move the first Long Term Goal to the fourth short term goal and maintain 2 long term goals. Mr. Gart made a motion to accept the goals as written with the adjustments and the ability to use them as a foundation for the SAC. The motion was seconded by Ms. Schaar. Members present approved the report and agreed to begin implementing the concepts.

## **PRESENTATION**

The scheduled presenter, Karen Riley, Neighborhood Plus, did not make scheduled presentation. In lieu of her absence, Gene Popk, G & G Medical, presented to the SAC members, special guest Chief Seals, Dallas Fire & Rescue, and citizens, on his "app" for medical emergencies. This device has been explored and discussed by the Victimization Committee as a possible project for the SAC. Chief Seals stated the product seems good, but the EMS/DFD staff do not carry City of Dallas issued smart phones, they do not have general Internet abilities and would probably not use the "app". He suggested the City attorney review the product and any agreements made between the SAC and the company as well as the Ethics Committee to ensure there was no financial gain for City.

In conclusion, Mr. Johnson stated the Victimization Committee would revisit this project and make sure there were "no conflicts of interest". The goal is to promote health and safety for all seniors and the best way may be to encourage all levels of recording health information: Vial of Life, G & G Medical, list of medical information in wallet or posted in home, etc.

# Health Committee – Lydia Simpson

Ms. Simpson reported Age Well Live Well Coalition met Wednesday, February 18, 2015 at the Senior Source. Their meeting was longer than usual to allow time to



work on their goals for 2015. They have agreed the target age would begin at age 55 and older. They are working on their website but have no money. The next meeting will be Wednesday, March 18<sup>th</sup> at 9:30 a.m. at the Senior Source. This coalition serves as the Health Committee for the SAC. A copy of their meeting notes was provided and attached to the minutes.

## **Housing Committee – Bill Gart**

Mr. Gart announced that Ms. Wick was nominated and won D Magazine's nurse of the year. He read the article that was written to the group. *Great accomplishment for Ms. Wick.* Mr. Gart discussed the Emergency Home Repair financial report (attached). The Housing Committee would be meeting Tuesday, March 17<sup>th</sup> at 1:00 p.m. in City Hall 6BN conference.

#### Victimization Committee – John Johnson

In addition to the Emergency response presentation, Susan Williams reported there would be a Scam jam, April 28 at the White Rock Hills Library from 1:00 p.m. -4:00 p.m. Mr. Johnson shared information on the upcoming election for Council seats, and he shared AARP's recent scams report.

Mrs. Alexander reminded members of the Senior Health & Safety Breakfast at El Rachito's on Jefferson March 20, 2015 from 8:00 – 11:00 a.m. The event is free and open to the first 180 registrants. Dr. Elba Garcia, Southwest Police Department and AARP will be presenting. Sponsorships are needed for the event. Information was provided to the Commissioners regarding the event.

Ms. Williams will be at the Health & Safety Breakfast for more "listening post" ideas and concerns as well as speaking on Age Friendly Communities.

### CITIZENS' COMMENTS

Ms. Thomas led a discussion on volunteerism and SAC activities. She commented on the Coffee & Conversation held at her facility and was appreciative of the event. She expressed her desire to volunteer more with senior activities and SAC initiatives.

### SENIOR SERVICES REPORT

Mrs. Alexander invited SAC members to participate in up-coming activies: Health and Safety Breakfast (March 20<sup>th</sup>), Senior Housing 101 (April 17th) and MayFair (May 22, 2015). She reported approximately 800 citizens received outreach efforts through the Senior Services staff, 600 were seniors only. The new staff person will begin April 1, 2015.
