2. Group Dynamics Exercise



Commissioner Fein reviewed the Senior Affairs Commissioner Responsibilities. She asked the Commissioners to request a calendar of events from their Councilmember's Secretary and to set up monthly meetings with their Councilmember on a Monday or a Tuesday starting the Monday of the next SAC meeting. Senior Services staff will monitor the Facebook page and schedule SAC group quarterly trainings about one of their programs. The Commissioners will write a summary of what they learned at training and turn in to be included in minutes, wear their name badges in public and at meetings with Councilmember, and use City email account to communicate.



Susan Williams, Associate State Director at AARP, provided an update on the Age-Friendly Communities Plan. She will present the Plan to the City Council following the Listening Sessions.

David Noguera, City of Dallas Housing Director, reported on the home repair program by conference call. The City is redesigning and consolidating the home repair programs into one program to stretch out the maximum expenditure to the HUD Housing cap of up to \$150,000 per unit/home. No changes have been made to the program eligibility requirements. Loan terms will be deferred as long as the resident is living in their home. The program is not set up to respond to emergencies. There is a bidding process.

5. Adjournment:

The meeting was adjourned at 3:30 p.m. followed by a tour of T. Boone Pickens Hospice and Palliative Care Center.
