Overview of Charter Review Process & Proposed Amendments

Discussion Item: The Chair briefed the public on the charter review process. The scope of the Commission's work included discussions on proposed amendments received from the City Council, City Attorney's Office and the general public. Suggested amendments considered by the Commission

included: City Council pay and terms; redistricting; the structure of boards and commissions; Civil Service and personnel. The Chair explained that the aggregate collection of suggested amendments was

segregated into three categories, Departmental, Technical and Policy. The Chair outlined preliminary recommendations the Commission will present to the City Council. The preliminary recommendations include raising Mayor and City Council compensation and restructuring the redistricting process. The next steps in the charter review process include:

- May 6, 2014: final commission vote on recommended amendments
- May 13, 2014: reserved for final vote if necessary
- May 21, 2014: briefing to the Dallas City Council
- June 2014: Dallas City Council consideration of recommended amendments
- August 2014: submission of Council approved items to Dallas County Elections Officials
- November 4, 2014: Election on Charter amendments
