## City Attorney

- First mention of an appointed City Attorney - 1871
- Was made an elective position - 1872
- Deputy City Attorneys were approved - 1877
- Became an appointed position again - 1879
- Two-year term; removal after public hearing by $2 / 3$ vote of Council - 1930
- Residency requirement; majority vote of Council to discharge 2005


## City Auditor

- Appointed position created as a bookkeeper - 1889
- Placed under the City Manager; selected by citizen nominating board of bank presidents and confirmed by Council; two-year term - 1930
- City Auditor position duties redefined and accounting responsibilities moved to newly created City Controller position 1976
- Selection process by nominating committee established by ordinance; confirmation by Council - 1989
- Residency requirement; added assistants and employees; additional duties - 2005


## City Secretary

- City Secretary first mentioned as an appointed position, but later became an elected position - 1871
- Became an appointed position - 1879
- Council could approve assistants to City Secretary - 1930
- Appointment for two-year term; requires $2 / 3$ vote to discharge 1973
- City-wide records management program added to City Secretary responsibilities - 1993
- Residency requirement; majority vote of Council to discharge: removes Council approval prior to discharge of assistant - 2005


## Chief Financial Officer (Treasurer)

- Elective position of Treasurer - 1856
- Became appointive position reporting to Council - 1896
- Position was opened for bid contract with two-year term - 1899
- Position still filled by open bid, but reported to Department of Finance - 1930
- Chief Financial Officer appointed by the City Manager, is the Treasurer - 2005


## Civil Service

- Civil Service Board of 3 members created - 1930
- One board member to serve as Chief Examiner and Secretary
- Board appoints subordinates as appropriated by Council
- Board expanded to 5 members, which appoints a non-member as secretary - 1968
- Created adjunct non-voting members to serve on trial board 1983
- Administrative Law Judge process created - 1989
- Board Secretary to also be Director of Civil Service Department; two-year term; 2/3 vote of Board to discharge - 1997
- Director appoints subordinates as appropriated by Council
- Expanded to 7 members - 2005


## Park Board

- Created to manage City of Dallas parks; original structure: Mayor as chair/president and 5 members, appointed by mayor - 1905
- Tax revenue assigned to Park Fund; board approves expenditures - 1916
- Expanded to 6 members - 1928
- Board reduced to 5 members, removed Mayor; president selected from among board - 1930
- Expanded to 7 members - 1968
- Clarification of land acquisition policy and contract approval 1983
- Expanded membership to number equal to the number of members on the city council - 1989
