2) Stucco porch foundation and sides of step buttresses, paint to match.

11316 E 6TH ST

1) Remove driveway, driveway retaining walls and top terrace retaining wall on front of property.

2) Replace lower retaining wall in similar material behind propery line and slope yard to meet.

12326 S EDGEFIELD AVE

- 1) Reconfigure rear addition.
- 2) Construct new rear deck.
- 3) Add french doors on rear.
- 4) Replace windows with wood one-over-one.
- 5) Reconfigure front porch.
