BACKGROUND

- The Aquatics Master Plan 2015 Update was approved by Park and Recreation Board on Oct. 8, 2015
- Amendment No. 1 to the Master Plan was approved on September 7, 2017 which added sprayground locations and a neighborhood family aquatic center
- Proceeds from the Elgin B. Robertson land sale provided funding for the Regional Family Aquatic Centers
- Phase 1 included:
 - Crawford Regional Family Aquatic Center
 - Fretz Regional Family Aquatic Center
 - Samuell Grand Regional Family Aquatic Center
 - Kidd Springs Community Family Aquatic Center
 - Lake Highlands North Community Family Aquatic Center
 - Tietze Neighborhood Family Aquatic Center
- Phase 1 was divided into 2 construction packages



Crawford Park Regional Aquatic Center Schedule



- Contract allows 273 calendar days, not including delays for excessive weather
- Challenges delaying completion:
 - Permit took approximately 4 months
 - Environmental testing and remediation took approximately 3 months
 - Contractor mobilization and limited work began on 9/05/2017
 - Excessive weather delays 16 days as of 5/31/2018
- Other Challenges
 - Difficulty in locating suitable fill material for the 16' depth under pools and building
 - Oncor requirements for easement on Park property for 3-phase power
 - Generator has been ordered to supply temporary power



Fretz Park Aquatic Center Schedule



- Contract allows 273 calendar days, not including delays for excessive weather
- Challenges delaying completion:
 - Permit took approximately 5 months
 - Environmental testing and remediation took approximately 3 months
 - Contractor mobilization and limited work began on 9/26/2017
 - Excessive weather delays 16 days as of 5/31/2018
- Other Challenges
 - Right-of-Way setback on Hillcrest Road caused redesign during permitting process
 - Difficulty securing fabricated structural steel due to high market demand



Samuell Grand Park Aquatic Center Schedule



- Contract allows 273 calendar days, not including delays for excessive weather
- Challenges delaying completion:
 - Permit took approximately 5 months
 - Environmental testing and remediation took approximately 3 months
 - Contractor mobilization and limited work began on 9/05/2017
 - Excessive weather delays 16 days as of 5/31/2018
- Other Challenges
 - Thermal break on new bathhouse roof required by Energy Code
 - Difficulty securing hand cut stone for buildings and retaining walls (quarried in California)

Kidd Springs / Lake Highlands North / Tietze

Phase 1 – Package 2 Aquatic Centers Kidd Springs / Lake Highlands North / Tietze

- Construction contract awarded by City Council on 1/24/18
- Environmental reports completed for all three sites
 - No soil remediation is required
 - Asbestos abatement will be required at Kidd Springs and Tietze
- Construction Documents submitted for permit in February
 - Lake Highlands North permit received 6/8/18
 - Kidd Springs and Tietze are in process
- Construction mobilization at Lake Highlands North started on 6/14/18
- Ground Breaking for Lake Highlands North scheduled for 6/23/18
 - Excavation work began on 6/20/18
- Construction of Kidd Springs and Tietze will begin at end of pool season (August 12)
- Complete construction May 2019

2017 Bond Program Aquatics Projects – Tentative Schedule

DESIGN PHASE

- Consultant selection process for aquatic centers and spraygrounds:
 - RFQ for Design Consulting Services received on 3/2/18
 - RFP for Design Consulting Services received on 4/4/18
- Consultant contract approvals:
 - Consultant contract for aquatic centers approved by Park Board on 6/7/18
 - Consultant contract for spraygrounds on June 21, 2018 Park Board Agenda
 - Consultant contract awards on 6/27/18 City Council agenda
- Complete design of 4 aquatic centers March 2019
- Complete design of 6 spraygrounds March 2019

2017 Bond Program Aquatic Centers – Tentative Schedule - Construction

Exline / Harry Stone:

- Award construction contract June 2019
- Begin construction August 2019
- Complete construction Summer 2020

Bahama Beach:

- Award construction contract June 2019
- Begin construction August 2019
- Complete construction Summer 2020

Bachman:

- Award construction contract June 2019*
- Begin construction August 2019
- Complete construction Summer 2020

* Construction start dependent on results of Bachman Lake study completion

2017 Bond Program Spraygrounds – Tentative Schedule

Design:

- Consultant contract award on 6/21/18 Park Board agenda
- Consultant contract on 6/27/18 City Council agenda (addendum)
- Complete design March 2019

Construction*:

- Construction contract award June 2019
- Begin construction July 2019
- Complete construction May 2020

* Construction procurement of the six spraygrounds will likely be in 2-3 packages
