WHEREAS, it has been determined that acceptance of the best and final offer from Thos S. Byrne, Ltd., in an amount not to exceed \$10,509,788, is the best value for the City of Dallas.

Now, Therefore,

BE IT RESOLVED BY THE PARK AND RECREATION BOARD AND THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to enter into a contract with Thos S. Byrne, Ltd. for construction of the Briscoe Carpenter Livestock Center in Fair Park which includes an auditorium, pre-function lobby, lounge, banquets and dining facilities, in an amount not to exceed \$10,509,788.

SECTION 2. That the President of the Park and Recreation Board and the City Manager are hereby authorized to execute a contract with Thos S. Byrne, Ltd., after approval as to form by the City Attorney.

SECTION 3. That the Chief Financial Officer is he reby authorized to receive and deposit funds from the State Fair of Texas in an amount not to exceed \$8,689,438 in Fund 0535, Department PKR, Unit T098, Revenue Source 8411.

SECTION 4. That the City Manager is hereby authorized to establish appropriations in the State Fair of Texas Capital Construction Fund, Fund 0535, Department PKR, Unit T098, Object 4310 in the amount of \$8,689,438.

SECTION 5. That the Chief Financial Officer is hereby authorized to disburse the amount of \$10,509,788 to Thos S. Byrne, Ltd., as follows:

District 5 Maintenance Service Center (6) – A motion by Gerald Worrall III, seconded by Robin Norcross, to authorize a twenty-year lease agreement with Texas Military Department (TMD) for use of approximately 8.96 acres of land and appurtenances, for District 5 Maintenance Service Center located at 1775 California Crossing Road in California Crossing Park - Financing: No cost consideration to the City, was carried. The vote was unanimous.

On June 28, 1960 the City entered into an agreement and lease with the Texas National Guard Armory Board for use of a portion of California Crossing Park to construct improvements for a training facility for a unit of the Texas National Guard. Upon expiration of the lease on May 31, 1990 a new lease was consummated between the City and the Texas National Guard. That lease is now set to expire on May 31, 2015.

The Texas Military Department (TMD) wishes to enter into a new lease agreement. TMD has approached the Park and Recreation Department with an offer of consideration to provide the Park and Recreation Department with approximately 3,500 square feet of office space, a maintenance facility building of approximately 2,000 square feet, parking space, and a fenced maintenance yard for use as the Park and Recreation Department District 5 Maintenance facility, with improvements, in lieu of rental payments.

Currently the Armory consists of approximately 66,000 square feet of floor space. The new lease provides for the TMD to make improvements to approximately 3,500 square feet of office space for use by the Park and Recreation Department's District 5 Maintenance division. Additionally, the district will have exclusive use of a portion of the fenced maintenance yard as well as parking for its staff.

RESOLUTION OF THE CITY OF DALLAS PARK AND RECREATION BOARD REGARDING THE MAYOR'S FAIR PARK TASK FORCE KEY RECOMMENDATIONS

WHEREAS, the Dallas Park and Recreation Board supports the Mayor's Fair Park Task Force Key Recommendations with the following proposed modifications:

Proposed Modification to MFPTF Key Recommendation 1:

The Dallas Park and Recreation Board recognizes that it has no authority to undertake planning initiatives around or near Fair Park. The Board encourages the City Council to undertake and develop a comprehensive land use study and urban design plan for the South Dallas/Fair Park neighborhood. This plan should have strong community participation and input. A goal of the study is to protect the community and surrounding neighborhood to mitigate gentrification.

Proposed Modification to MFPTF Key Recommendation 2:

The Dallas Park and Recreation Board recommends below-ground parking to preserve the character and landscape of Fair Park.

Proposed Modification to MFPTF Key Recommendation 3:

The Dallas Park and Recreation Board recommends the new 501(c)(3) board for the public/private partnership be a board with a diverse membership composition with at least 10% individuals who represent the surrounding Fair Park community and at least 10% individuals who have historic preservation expertise. There would be no less than one individual on the board representing each of these two communities.

Proposed Modification to MFPTF Key Recommendation 4:

The Dallas Park and Recreation Board recommends that implementation of the Task Force recommendations within the Dallas Park and Recreation Board jurisdiction is the responsibility of the Dallas Park and Recreation Board.

BACKGROUND

The City of Dallas owns land totaling approximately 9.37 acres at 4550 Worth Street known as Buckner Park. The park property, originally acquired in 1914 is currently developed with a playground, picnic pavilion, soccer field, tennis court, volleyball court, and a basketball court.

The Dallas Independent School District (DISD) has requested title of approximately 1.06 acres of land at Buckner Park for parking and driveway improvements to the adjacent Ignacio Zaragoza Elementary School. Based on an independent fee appraisal, DISD will pay the City of Dallas \$381,348 for the purchase of this property.

The City of Dallas Park and Recreation Department, DISD, and the surrounding community have worked together to develop a Park Development Plan that details future improvements to Buckner Park. This Park Development Plan process developed the concept on which to delineate the sale of property to DISD for parking and traffic control purposes.

In accordance with the Texas Parks and Wildlife Code, Chapter 26 (Sections 26.001 through 26.004), the City Council must advertise and hold a public hearing on the change of use and sale or exchange of park land. The public referendum and competitive bid requirements are not applicable for the sale or exchange of park land to an entity with eminent domain authority. The proceeds of the sale of park property must be used to acquire park land in accordance with the Texas Local Government Code, Chapter 253.





On February 26, 2014, Resolution No. 14-0452 authorized the acceptance of the United States Economic Development Administration Grant in the amount of \$1,200,000 from the United States Economic Development Administration (EDA) for infrastructure and improvements to compliment the Briscoe Carpenter Livestock Center Project, Fair Park.

On April 8, 2015, Resolution No. 15-0661 awarded a contract to J.C. Commercial, Inc. for site utilities, grading and paving for the Briscoe Carpenter Livestock Center, in an amount not to exceed \$2,687,777. This project will be funded by the U.S. Department of Commerce, Economic Development Administration reimbursable grant in the amount of \$1,200,000 and 2006 Bond Funds will be used for the remaining portion of the project.

This action will authorize deductive Change Order No. 1 to the contract with J.C. Commercial, Inc. for reduced scope of work to include: paving and storm sewer work. It also includes added amounts of underground electrical duct banks, for a net deductive amount of (-\$271,203.01). The Economic Development Administration funded \$1,200,000 of the original grant, and there was a \$300,000 required City match. The deduct will be credited to the City of Dallas 2006 Bond Funds.
