Proposed New Partners Workshop

Administration and Finance Committee Briefing Park and Recreation Board August 18, 2016

Background

- In 2010 as a way to engage the community to take an active role in supporting the park system, the Park and Recreation Board developed an initiative to bring together park stakeholders throughout the City for a one-day program titled "Love Your Parks Stakeholders Summit". The objectives were to:
 - Consolidate park support efforts
 - Identify support opportunities
 - Network with other organizations
 - Engage volunteers and supporters
 - Leverage available resources

Dallas "Love Your Parks" Summit

- The 2010 Love Your Parks Stakeholders Summit all-day program included:
 - Opening Session with Keynote speaker
 - 36 Educational Sessions: Developing a 501c(3) organization; Partnering with the City and Department; Volunteer
 Opportunities and Community Resources, Advocacy and Fund-Raising
 - Council District discussions with Councilmembers and Boardmembers on the park bond program, needs inventory and other park related issues
 - Networking opportunities with organizations such as Friends groups, athletic leagues, recreation clubs, and neighborhood associations

Dallas Love Your Parks Summit

- The 2011 Love Your Parks Summit half-day program focused on "moving the system forward". The program consisted of:
 - A continental breakfast
 - Opening session with keynote speaker
 - 9 Educational Sessions: Working with the Dallas Parks Foundation; Trails and Safety; 2011 Dallas Bike Plan; Social Media and Website Development, Aquatics Master Plan, Preliminary Bond Program Recommendations; Rental and Special Events Facilities; "Stay-cations" in the Dallas Park System; The Power of Parks in Creating Healthy Communities; and Positioning for the Future
 - Breakout lunch sessions by council districts
 - Fair Park Tram Tour

Transition to CONFAB

- The Love Your Parks Summit proved to be labor intensive for the numbers in attendance; resulted in the Summit being suspended and the program redefined
 - The Dallas Parks Foundation, in partnership with the Dallas Park and Recreation Department, created the CONFAB symposium and hosted the inaugural CONFAB at the House of Blues Main Stage on June 11, 2013
 - The engaging conversation series featured topics on transforming public spaces, hiking and biking, recreation and progress taking place in our park system and City
 - The program runs approximately 2 hours, features 7-8 presentations and is funded through sponsorships and admissions





In accordance with the terms of the PSA Dallas County will provide the funding for this acquisition by the City.

This item authorizes the acquisition of a tract of land containing a total of approximately 21,874 square feet of land from Golden Venture, LTD. for the proposed Northaven Trail. The property to be purchased is required as a trailhead for the pedestrian flyover of U.S. Route 75/ North Central Expressway. The total consideration for this acquisition is \$1,320,000 based on an independent appraisal. Funding for the acquisition will be provided by Dallas County MCIP Fund in accordance with the Project Specific Agreement between the City of Dallas and Dallas County.

Staff recommends approval of this acquisition with the condition that this property is not officially dedicated as municipal parkland until such time the property is developed for its intended use.
