Jennifer Muñoz (CC District 5) An application for an amendment to and an expansion of Planned Development District No. 844 on property zoned an R-7.5(A) Single Family District, on the south side of Alto Garden Drive, between Buckner Boulevard and Pleasant Drive.

Z178-261(PD)

Pamela Daniel (CC District 4) An application for an amendment to Specific Use Permit No. 1774 for an open-enrollment charter school on property zoned a CR Community Retail District, on the northeast side of South Lancaster Road and the northwest side of East Kiest Boulevard.

Z178-327(CY) Carolina Yumet (CC District 4) An authorized hearing to determine the proper zoning on property zoned an IM Industrial Manufacturing District with Specific Use Permit No. 1583 for a refuse transfer station use, on the northeast side of Pontiac Avenue, between Childs Street and Cedar Crest Boulevard, with consideration given to evaluate whether the SUP is compatible with adjacent property and consistent with the character of the neighborhood.

Sarah May (CC District 6) An application for an MU-1 Mixed Use District with deed restrictions volunteered by the applicant on property zoned an IR Industrial Research District, on the south line of Duluth Street, east of Chicago Street.

Z178-314(CY) Carolina Yumet (CC District 6) An application for a Planned Development Subdistrict within Planned Development District No. 621, the Old Trinity and Design District Special Purpose District, on property zoned Planned Development Subdistrict 1 within Planned Development District No. 621 and Planned Development District No. 442, north of the intersection of North Stemmons Freeway and Slocum Street.
