# PLAN COMMISSION MINUTES

The City Plan Commission held a regular Zoning Hearing on September 15, 2016, with the briefing starting at 11:03 a.m., in Room 5ES and the public hearing at 1:33 p.m., in the City Council Chambers of City Hall. Presiding were, Matt Houston, Acting Chair and Mike Anglin, Acting Vice-Chair.
