# CORRECTED PLAN COMMISSION MINUTES

The City Plan Commission held a regular Zoning Hearing on December 1, 2011, with the briefing starting at 11:31 a.m. in Room 5ES and the public hearing at 1:33 p.m. in the City Council Chambers of City Hall.
