

## PLAN COMMISSION MINUTES

The City Plan Commission held a regular Zoning Hearing on October 25, 2007, with the briefing starting at 10:45 a.m. in Room 5ES and the public hearing at 1:30 p.m. in the City Council Chambers of City Hall. Presiding were Bob Weiss, Chair and Chris Buehler, Vice Chair. The following Commissioners were present during the hearing: James Prothro, Jeff Strater, Clarence Gary, Michael Davis, Debra Woolen Lipscomb, Ann Bagley, Erma Jones-Dodd, Peggy Hill, Sally Wolfish, Robert Ekblad and Neil Emmons.
