

PLAN COMMISSION MINUTES

The City Plan Commission held a regular Zoning Hearing on December 13, 2007, with the bus tour starting at 9:15 a.m. followed by the briefing starting at 10:55 a.m. in Room 5ES and the public hearing at 1:33 p.m. in the City Council Chambers of City Hall.
