3. Briefing Item: The Internal Affairs Process

Presenter: Major Reuben G. Ramirez, Dallas Police Department

- The DPD Internal Affairs are responsible for conducting independent administrative investigation of alleged misconduct by DPD employees, and to ensure due process is afforded to all department members in the discipline process.
- All complaints must be made in writing and must be signed by the complainant.
- All complaints are reviewed by Internal Affairs Division Commander
- Determination made to classification:
  - Cursory investigation reveals complaint did not meet criteria (non-investigation)
  - Control Number Investigation (IAD investigates)
  - Division Referral Investigation (Division Investigates)
- In 2015, DPD received 404 complaints, compared to 302 complaints in 2017.
- The majority of allegations are for discourtesy and unprofessionalism.
- Upon completion of the investigation, a finding will be attached based on the evidence developed during the investigation:
  - o Unfounded: investigation determined the act(s) complained of did not occur
  - Exonerated: investigation revealed the act(s) complained of occurred, but were justified, lawful, and proper
  - Not sustained: investigation failed to disclose sufficient evidence to prove or disprove the allegation
  - Sustained: investigation disclosed a preponderance of evidence in support of the allegation made in the complaint
- Once an external complaint is completed, the citizen is contacted and notified of the finding and instructions on how to appeal to the CPRB
- 1/3 of DPD or 1,000 police officers have body cameras, with a goal of increasing that number
- Invitation for the Board to participate in ride-alongs, Blue Team trainings, reality-based trainings, and the review process
- Request to have future discussion on making the Board more visible to the public

Motion to add additional trainings, such as DPD ride-alongs, Blue Team trainings, and reality-based trainings, to the Board's member requirements
